# OFFICE OF THE HENNEPIN COUNTY ATTORNEY

--- Arturo Rocha-Campiz pled guilty to second degree murder and sentenced today to 440 months in prison

---- Billy Nash, charged with murder, returns to Henn County District Court later this month for a hearing (5/27/10 @ 130p)

--- Jeffrey Thomas Frisk (New Hope) charged with harassment and pattern of harassing conduct has a morning hearing tomorrow (5/14/10@9am). From the complaint:

*Frisk is accused of coming to a home in New Hope and bringing several gifts, including a ring with a heart on it and a bracelet...In November of last year, Frisk is accused of going to the person's home to give the victim a picture that has a heart with a chain and locket on it and words similar to "my heart belongs to you".*

---- John Albert Cochran charged with possession of pornographic material (4 counts). Cochran was taken into custody Wednesday morning (criminal complaint attached)

**COMPLAINT**

*The Complainant, being duly sworn, makes complaint to the above-named Court and states that there is probable cause to believe that the Defendant committed the following offense(s). The complainant states that the following facts establish PROBABLE CAUSE:*

Complainant Det. Pat Clark of the Hennepin County Sheriff's Office has investigated the facts and circumstances of this case by reviewing reports of other officers and believes that the following establishes probable cause:

Beginning in approximately October 2009, Officer Dale Hanson identified by unique IP address a computer in the state of Minnesota that was offering to participate in the distribution of child pornography. On multiple dates, through a public file sharing network on the internet, Officer Hanson obtained a list of the publicly available files from that computer. Officer Hanson identified 10 files by their unique Secure Hash Algorithm as exactly the same computer files seen during prior investigations of child pornography and known to be child pornography as defined by Minnesota law. These include:

- a video file named Toddler Rape kiddy daughter pedo incest Diaper pthc 1yo 2yo 3yo 4yo 5yo 6yo 7yo 8yo.avi (File A) that depicts an adult male rubbing his penis on a prepubescent juvenile female's vagina and then forcing his penis into her vagina before ejaculating onto her anus. This file was available from the defendant's computer on multiple dates in January and February 2010.
- a video file named Pedo (Pthc) - Very willing premature sexualized little girls (Hussyfan) (r@ygold) (babyshivid) Babyj - no sound.avi (File B) that depicts a 6-8 year old girl dancing in her underwear in front of the camera before being vaginally penetrated and ejaculated on by an adult male. This file was available from the defendant's computer in November 2009, January, February, March, and April 2010.
- a video file named Frifam Gaijin fucks 3\_4yo toddler girls\_a childs PP orgasm cums again!!!.mpg (File C) that depicts three 4-6 year old girls in a bath tub touching the penis of an adult male before performing oral sex on the adult male. The adult male penetrates the vagina of one of the girls with his penis and a dildo. This file was available from the defendant's computer in February and March 2010.

Response to administrative subpoena showed that the unique IP address belonged to the defendant, **JOHN ALBERT COCHRAN**, at an address in Champlin, Hennepin County, Minnesota. On May 12, 2010, Det. Martin, Inv. Pollock, and other officers executed a search warrant at the home of the defendant, **JOHN ALBERT COCHRAN**, in Champlin, Hennepin County, Minnesota. Pursuant to the warrant, the officers seized three computers, a digital camera with memory card, an external hard drive, and a number of CD/DVDs. While at the scene, Inv. Pollock conducted a preliminary examination of one of the computers. The preliminary investigation revealed numerous images of prepubescent females exposing their genitalia.

The defendant was arrested. Before being taken to jail, the defendant was permitted to change clothes and call his wife. Officers heard the defendant leave his wife two messages in which he told her that the police were at the home looking for child pornography and "They found some on one of my computers."

The seized evidence was transported to the Hennepin County Sheriff's Digital Examination Laboratory, where Inv. Pollock began examining the items. Initial review of the contents of one of the computers revealed at least 8,000 images and videos of what appears to be child pornography. One of the videos, labeled on the computer as Pthc Toddler Girl Daphne Diaper(Tender) Bum Yum Diaper Baby Bayshivid Ped 1Yo 2Yo 3Yo 4Yo 5Yo Private Incest Toddler Avi.mpg (File D), shows an adult male rubbing his finger on and licking the genitals of an approximately 3 year old (or younger) female child, an adult male penis inserted through the rails of a crib so that the child touches the penis, and an adult male rubbing his penis on the child's genitalia and ejaculating. This is one of the files that was located by Officer Hanson as part of his undercover investigation. Names of other files on the computer include (Pthc) !!! NEW !!! MegaMexicans (All Spicey Latina Preteens); (PTHC)\_2010 PT PICS !!!!!!!NEW!!!!!! 5YO SLEEPING & XTRAS PICS; 142 Pics Of Naked Little Girls Sweet! Pthc Underage Preteen; Sex Collection (2009 Pthc).part2; Toddler Pedo Pthc From 1Yo To 4Yo Saatama; and Baby And Toddler Pics 3.

The defendant is in custody.

**COUNT 1: POSSESSION OF PORNOGRAPHIC WORK INVOLVING A MINOR (FELONY)**  
 MINN. STAT. § 617.247, SUBD. 4(a)  
 PENALTY: 0-5 YEARS AND/OR \$5,000 PLUS A CONDITIONAL RELEASE TERM

That on or between January 1, 2010 and February 28, 2010, in Hennepin County, Minnesota, **JOHN ALBERT COCHRAN** knowingly possessed a computer storage system containing pornographic work involving a minor, namely File A..

**COUNT 2: POSSESSION OF PORNOGRAPHIC WORK INVOLVING A MINOR (FELONY)**  
 MINN. STAT. § 617.247, SUBD. 4(a)  
 PENALTY: 0-5 YEARS AND/OR \$5,000 PLUS A CONDITIONAL RELEASE TERM

That on or between November 1, 2009 and April 30, 2010, in Hennepin County, Minnesota, **JOHN ALBERT COCHRAN** knowingly possessed a computer storage system containing pornographic work involving a minor, namely File B.

COUNT 3: POSSESSION OF PORNOGRAPHIC WORK INVOLVING A MINOR (FELONY)

That on or between March 1, 2010 and April 30, 2010, in Hennepin County, Minnesota, JOHN ALBERT COCHRAN knowingly possessed a computer storage system containing pornographic work involving a minor, namely File C.

COUNT 4: POSSESSION OF PORNOGRAPHIC WORK INVOLVING A MINOR (FELONY)  
 MINN. STAT. § 617.247, SUBD. 4(a)  
 PENALTY: 0-5 YEARS AND/OR \$5,000 PLUS A CONDITIONAL RELEASE TERM

That on or about May 12, 2010, in Hennepin County, Minnesota, JOHN ALBERT COCHRAN knowingly possessed a computer storage system containing pornographic work involving a minor, namely File D.

**NOTICE: You must appear for every court hearing on this charge. A failure to appear for court on this charge is a criminal offense and may be punished as provided in Minn. Stat. § 609.49.**

*THEREFORE, Complainant requests that said Defendant, subject to bail or conditions of release be:*  
*(1) arrested or that other lawful steps be taken to obtain defendant's appearance in court; or*  
*(2) detained, if already in custody, pending further proceedings;*  
*and that said Defendant otherwise be dealt with according to law.*
