

December 5, 2009

The defendant is observed in the club's hot tub with the victim. The defendant pulls the victim to a corner of the hot tub, positions himself behind her and places his hands on the victim's groin area for several minutes. The defendant and the victim exit the hot tub and both enter the women's changing room together.

December 27, 2009

The defendant is observed in the club's swimming pool with the victim. The above-described witness is observed swimming laps. The defendant and the victim are observed in close contact as described by the witness. The witness is observed exiting the pool.

The defendant is observed in the club's hot tub with the victim. The defendant pulls the victim to the same corner of the hot tub, positions himself behind the victim and places her left leg on the edge of the hot tub. Thereafter, the defendant's hands are observed on the victim's groin area for several minutes. The defendant then turns the victim around to face him and both the victim and the defendant take turns touching the defendant's groin area. The defendant and the victim exit the hot tub and both enter the women's changing room together.

Sgt. Martinson learned the victim's mother is an acquaintance of the defendant and that the defendant often takes the child to the club. Sgt. Martinson learned the defendant and the victim's mother made arrangements for the victim to be in the defendant's custody on December 27, 2009 and that they went to the Minneapolis Athletic Club.

Sgt. Martinson scheduled a forensic interview for the victim at CornerHouse. During the interview, the victim identified her vaginal and buttocks area as the "butt." The victim did not disclose any sexual misconduct during the interview, but stated that the defendant would follow her into the women's changing room at the club and tell her to remove her swimsuit. The victim reported the defendant was present in the changing room when she was naked.

Sgt. Martinson took a statement from the victim. During the statement, the victim stated the defendant put his hands inside her swimsuit while in the hot tub, that he wanted to "massage" her, and that he told her that it would make her feel good. The victim stated the defendant performed these "massages" on her butt, an area she identified as her vaginal region and buttocks.

At present, the defendant is not in custody.
