The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Criminal Sex Conduct-3rd Degree-Force or Coercion**

Minnesota Statute: 609.344.1(c), with reference to: 609.101.2, 609.3455.10, 609.344.2(1)  
Maximum Sentence: 15 YEARS AND/OR \$10,000-\$30,000 PLUS CONDITIONAL RELEASE  
Offense Level: Felony

Offense Date (on or about): 05/22/2020

Control #(ICR#): 20001893

Charge Description: That on or about 5/22/2020, in Hennepin County, Minnesota, JONATHAN MAURICE-ROBERTSON TAYLOR, engaged in sexual penetration with Victim, using force or coercion to accomplish the penetration. Specifically, defendant penetrated Victim's vagina.

**COUNT II**

**Charge: Criminal Sex Conduct-3rd Degree-Force or Coercion**

Maximum Sentence: 15 YEARS AND/OR \$10,000-\$30,000 PLUS CONDITIONAL RELEASE

Charge Description: That on or about 5/22/2020, in Hennepin County, Minnesota, JONATHAN MAURICE-ROBERTSON TAYLOR, engaged in sexual penetration with Victim, using force or coercion to accomplish the penetration. Specifically, defendant penetrated Victim's anal opening.

**COUNT III**

**Charge: Domestic Assault - By Strangulation**

Minnesota Statute: 609.2247.2, with reference to: 609.2247.2

Maximum Sentence: 3 YEARS AND/OR \$5,000

Offense Level: Felony

Offense Date (on or about): 05/22/2020

Charge Description: That on or about 5/22/2020, in Hennepin County, Minnesota, JONATHAN MAURICE-ROBERTSON TAYLOR assaulted Victim, a family or household member, by strangulation.

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about May 22, 2020, at approximately 12:20 p.m., Brooklyn Center police officers responded to a domestic incident that occurred at the Super 8 hotel, located on James Circle North, in Brooklyn Center, Hennepin County, Minnesota. Upon arrival, officers met with female Victim, age 31, outside the hotel. Victim was crying and appeared very upset. Victim stated her boyfriend assaulted her earlier that day. Victim identified her boyfriend as JONATHAN MAURICE ROBERT TAYLOR (DOB: 8/12/79), hereinafter "Defendant." Victim believes she is pregnant with Defendant's child.

Victim stated early that morning, at approximately 3:30 a.m., she was with Defendant in their room at the hotel when Defendant got angry at her because he believed she was hiding heroin from him. While in the bathroom, Defendant started grabbing her breasts and bra in an attempt to search for the drugs. At one point, Defendant cornered her and forcefully pulled down her pants and underwear. Defendant then penetrated both her vagina and anus with his fingers as he continued to look for the drugs. Victim stated after Defendant left the bathroom, she waited a while, then crawled out of the bathroom and fell asleep on the bed. A short time later, Defendant woke her up and started arguing with her again. During the argument, Victim tried to leave but Defendant prevented her from leaving. Defendant grabbed Victim by the neck and pushed her against the wall. Defendant squeezed Victim's neck for approximately 30 seconds. Victim stated she had trouble breathing and her vision started to narrow. Defendant eventually released his grip and Victim fell to the ground. Victim had injuries to her foot, pinkie finger, bicep and neck.

Officers located Defendant inside the hotel room and placed him under arrest. Defendant has a prior conviction for felony Stalking on April 10, 2018, in Anoka County file no. 02-CR-17-6539. Defendant is currently in custody.
