COMPLAINT

The Complainant, being duly sworn, makes complaint to the above-named Court and states that there is probable cause to believe that the Defendant committed the following offense(s). The complainant states that the following facts establish PROBABLE CAUSE:

Complainant, Luke Huck, of the University Of Minnesota Pd, has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On November 20, 2013, Minneapolis Police Officers were dispatched to a robbery that had just occurred, located in the city of Minneapolis, Hennepin County, Minnesota. Upon arrival, officers spoke to the victim, a known adult male

The victim reported he was walking home from the library when he was approached by a male who yelled "motherfucker" and punched him on the right side of the face. The victim reported he fell to the ground and loss consciousness. The victim further stated when he came to, his backpack and wallet had been stolen including his laptop computer and credit cards.

The victim was able to track his computer using a tracking device that led officers to a specific residence. The residents of the home turned over the computer to law enforcement and informed police that **MYRON JOVAN RICHARDSON-RIVERS**, dob 02/27/1993, the Defendant herein, had brought the computer to the home.

Further investigation also revealed that the victim's credit card was used at a nearby gas station. Video surveillance at the gas station shows the Defendant enter the store and also pay for gas at the pump using the victim's credit card.

In a post-*Miranda* statement, the Defendant admitted to being an active participant in the robbery. He claimed that another male punched the victim and that he, the Defendant, was the one who took the victim's backpack with the computer inside.

The victim reported that his I-Mac laptop computer is valued at \$2,000.00.

The Defendant is presently in custody.

COUNT 1: AGGRAVATED ROBBERY FIRST DEGREE (FELONY)

PENALTY: 0-20 YEARS AND/OR \$35,000

That on or about November 20, 2013, in Hennepin County, Minnesota, **MYRON JOVAN RICHARDSON-RIVERS**, acting alone or intentionally aiding, advising, hiring, counseling or conspiring with another, took personal property, from the person or in the presence of the victim, knowing that he was not entitled to the property and used and/or threatened the imminent use of force against the victim, to overcome his resistance or powers of resistance to or to compel acquiescence in the taking or carrying away of the property and inflicted bodily harm upon the victim.
