COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Criminal Sexual Cond-1st Degree-Penetration or Contact with Person Under 13-Actor >36m older

Minnesota Statute: 609.342.1(a), with reference to: 609.342.2(a), 609.342.2(b), 609.101.2, 609.342.2(c), 609.3455.10

Maximum Sentence: 30 YEARS AND/OR \$12,000-\$40,000, PLUS CONDITIONAL RELEASE

Offense Level: Felony

Offense Date (on or about): 10/04/2015

Control #(ICR#): 15373132

Charge Description: That on or about 10/4/2015, in Hennepin County, Minnesota, AHMED HERSI ABDI , born 01/01/1981, engaged in sexual contact, as defined in Minn. Stat. 609.341, Subd. 11(c), with Victim A, a person under the age of thirteen years, and more than thirty-six months younger than AHMED HERSI ABDI .

COUNT II

Charge: Criminal Sexual Cond-1st Degree-Penetration or Contact with Person Under 13-Actor >36m older

Minnesota Statute: 609.342.1(a), with reference to: 609.342.2(a), 609.342.2(b), 609.101.2, 609.342.2(c), 609.3455.10

Maximum Sentence: 30 YEARS AND/OR \$12,000-\$40,000, PLUS CONDITIONAL RELEASE

Charge Description: That on or about 10/4/2015, in Hennepin County, Minnesota, AHMED HERSI ABDI , born 01/01/1981, engaged in sexual penetration with Victim A, a person under the age of thirteen years, and more than thirty-six months younger than AHMED HERSI ABDI .

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On October 4, 2015, an off-duty officer at the Riverside Plaza received information concerning a sexual assault of a child at 1601 South Fourth Street in Minneapolis, Hennepin County, Minnesota. Witnesses flagged officers down. The witnesses said they heard screaming from the third floor hallway and saw a young girl crying. She said a male pulled her pants down and did something to her.

Police located the child, identified herein as Victim A, dob 05/06/2005. A hysterical Victim A told responding police officers that a man followed her onto the elevator. They exited the elevator on the third floor and went to the east hallway. The male asked Victim A for her name. He extended his hand to her. When she shook his hand, he refused to let go. He ordered Victim A to not move. He lifted her dress and pulled her tights down. He made Victim A bend over. Victim A stated he 'did something to me'. In a subsequent SARS exam and interview, Victim A stated the male stuck something in her butt and started to shake. She said she felt wet and slimy after the assault.

Police learned that an ambulance transported the child to the Hennepin County Medical Center for treatment.

She described the male as 40 years old, dark skinned, with gray hair and a light mustache. He wore a red and white striped shirt, black jacket and black shoes. Police recovered surveillance video capturing the suspect and Victim A entering the elevator together. Police identified AHMED HERSI ABDI, the Defendant (dob 1/1/81), from the video. Police later located and arrested the Defendant in St. Paul. He wore the same clothing observed on the video surveillance at Riverside Plaza.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

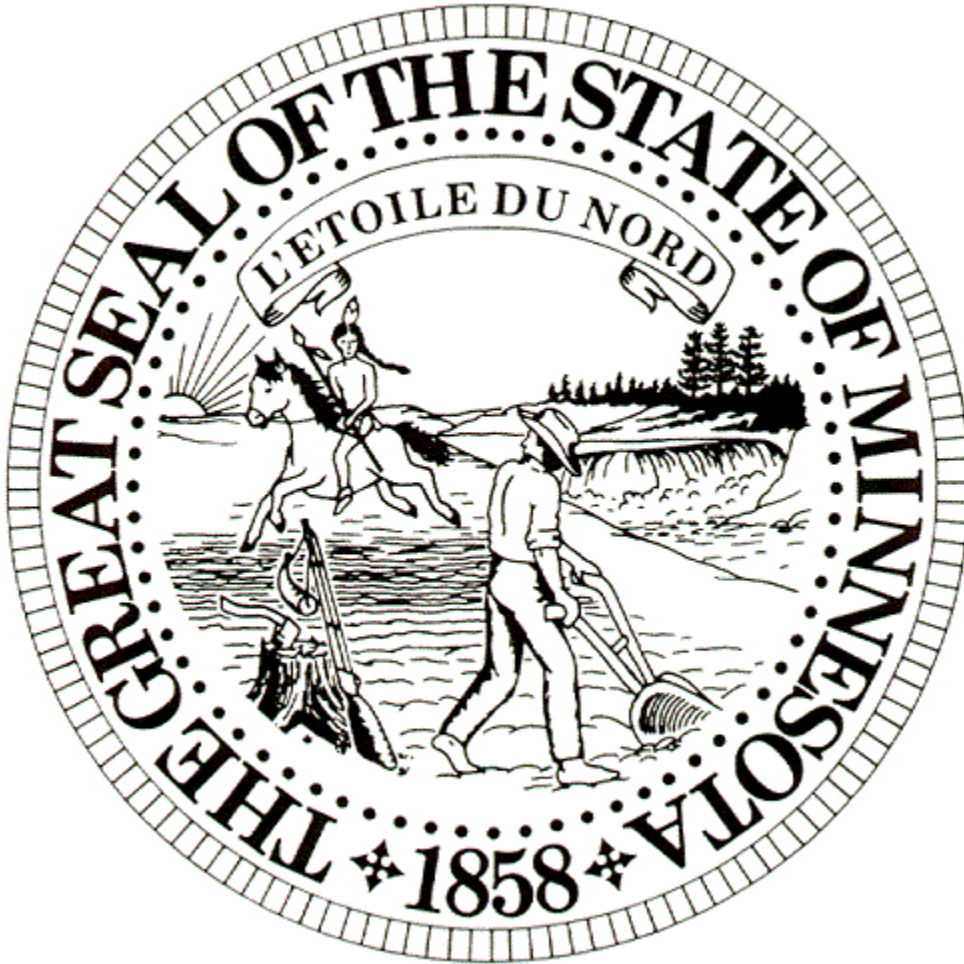
