The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-2nd Degree-Dangerous Weapon-Substantial Bodily Harm

Charge Description: That on or about 8/19/2014, in Hennepin County, Minnesota, PERCY MINIFER LACEY possessed a firearm and PERCY MINIFER LACEY has been convicted or adjudicated delinquent in this state or elsewhere of a crime of violence, Burglary in the Second Degree from July 2011, for which the sentence or court supervision expired on or after August 1, 1993.

Minimum Sentence: 5 YEARS

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On August 19, 2014, officers responded to a call of shots fired in the area of the 3600 block of Columbus Avenue South, City of Minneapolis, County of Hennepin, State of Minnesota. Officers learned that an individual had been shot and was in a nearby apartment. Officers arrived and met with the victim, D.L., who appeared to have been shot in the leg. A second individual, T.M., was with D.L. T.M. told officers that he had been with D.L. and that multiple people shot at them from the corner of 37th Street East and Chicago Avenue South, Hennepin County, Minnesota. T.M. did not know why people would want to shoot at them. D.L. was transported to the hospital.

Officers spoke with a third individual, A.S. A.S. told officers he had been walking with T.M. and D.L. when he observed a gold colored Tahoe drive past them at a slow speed. A.S. said he, T.M., and D.L. were walking westbound 37th Street when someone started shooting at them. A.S. said he jumped in a pond in an effort to avoid being shot.

Officers went to the area of the shooting and recovered twenty-four (24) 9mm discharged cartridge casings. Officers also noted that a business near where the casings were recovered had surveillance cameras pointing toward the street. Officers viewed the surveillance footage, which showed three males walking westbound on from Elliot Avenue to Chicago Avenue with their hands tucked into their clothing. Officers noted that the video shows each of the three men pull out a handgun and start shooting towards Chicago Avenue.

Based on the investigation of law enforcement, officers presented D.L. with a photographic line-up which included the photo of a suspect, PERCY MINIFER LACEY, "the Defendant" herein. D.L. viewed the line-up and identified the Defendant as one of the individuals who shot at him. D.L. further told officers that he had to have a rod inserted into his leg as the bullet shattered the bone.

Your Complaint is aware that the Defendant has a prior adjudication for Burglary in the Second Degree from July 2011.

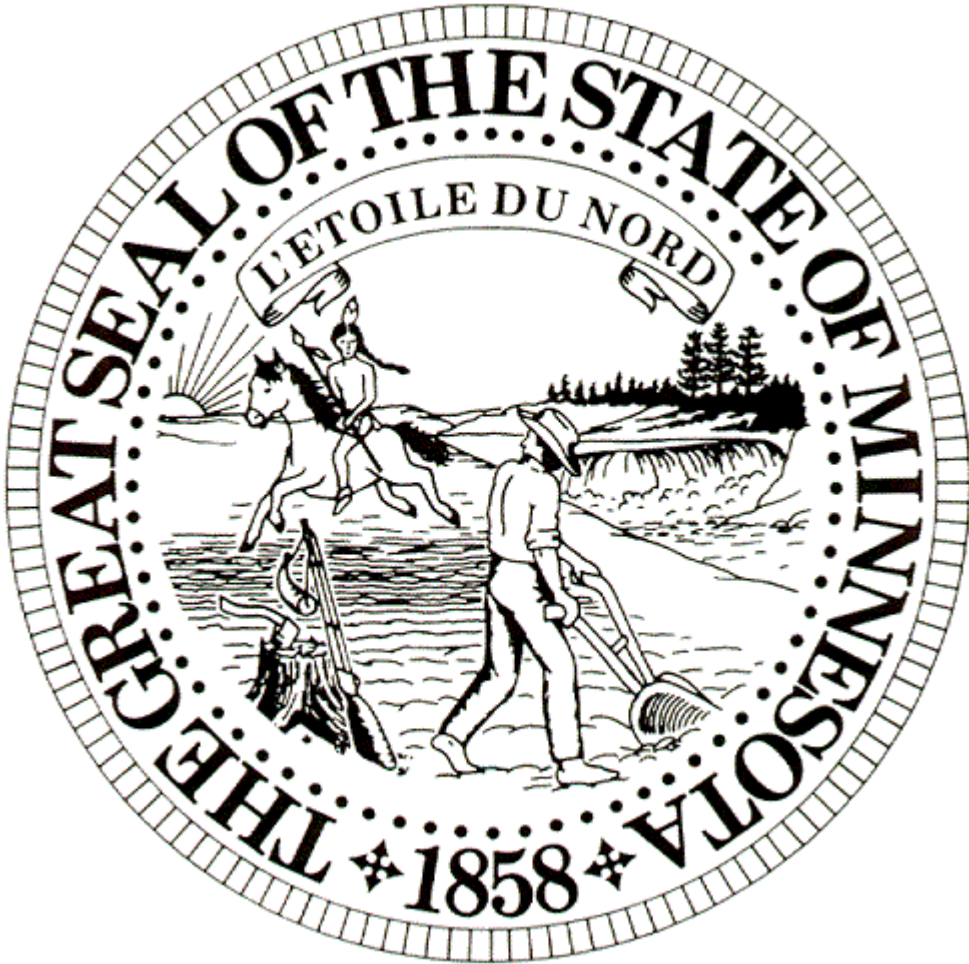
