The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Assault-3rd Degree-Substantial Bodily Harm**

Minnesota Statute: 609.223.1, with reference to: 609.223.1, 609.101.2

Maximum Sentence: 5 YEARS AND/OR \$3,000-\$10,000

Offense Level: Felony

Offense Date (on or about): 05/30/2016

Control #(ICR#): 16180994

Charge Description: That on or about 5/30/2016, in Minneapolis, Hennepin County, Minnesota, CHRISTOPHER REITER assaulted M.O. and inflicted substantial bodily harm.

## STATEMENT OF PROBABLE CAUSE

Complainant, a licensed peace officer with the St. Paul Police Department, has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On May 30, 2016, Minneapolis Police Officers were dispatched to a known apartment building located in Minneapolis, Hennepin County, Minnesota, on a domestic assault call. Officers were informed the offender was M.O. As officers were inside the building speaking to the reporting party, another officer located M.O. in a vehicle parked outside the building.

Once M.O. was located, the other officers returned outside and M.O. was ordered to exit his vehicle. M.O. complied with the order as well as the order to get on the ground. As M.O. was on his hands and knees on the ground, Officer CHRISTOPHER REITER, the defendant herein, approached M.O. and kicked him in the face. M.O. collapsed to the ground unconscious and bleeding. An ambulance was summoned and M.O. was transported to the hospital. At the hospital, M.O. was diagnosed with a displaced nasal bone, nasal septal fractures, and a mild Traumatic Brain Injury.

An investigation was launched regarding the defendant's use of force in this instance. The three other officers on scene were interviewed. All three stated that the situation did not call for the use of deadly force. A kick to the head is deadly force.

Surveillance video from a nearby building captured the assault. The defendant is seen quickly approaching M.O. and violently kicking him in the face within seconds of M.O. going to the ground.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
