The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Terroristic Threats-Reckless Disregard Risk

Minnesota Statute: 609.713.1, with reference to: 609.713.1

Maximum Sentence: 10 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 10/09/2017

Control #(ICR#): 17389618

Charge Description: That on or about 10/9/2017, in Hennepin County, Minnesota, TREVOR DEONTRE SCHLOTFELDT-GIDNEY did threaten to commit a crime of violence with the purpose of terrorizing another, and/or in reckless disregard of the risk of causing terror in another, the victim.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about October 8, 2017, a Minneapolis Police Officer was working off-duty at a night club in downtown Minneapolis, Hennepin County, Minnesota. While working there he denied several known members of the YNT gang entrance into the club due to security concerns as there had been several gang shootings in the area recently. Officers of the Minneapolis Police Department became aware that due to this there were a series of online comments and a video of the interaction shared online.

On October 9, 2017, there were several threats made on Facebook due to the interaction. The comments first stated that "12 won't let Gang in the Club (then middle finger emoji)", the posts then go on to state the officer's name and that he is "a bitch". A Facebook page from a known YNT gang member of TREVOR DEONTRE SCHLOTFELDT-GIDNEY, the Defendant herein, stated "Mfs need wack his bitch ass Fuk 12" and called the officer out by name saying "...Coward Ass Bitch Ass Cop (middle finger with police officer image, explosion image, and handgun image)."

The officer was interviewed and he confirmed reading the Facebook posts while in Minneapolis and stated the words used by the Defendant were seen as a direct threat to his safety and based on his knowledge of this gang, he took this very seriously. The officer stated that by saying "Mfs need to wack his bitch ass", that this was a clear threat that the Defendant is saying either the Defendant or the gang should kill the officer.

The Defendant has had numerous contacts with Minneapolis Police Department including being a suspect in a shooting.

Minneapolis Police have confirmed that the Defendant is an associate of the YNT gang, by in person contact as well as the Defendant's online presence (numerous photos of the Defendant with known gang members using known gang signs) and is aware that the gang has more than three members, has a common name (YNT) and whose members have been engaged in a pattern of criminal activity including murders, shootings, armed robberies and other crimes.

A warrant is requested for the Defendant as his whereabouts are unknown and there is an active probation warrant seeking his arrest.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
