The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Murder - 2nd Degree - With Intent-Not Premeditated

Minnesota Statute: 609.19.1(1), with reference to: 609.11.5(a)

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 10/14/2015

Control #(ICR#): 15385497

Charge Description: That on or about 10/14/2015, in Hennepin County, Minnesota, JONTREL MARQUISE BOLDEN, caused the death of E.L., a human being, with intent to effect the death of that person or another, but without premeditation, and did so while using and /or possessing a firearm.

Minimum Sentence: 3 YEARS

COUNT II

Charge: Possess Ammo/Any Firearm - Conviction or Adjudicated Delinquent for Crime of Violence

Minnesota Statute: 624.713.1(2), with reference to: 609.11.5(b), 624.713.2(b)

Maximum Sentence: 15 YEARS AND/OR \$30,000

Offense Level: Felony

Offense Date (on or about): 10/14/2015

Control #(ICR#): 15385497

Charge Description: That on or about 10/14/2015, in Hennepin County, Minnesota, JONTREL MARQUISE BOLDEN possessed ammunition or a firearm and JONTREL MARQUISE BOLDEN has been convicted or adjudicated delinquent in this state or elsewhere of a crime of violence, Terroristic Threats on February 14, 2011, for which the sentence or court supervision expired on or after August 1, 1993.

Minimum Sentence: 5 YEARS

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about October 14, 2015, at approximately 6:20 p.m., officers of the Minneapolis Police Department responded to the area of 30th and Emerson Avenues North, located in the city of Minneapolis, Hennepin County, Minnesota, on a report of a shooting. Upon arrival, officers followed a blood trail inside a nearby church. Inside the church, officers located the victim, E.L., a known adult male, who was unresponsive. E.L. had blood pooling from his upper body and had suffered at least one apparent gunshot wound. Medical treatment was administered to E.L. but he was pronounced deceased on arrival.

In the course of the investigation, law enforcement identified multiple witnesses, reviewed surveillance video from multiple sources, examined the scene, and utilized additional law enforcement tools and forensic analysis which revealed the following:

Just prior to the shooting, E.L. disembarked from a Metro Transit bus. Upon exiting the bus, E.L. engaged in a verbal argument that turned physical with a male positively identified as JONTREL MARQUISE BOLDEN, DOB 2/5/1995, the Defendant herein. The Defendant had also exited a bus just before E.L.

During the altercation, the Defendant was observed pulling a handgun, pointing it at E.L., and firing the gun several times. Reports revealed five to six shots and at least four discharged cartridge casings were recovered at the scene. E.L. ran for cover inside the church and the Defendant fled the area. The Defendant's whereabouts are still unknown.

The Defendant's criminal history revealed he was adjudicated delinquent of Terroristic Threats on February 14, 2011, a crime of violence.

The Defendant is not presently in custody.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.


