The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Domestic Assault - By Strangulation**

Minnesota Statute: 609.2247.2, with reference to: 609.2247.2

Maximum Sentence: 3 YEARS AND/OR \$5,000

Offense Level: Felony

Offense Date (on or about): 12/26/2018

Control #(ICR#): 18419416

Charge Description: That on or about 12/26/2018, in Hennepin County, Minnesota, AARON HERBERT DOERING assaulted M.R., a family or household member, by strangulation.

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about December 26, 2018, Minneapolis police officers were dispatched to a reported domestic assault-in-progress, occurring at an apartment on the 1700 block of Madison Street N.E., located in the City of Minneapolis, Hennepin County, and State of Minnesota. When officers approached the apartment, they could hear a male and female arguing inside. Officers knocked, announced their presence, and entered the apartment. Inside, officers located a male, later identified as the Defendant AARON HERBERT DOERING, born June 2, 1971, and a female, later identified as Victim M.R. Officers separated the parties and inquired what had happened. Officers later determined the Defendant and Victim M.R. both reside at the apartment and are in romantic relationship.

Victim M.R. reported she had been assaulted by the Defendant in the course of an argument that evening. Defendant had grabbed her by the hair and dragged her around the apartment. Defendant slapped and hit her. Victim reported being choked by the Defendant, being unable to breathe, and feeling that she was going to lose consciousness. Victim reported her belief that Defendant would eventually kill her. Officers observed red marks on Victim's forehead and bruising in the shape of fingers appearing on the left side of the Victim's neck.

Victim reported Defendant assaulted her several times in the past. Victim provided pictures documenting prior injuries caused by the Defendant on several occasions. Victim believes Defendant will kill her if he returns to the apartment.

Defendant was arrested on scene and transported to Hennepin County Jail. Defendant remains in custody at this time.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
