

**Audio Dispatch – Track03**

[AUTOMATED VOICE: November 10, 2017, 5:13:34 p.m.]

DISPATCH: Hennepin TAC3 is now in use for Crystal at 1713.

OFFICER: And 4127 I'll be enroute if you can send me the call.

DISPATCH: 1713.

OFFICER: 3307 [inaudible]. I want everybody to just stay back and we'll try to figure out what we got, talked to the mom – or the wife, this is gonna be a dead-end, [inaudible] officers on 53<sup>rd</sup>, it's gonna be north of it and then Angeline is gonna continue on the other side of a park to the left of it, you go down Scott, 53<sup>rd</sup> and Angeline, that area. We'll get everybody to the north and to the left, we'll be coming in from the east and we'll go from there.

DISPATCH: 3307.

OFFICER: [Inaudible].

DISPATCH: 3307, dispatch to 3307. Dispatch to 3300, enroute to Angeline.

OFFICER: 3327, TAC3.

DISPATCH: I have a female on the line that says that he's a former client of hers, she has him on the other line says he wants to die through his arsenal or by officer shooting.

OFFICER: 27, copy that, is the uh mother who left the house, is she still around, do you know?

DISPATCH: My RP states she doesn't know if the wife is around, unknown [inaudible] the mother.

OFFICER: 10-4. Do we have the uh person inside's phone number?

DISPATCH: Negative, we don't have the original RP on the line.

OFFICER: 10-4.

DISPATCH: 1716.

OFFICER: Anybody coming into the area, no lights right now. Don't want him to know we're here.

OFFICER: 3307 [inaudible].

DISPATCH: 3307.

OFFICER: You said you were on the phone with the female who he used to be a client with?

DISPATCH: Affirmative, she did lose connection with him, but we do have his phone number in the call here if we need it.

OFFICER: Copy.

DISPATCH: 1717.

OFFICER: 4127 to 3307, TAC3

OFFICER: Go ahead.

OFFICER: I'm on the west side at Angelina and Scott, do you want anybody over here?

OFFICER: Yeah, stick in place. Like I said, that's over there to the west there should be a park over there and then on the north side uh it's gonna be 53<sup>rd</sup>, have a couple of squads lined up on 53<sup>rd</sup>, try and make our way over there see if uh – we do have a negotiator on scene here, we'll see if we can make contact.

OFFICER: Copy. 4127, I'll be Angelina and Scott, darked out.

DISPATCH: 1718.

OFFICER: 307, where are you at?

OFFICER: Are you looking for 3307?

OFFICER: Yeah, where's uh – what location you at?

OFFICER: I'm at Angeline and Quail.

OFFICER: Got it.

DISPATCH: 3300.

OFFICER: Go ahead.

DISPATCH: I have my call taker on the phone with the male again. Stated that when the police come he will shoot them through the door and blow the place up.

OFFICER: Copy. Can you get a phone number for him please?

DISPATCH: 1720. 307?

OFFICER: Go ahead.

DISPATCH: [Inaudible] phone number for the texts. We also have a possible cell phone number at the beginning of the call.

OFFICER: I'm sorry, can you repeat?

DISPATCH: The RP gave the phone number she has on his file, we also have a possible cell phone number at the beginning of the call.

OFFICER: Copy. Are you able to ping those numbers to see if they come back to this house so we can figure out what one we need to use?

DISPATCH: Copy, I'll check with the Sergeant. 3307 we'll ping the phone at 1723.

OFFICER: 3307, can you go again?

DISPATCH: We will ping the phone to see which one is at this location.

OFFICER: Copy, thank you. And can you start a canine please?

DISPATCH: Copy, we'll start canine at 1724.

OFFICER: 4115, can we get a uh description and uh maybe clothing description of this guy, just in case?

DISPATCH: 3307.

OFFICER: Go ahead.

DISPATCH: The phone number we got is the land-line and the second one is the voice-over Internet out of Champlin.

OFFICER: Copy.

DISPATCH: 1727.

OFFICER: And 3333, this SWAT, I put his uh info in the call [inaudible] a picture.

DISPATCH: 3307.

OFFICER: Go ahead.

DISPATCH: Per the RP, she said that the only way police can get in is through a back window, he has no lights on in the house. He was last at the back side and lost connection.

OFFICER: Copy. Did she say what other statements he made?

DISPATCH: She stated where he was at in the house and that he had more fire power than police do.

OFFICER: Copy. Do we have the - or was she able to give a description of him at all?

DISPATCH: Stand by I'll check. 1736.

OFFICER: And 3307 to all squads on this detail, we just found out information that uh the male found his brother on Monday, his brother committed suicide by shooting himself in the head, uh sounds like we've had contact with him previously regarding suicide and uh this could be a really legitimate chance that's he's gonna um try to commit suicide today.

OFFICER: Plymouth PI to command, we're arriving there, where would you like me to respond to?

OFFICER: For now you can just come to Angeline and Quail. We're still staging, trying to figure out where to go from here.

OFFICER: Copy.

OFFICER: 3800, were you guys able to make out that car?

OFFICER: Arriving right now. A car sitting here uh eastbound with headlights on, it's a silver four-door car.

OFFICER: Copy.

OFFICER: And we've got one blue house which has a garage door open and a maroon SUV, I believe, inside of it. Is that gonna be the target house?

OFFICER: It sounds like that's going to be the target house and that uh the vehicle in the garage is gonna be moms.

OFFICER: Copy that, we'll see if we can a better eye on it.

OFFICER: Is there also a white vehicle there?

OFFICER: Uh from where we're at I can only see one in the garage right now.

OFFICER: Copy that. Mom could've left in the uh - the white car.

OFFICER: Is that a white car coming up to you guys?

OFFICER: 332 to command.

OFFICER: Go ahead for 3307.

OFFICER: We've got a good view, there's one vehicle in the garage, looks like there's one white car that's possibly in the neighbor's driveway to the left, the front bay window, uh no drapes, can see in, we do not see anyone inside the residence at this point.

OFFICER: 4114 copy.

DISPATCH: 3307.

OFFICER: Go ahead.

DISPATCH: [Inaudible] found a possible cell phone for the male, it did register to the mother and it last pinged less than a half a mile from that residence.

OFFICER: Copy. And just an update, the description's gonna be approximately five-six, uh slim to medium build, wearing blue jeans and a light colored sweatshirt, poss – possibly with Morris on the front.

DISPATCH: 1744.

OFFICER: 332 to command. Appears there is one light on in the house, possibly a kitchen and then the lights on are in the garage, but no change.

OFFICER: Copy.

OFFICER: 332 to command, if you're attempting to make a call in we are hearing it from here.

OFFICER: Negative [inaudible].

DISPATCH: 3307.

OFFICER: Go ahead.

DISPATCH: The male just called dispatch stated he is coming out shooting and hung up.

OFFICER: Copy. 3307 to squads, what we're gonna do is we're gonna start moving up on the house on foot, we're gonna set up a perimeter one to two houses out, make sure that everybody's safe. We're gonna make contact with our [inaudible] and see where we go from there. Uh squads on 53<sup>rd</sup>, if you can, take cover behind a house uh perimeter, we're gonna be making up our way left on Angeline and uh hopefully we can make contact.

OFFICER: 332 contact, individual did come into the garage, description is correct, same sweater, same blue jeans, correct height, smoking a cigarette, was yelling, has gone back into the house.

OFFICER: Copy.

OFFICER: 327 and 22 copy on TAC3. 3827 to 3307, do you want us to meet up with you somewhere, we're still on 53<sup>rd</sup>.

OFFICER: No, we wanna keep you on 53<sup>rd</sup>. You're gonna be my rear perimeter.

OFFICER: Copy that, we're about mid-lot.

OFFICER: If you could go east, that's fine, just make sure you guys get good cover.

OFFICER: Copy.

OFFICER: I'm sorry, I meant west.

OFFICER: Quick FYI, he does have a 45 revolver and a 9-millimeter, has shot them several times [inaudible].

OFFICER: Okay, any officer who's at 53<sup>rd</sup> and Quail – or Angeline and Quail, let's meet up, we're gonna grab some bunkers and we're gonna move up.

OFFICER: 332, house to the west we have an individual outside smoking, they are getting into a vehicle and we've got kids.

OFFICER: 4115, what uh color is the house?

OFFICER: Looks like a white house, it's got a blue light out front, individual is standing outside smoking right now, kids back inside.

OFFICER: All right, I'm gonna try to get the – a sight on the back yard here.

OFFICER: It's a split level uh garage is detached in the back.

OFFICER: Do we have a free squad that can uh come here to command, Quail and Angeline, less lethal, we need one.

OFFICER: 4126, I can uh start heading that way.

DISPATCH: 3307, we do have the party back on the line again.

OFFICER: 3307, I copy. Can you see if he would be okay with talking to one of our officers and if so we'll have you patch him in with 3327.

DISPATCH: Copy, he disconnected, all he kept saying was he's gonna kill himself.

OFFICER: Copy. We're gonna be moving up to the house.

OFFICER: 332, house to the west is back inside, we've got no residents outside right now.

OFFICER: Copy. Can you give a description of the house again?

OFFICER: It's gonna be a blue house with a large bay window in the front then the garage is gonna be on the west side tucked back a little bit, open garage door, maroon vehicle inside.

OFFICER: 3306 to 3307.

OFFICER: Go ahead.

OFFICER: About five minutes out if you want one more body, a canine or whatever.

OFFICER: Yeah, we'll take you. On your way up why don't you start calling night-shifters in?

OFFICER: Copy that. 169 and 49.

OFFICER: 332, light inside of the residence is now off.

OFFICER: 07 on TAC3. I'm gonna go radio silence and I'm gonna call.

OFFICER: Copy. You're good to go, walking up to the house.

OFFICER: 10-4, if anyone's free I could use you as a liaison on my squad.

OFFICER: 3800, [inaudible] do you have eyes on us, we're making our way up to the house.

OFFICER: 3822, repeat.

OFFICER: I was wondering if you have eyes on us, we're making our way up to the east side here.

OFFICER: Negative, we're positioned directly across, we are not able to see to the east. We still have another resident outside of the house to the west getting into the black car right now. I think we've got one individual in the black car in the driveway, another person went back inside of the residence. One to the west of the target address.

OFFICER: 4115, I'm in the back yard of 5127 53<sup>rd</sup> there's a uh six-foot tall privacy fence separating the uh two houses here.

OFFICER: 27, do you have a liaison?

OFFICER: 332, we've got a whole family coming out of the other address.

OFFICER: 4126 to uh 3307, you got a spot over there for 308?

OFFICER: Yes. So at uh Quail and Angeline there's a walking path that goes south then it's gonna be – go west along those railroad tracks, keep going there, you're gonna meet up with Robbinsdale, they've got two officers over there directly across uh the street behind a couple of houses, be a good spot for a sniper.

OFFICER: Copy. [Inaudible].

OFFICER: 332 address to the west is clear. Appears all occupants are now gone. Yeah, we copy. Okay, we're in position to the house to the east. 332, do you have any visual on the suspect?

OFFICER: Negative, there was possible yelling about 10 seconds ago, we have no visual and it is dark inside of the residence now.

OFFICER: He just called sister, told 'em he's coming out, he's going to find the police to have a shoot-out, he might be entering in the Buick. Told her he loved her and that was it.

OFFICER: 332, light off in the garage, lights on in the house.

OFFICER: He's not answering his phone.

OFFICER: 332, in the event that he does leave the house we are going to stay where we're at to prevent crossfire. 332, light on garage, light off house. In the garage, suspect is in the garage coming out into the driveway right now, cigarette in right hand.

DISPATCH: Suspect coming out, 1805.

OFFICER: 332, at the end of the driveway, unknown object in left hand.

DISPATCH: Suspect at end of driveway, unknown object in left hand, 1805.



OFFICER: 332, right hand is possibly laser sight, I see the red. Walking back northbound, yes, definitely laser sight on the ground.

OFFICER: Phone is now busy.

OFFICER: Inside of the garage.

[Screaming in background]

OFFICER: Yelling, [inaudible].

OFFICER: Yelling...

[Shot fired]

OFFICER: Whoa, shots fired, shots fired.

DISPATCH: Shots fired at 1806.

OFFICER: Okay, we have one shot fired, 3307, we have one shot fired that was not an officer. That came from the garage.

DISPATCH: Shots fired from the garage at 1807.

OFFICER: Phone's still busy.

OFFICER: 06 to 07, I'm moving up on foot. Where are you exactly, where do you want me?

OFFICER: Okay, we're – we're one house east of where the cul-de-sac actually starts on the north side, you'll see us in the front yard.

OFFICER: 26, I'm getting closer if you're gonna make entry I can join your team.

OFFICER: Be aware, I'm moving east to west on the north side, I'm coming in.

OFFICER: 3304, [inaudible].

OFFICER: Okay, we're hearing a lot of yelling from him, he's basically saying that he wants it over, he's pretty upset.

OFFICER: Do you guys want us to hold our position on the other side of that fence?

OFFICER: 332, possibly going back inside of the residence now.

OFFICER: 3304, I'm [inaudible] just trying to confirm here, did the suspect fire a shot?

OFFICER: [Inaudible] 04, affirmative, one shot was fired, shot at [inaudible] in the garage.

OFFICER: 332, still in the garage, the northeast corner of the garage, do not have a visible at this time.

OFFICER: 3307 to dispatch.

DISPATCH: 3307.

OFFICER: I need you to start trying to find phone numbers for the addresses surrounding this house and calling them, telling them to get in the basement, we see movements to the house to the west of us, they're inside, see what you can do about phone numbers and getting them into their basements.

DISPATCH: Copy, we'll get residents surrounding to the basements.

OFFICER: 332, out of the garage, out of the garage. 332, back in the garage, northeast corner of the garage.

OFFICER: 4115, to 3307, uh do we have anybody uh at the very...

OFFICER: 4126, are you in position?

OFFICER: 3822 to 3307 on H-TAC3.

OFFICER: Go ahead.

OFFICER: Can we just do a quick roll call, make sure we know where everyone's at right now? Myself and 27 are at 53<sup>rd</sup> and Regent.

OFFICER: Copy, we have [inaudible] canine, uh [inaudible] sergeant, 3306, 4127 and myself the front yard...

[Screaming in background]

OFFICER: For the house directly east.

OFFICER: 118's on Scott just uh west of the address and uh be advised I'm with [inaudible] as well...

OFFICER: 3832 and 330 are just south of the target address eyes on, individuals still in the garage.

OFFICER: 3800, do you guys have anybody who's available to get the armor?

OFFICER: We do, I will uh get a hold of 3807 and I'll have him get it.

OFFICER: I think at this point we're gonna need the armor, we need to get eyes on this guy. I don't know what he's gonna do when he actually sees us so that's a problem.

OFFICER: 3822, we copy.

OFFICER: 3832 we have the sniper with us now, possibly he's gone back inside of the house, unable to hear anything.

OFFICER: Copy.

OFFICER: 4150, I am across the street from the target house in the back yard right now.

OFFICER: 412 – or correction, 332 [inaudible] are you continuing to try to make contact?

OFFICER: 10-4, busy, I believe it's off the hook.

OFFICER: Dispatch thought that they had a possible cell phone number for him, have you tried that?

OFFICER: I did, this number I got is from his daughter 'cause it's the only way – that's what he's been calling them on.

OFFICER: 4115, is the target house directly to the west of that brown house?

OFFICER: Correct, 'cause you can see us we're at the front door of the brown house, the blue house directly west is the target house.

OFFICER: Copy.

OFFICER: 3800, do you still have two people to the north of the target house?

OFFICER: Myself and uh 4118 are to the north. 3822 why don't you get the Humvee.

OFFICER: Okay. If I can have one of you actually make your way west and you're gonna try to come up, there's a – there's a playground if you go west on 53<sup>rd</sup> and then take your first left there's a playground over there. You should be able to make your way to the back of the house directly west of the target house, see if you can make it in the back yard and make contact through a back window or back door for that house and you can put those people – I wanna make sure those people don't come out of their house right now.

OFFICER: Did anyone just hear a phone ring?

OFFICER: Negative, I will say we're probably not close enough unless the doors or windows are open.

OFFICER: 10-4, I have another possible number but it rings to an all circuits busy. If it is a good number he's just sending me to voicemail now.

OFFICER: Copy.

OFFICER: 3304 to 3307.

OFFICER: Go ahead.

OFFICER: Where's your command post gonna be?

OFFICER: At uh Angeline and Quail.

OFFICER: Copy.

OFFICER: 15 to 26 where exactly are you uh across the street?

OFFICER: 27 to 07, you want the uh gray or bluish house evacuated, is that correct?

OFFICER: You can evacuate 'em out the back, that's fine, I would at least want 'em -- is to get in the basement.

OFFICER: All right, we'll see what we can do.

DISPATCH: 3300 and 3800, I have him on the line now [inaudible].

OFFICER: Copy. See if you can patch him to 3327.

DISPATCH: 1820.

OFFICER: 332, we are notifying residents on the south side of the street to bunker in place.

OFFICER: 3325 to 3307, I'm arriving, where do you want me?

OFFICER: We're gonna keep you clear right now.

OFFICER: 10.

OFFICER: 4126 to 3307, just uh for clarity here target house has a maroon SUV in the garage, is that correct?

OFFICER: I'm unable to answer that, 3800 can answer it, I believe it's a blue house on the north side directly where the cul-de-sac circle starts. Uh there's a brown house directly to the east of it. And 3307 to dispatch, can you see if you can get a phone number for 5122 Angeline and make contact with them, tell 'em to come to the door.

DISPATCH: Dispatch copies at 1822.

OFFICER: [Inaudible] window [inaudible] so you're advised - are you aware I'm uh in place outside, I can see the full [inaudible] side of the house.

OFFICER: Copy that.

DISPATCH: 3327, I'm just gonna have to transfer him over as he keeps talking.

OFFICER: 3307.

OFFICER: Go ahead.

DISPATCH: Okay, he's very irate, he's threatening to shoot neighbors houses, everyone in sight. I tried transferring him he disconnected on me.

OFFICER: Copy.

DISPATCH: 1823.

OFFICER: Living room light just went off.

OFFICER: Okay. With these threats, with one shot already fired, with him coming out if we get a shot we're gonna take a le – less lethal shot, that's gonna be the first shot, okay? If we're able to, we're gonna take him down, if not and lethal force is needed then do it, be smart with this, okay? We cannot have him shooting other houses though.

OFFICER: 332 copies, he's past the window, he's at the bay window.

OFFICER: 3304, make sure nobody's exposed [inaudible] cover.

OFFICER: Okay, I see a laser sight in the uh bay window again.

OFFICER: Was anybody able to clear the house to the west?

OFFICER: We're working on clearing houses here, we had no contact with the one.

OFFICER: Copy.

OFFICER: 332, suspect's moved from the bay window.

DISPATCH: 3307.

OFFICER: Go ahead.

DISPATCH: Do you want 5122 Angeline to the front door or back door?

OFFICER: Back door.

DISPATCH: Copy, we're having them go to the back door now, 1825.

OFFICER: 3822 to 3307, I'm enroute with the Humvee.

OFFICER: Copy. I'm gonna just have you stage it uh at Angeline and Unity – or I'm sorry, Quail.

OFFICER: 10-4.

OFFICER: Black to Hardy, where exactly are you?

OFFICER: 332, Hardy is with us, we are just south of the residence.

OFFICER: Copy, are you across the street?

OFFICER: 10-4.

OFFICER: Copy, I'm just making sure [inaudible] there.

OFFICER: Copy, yes, we're in the back yard of the tan and maroon house.

OFFICER: [Inaudible].

OFFICER: 3832, sniper has shadow in bay window.

DISPATCH: 1828.

OFFICER: 04 to 07.

OFFICER: Go ahead.

OFFICER: Is the Quail at uh Angeline spot, out of sight of the house?

OFFICER: Yes.

OFFICER: 4104, house to the east is uh evacuated.

DISPATCH: House to the east is evacuated, 1829.

OFFICER: He's in the garage, he's in the garage.

DISPATCH: 1829.

OFFICER: Shots fired, shots fired again.

DISPATCH: Shots fired at 1830.

OFFICER: Back door to the garage.

OFFICER: Less lethal deployed or no?

OFFICER: 4104, negative, shots fired suspect only.

OFFICER: We got a visual, he's in the garage.

OFFICER: Is he still moving?

OFFICER: Yeah, he's uh screaming. He's got uh – I can't tell what he's got in his hand from here, he's uh talking to himself.

OFFICER: [Inaudible] suspect, the sniper does not have a shot right now.

OFFICER: 4115, I got a perfect shot right now.

OFFICER: Copy.

OFFICER: 3822 arriving at Quail at Angeline.

OFFICER: He was waving the laser around.

OFFICER: Do we have any squads on scene?

OFFICER: 04 is just arriving, he'll be coming to scene and [inaudible].

OFFICER: All right, he's extremely agitated uh almost to the uh – the entrance to the garage now.

OFFICER: Gun in right hand, middle of the garage.

DISPATCH: 3300 just be advised he's on the phone with his sister, I can hear him yelling as they have the phone up to my phone.

OFFICER: Copy.

DISPATCH: They are trying to talk him down.

OFFICER: Whoever's – whoever squad car has their siren on, kill it right now.

OFFICER: All right, he's walking out of the garage.

OFFICER: Shots fired, suspect down.

DISPATCH: Shots fired suspect down, 1833.

OFFICER: Where is he shooting, where is he pointing the gun when he shoots?

OFFICER: That was a [REDACTED] subject down.

OFFICER: Copy [REDACTED] officer shot him, he's down. We're gonna be making our way up to the next corner to get a visual, we're moving west.

DISPATCH: Copy, suspect down, officer shot him, 1834.

OFFICER: 3304 is North on standby?

OFFICER: 3832, we do not see movement on suspect. We have a long cover.

[Screaming in background]

OFFICER: Less lethal only.

DISPATCH: Less lethal only at 1834.

OFFICER: 04, I'm letting North [inaudible] know when we're code 4, bring medics in please.

OFFICER: [Inaudible] [REDACTED] to command I'm holding position here.

OFFICER: 3307, we're code 4. He's in custody [inaudible] north of here.

DISPATCH: Copy, code 4, one in custody north of the residence at 1835.

OFFICER: 07, I'm enroute to you in the [inaudible].

OFFICER: 04, I'm coming in with the north [inaudible].

OFFICER: 332, we're clearing the house.

OFFICER: [REDACTED] to command, I'm gonna make my way back to the street but I'm gonna leave my stuff in place here.

OFFICER: 3304, I need an officer to stay with [REDACTED] equipment.

DISPATCH: 307.

OFFICER: Uh [REDACTED] I'll wait here, I guess, until somebody can come sit with this.

OFFICER: 327 to 3307, I'm gonna clear this area, do you want me uh to come back to your location?



DISPATCH: Dispatch to command, H-TAC3.

OFFICER: 3307, go ahead.

DISPATCH: Do we need a cancellation page sent for SWAT.

OFFICER: Affirmative, SWAT can cancel.

DISPATCH: Thank you, 1839.

OFFICER: Is there a 3300 in their squad down by Quail and Angeline, somebody circle back and bring their squad up here.

OFFICER: 325.

OFFICER: Albers, are you back?

OFFICER: Your car or are you at the scene still?

OFFICER: Still at the scene.

OFFICER: Copy that. [Inaudible] squads but I don't know who's they are, so [inaudible].

OFFICER: [Inaudible] Scott [inaudible] 2 or 3, just hold up, hold up right there.

OFFICER: Angeline?

OFFICER: Yeah, swing back around, grab a different car you need to be free, we can't have everybody tied up here.

OFFICER: Okay.

OFFICER: 3307, uh I'm assuming we have Crime Lab, I'm just double-checking are they en - enroute?

DISPATCH: Negative, I can start Crime Lab.

OFFICER: Yes, please start them.

DISPATCH: 1844.

OFFICER: 3325.

DISPATCH: 3325.

OFFICER: Please start one more North over to the area.

DISPATCH: Do you have a reason?

OFFICER: Just to check an officer.

DISPATCH: Copy, do you need 'em on the red?

OFFICER: Negative, routine's fine.

DISPATCH: 1845.

OFFICER: 3304 to dispatch, uh Quail and 53<sup>rd</sup> is where we need North to check an officer.

DISPATCH: Copy, it's Quail and 53<sup>rd</sup> at 1845.

OFFICER: 4104, do we have a free perimeter squad that actually come here to the cul-de-sac, we're gonna need one more squad to help uh keep – contain this cri – crime scene.

OFFICER: 4115, I'm on my way.

DISPATCH: 4115, 1847.

OFFICER: 3307.

OFFICER: Go ahead.

DISPATCH: Do you still need the neighbors bunkered in their basement?

OFFICER: Negative, uh can you tell me who you got a hold of and I can uh – I can make contact with them as well.

DISPATCH: Copy, or we can – we have a phone list if you need us to call 'em
