The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 - Not Small Amount Marijuana

Minnesota Statute: 152.025.2(1), with reference to: 609.101.3, 152.025.4(b)

Maximum Sentence: 5 YEARS AND/OR \$3,000-\$10,000

Offense Level: Felony

Offense Date (on or about): 01/22/2018

Control #(ICR#): 18000920

Charge Description: That on or about 1/22/2018, in Hennepin County, Minnesota, CORTNEY ANN METCALFE unlawfully possessed one or more mixtures containing a Schedule I, II, III, or IV controlled substance, to-wit: heroin.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On January 22, 2018, officers were conducting a narcotics investigation involving CORTNEY ANN METCALFE, "the Defendant" herein. As part of that investigation, officers had obtained a search warrant for the person of the Defendant. Officers brought the Defendant to the Hennepin County Medical Center ("HCMC"), City of Minneapolis, County of Hennepin, State of Minnesota. While at HCMC, officers noted that the Defendant was restless as she sat on a bench. Officers observed a plastic bindle on the ground underneath where the Defendant was seated. The bindle was found to contain 0.55 grams of heroin. The heroin did later field test positive. Heroin is a Schedule I controlled substance.

Officers spoke with the Defendant who stated that the heroin had been located in her vagina.

Defendant is in custody.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
