The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Murder - 2nd Degree - With Intent-Not Premeditated

Minnesota Statute: 609.19.1(1), with reference to: 609.11.5(a), 609.19.1

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 04/26/2018

Control #(ICR#): 18131061

Charge Description: That on or about 4/26/2018, in Hennepin County, Minnesota, WILLIE B BROWN Jr, caused the death of victim, a human being, with intent to effect the death of that person or another, but without premeditation, while using a firearm.

Minimum Sentence: 3 YEARS

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

That on April 26, 2018, at approximately 5:08 a.m., officers were dispatched to 1910 Newton Avenue North in Minneapolis, Hennepin County, Minnesota, in response to a shot spotter activation indicating three shots were fired at this location. Upon arrival, officers observed the body of an adult male, hereafter victim, lying in the street. Victim was determined to have sustained three gunshot wounds to the face/neck area and was bleeding profusely. Victim was transported to the hospital where he was pronounced dead. Officers located three discharged cartridge casings at the scene.

Officers spoke with a nearby resident who reported she heard shots, looked outside, and saw a black male standing by a black colored vehicle. This witness observed the black male step over a body lying on the street, enter the vehicle, and leave the scene. This witness initially described the vehicle as a black Mazda but then indicated it was a black Chevrolet Impala.

Officers spoke with several individuals who reported victim was with WILLIE B BROWN, JR., hereafter defendant, earlier in the morning. These witnesses explained that on April 24, 2018, defendant was at a residence on the 2900 block of Sheridan Avenue North and attempted to proposition a female inside the residence. Male relatives of the female intervened and an argument ensued. Defendant ended up leaving. Defendant returned to this residence on the night of April 25/early morning of April 26 and confronted the male relatives. Victim arrived driving a black Chevrolet Impala and intervened to diffuse the situation. Thereafter, victim and defendant left in victim's Chevrolet Impala.

Officers spoke with victim's wife who reported she had rented the Chevrolet Impala and that victim was in possession of the vehicle.

On April 26, 2018, at approximately 7:39 a.m., as the investigation into the homicide at 1910 Newton Avenue North continued, officers were dispatched to the 2900 block of Sheridan Avenue North to investigate a report of multiple shots fired. In route, officers were advised that a black male driving a black Chevrolet Impala was firing multiple rounds into the above-referenced residence on the 2900 block of Sheridan Avenue North. Upon arrival, officers spoke to the resident (the same female who was propositioned earlier by defendant) who reported she observed defendant driving past and shooting at her residence. Defendant was driving victim's Chevrolet Impala. Other witnesses reported seeing a male shooting at the residence and that the male was in possession of two handguns.

Officers searched the area and located the black Chevrolet Impala parked and abandoned. The vehicle was running. The vehicle's interior was covered in a blood like substance. The vehicle was confirmed to be the rental vehicle of victim's wife.

Officers located defendant walking in the area and arrested him. Officers retraced defendant's steps and located two handguns stashed in a gutter of a detached garage in the area. One of the handguns had a blood like substance on it. The handguns were determined to be a .40 caliber and a .9mm. The three discharged cartridge casings found at the murder scene were .40 caliber and the large number of discharged cartridge casings located in front of the residence on the 2900 block of Sheridan Avenue North were a mix of .40 caliber and .9mm.

Officers received information from the Brooklyn Park Police Department that blood soaked clothing was located in a car wash in that city. Officers were also advised that video surveillance was available. Officers

recovered the bloody clothing and video surveillance. The video is of sufficient quality such that individuals and vehicles can be identified. The video depicts defendant at the car wash driving victim's Chevrolet Impala, exiting the vehicle, and entering the car wash where the bloody clothing was deposited. These recorded actions occur at a time between the homicide on Newton Avenue North and the later shooting on Sheridan Avenue North.

At present, defendant is in custody.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
