The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

#### **COUNT I**

Charge: Drugs - Aggravated Controlled Substance Crime 1st Degree and Firearm

Minnesota Statute: 152.021.2b(1), with reference to: 609.101.3, 152.021.3(d)

Maximum Sentence: 40 YEARS AND/OR \$300,000-\$1,000,000

Offense Level: Felony

Charge Description: That on or about 4/6/2018, in Hennepin County, Minnesota, Gabriel Pimentel-Espinal

#### STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about April 8th, 2018, officers executed a search warrant at 1153 North 7th Street, Minneapolis, Hennepin County, Minnesota.

Officers encountered Defendant GABRIEL PIMENTAL-ESPINAL. Officers recovered multiple documents belonging to Defendant, his wife and his son throughout the apartment.

Officers recovered a Hi-Point .45 caliber firearm and .45 ammunition in the TV stand in the living room area. Officers also recovered a Taurus handgun underneath a bunk bed where Defendant's grandchildren were sleeping.

As a result of the warrant, officers recovered several quantities of methamphetamine totaling 903.57 grams and several quantities of cocaine totaling 485.22 grams. Officers also recovered multiple digital scales and over \$100,000 in currency in the home.

In a post-Miranda interview, Defendant admitted that the drugs and firearms belonged to him. He also admitted to dealing drugs to make money.

Defendant is pending a different first degree drug sale, MNCIS 27-CR-18-8884, from March 28th, 2018. Given the risk to public safety this offense poses and concern about ongoing criminal activity, your complainant asks that this matter issue by warrant.

#### SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
