The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Burglary-3rd Deg-Steal/Commit Felony or Gross Misd

Minnesota Statute: 609.582.3, with reference to: 609.582.3, 609.11.5(a)

Maximum Sentence: 5 YEARS AND/OR \$10,000

Offense Level: Felony

Offense Date (on or about): 03/09/2019

Control #(ICR#): 19001462

Charge Description: That on or about 3/9/2019, in Hennepin County, Minnesota, JOHN ROSS WHITAKER, either directly or as an accomplice, entered a building without consent and with intent to steal or commit any felony or gross misdemeanor while in the building, or entered a building without consent and stole or committed a felony or gross misdemeanor while in the building, while possessing a firearm

Minimum Sentence: 3 YEARS

COUNT II

Charge: Receiving Stolen Property

Minnesota Statute: 609.53.1, with reference to: 609.52.3(1)

Maximum Sentence: 20 YEARS AND/OR \$100,000

Offense Level: Felony

Offense Date (on or about): 03/09/2019

Charge Description: That on or about 3/25/2019, in Hennepin County, Minnesota, JOHN ROSS WHITAKER received, possessed, transferred, bought or concealed stolen property or property obtained by robbery, and JOHN ROSS WHITAKER knew or had reason to know the property was stolen or obtained by robbery, and the property was a firearm.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

That on March 9, 2019, at approximately 2:28 a.m., St Louis Park Police were dispatched to Frontiersman in St. Louis Park, Hennepin County, a business which sells guns and ammunition on a call of a security alarm being activated. Upon arrival, officers heard the audible alarm and checked the perimeter however did not detect signs of forced entry. No one was found inside the business.

The owner later came to the store and reviewed surveillance video. The video shows an individual wearing all black clothing, shoes and a black mask or balaclava concealing almost the entire face. Only the eyes and the bridge of the nose were visible, showing what appeared to be a Caucasian male. The owner reported that no one had permission to be in the business at the time of the burglary.

The video shows this person, later identified as Defendant herein, JOHN ROSS WHITAKER III, age 25, DOB 3-25-1994, in the front area of the store and walking toward a display of 9mm handguns. Defendant is seen selecting two 9mm handguns, an H&K make and a Walther make. Defendant is then seen selecting approx. 40 boxes of 9mm ammunition which he puts in a duffle. He then is seen taking magazines for the guns he selected. Defendant exits out of the back door. The guns and ammunition were reported stolen with the law enforcement including the ATF.

Additional video from the business shows Defendant at the exterior back door picking the lock, permitting entry into the business. He also picked a lock to an interior door.

Officers recovered video from neighboring businesses and apartment complexes. One of these videos shows a light-colored pickup truck leaving the area at the time of the burglary.

On March 25, 2019, at approximately 5:25 a.m., Eden Prairie Police were called to a residence in Eden Prairie, Hennepin County, on a call of an unwanted person at the residence. Upon arrival, officers met with the homeowner who reported that Defendant, one of his patients, rang his doorbell at 5:15 a.m. and spoke nonsensically. Defendant was dressed in all black and was driving a light-colored pickup truck with U haul lettering on the side. The homeowner told Defendant became afraid for his safety and contacted police.

Eden Prairie Police arrived and found Defendant near the scene. As Officer Moua talked with Defendant, the office saw a handgun in the inside left breast pocket of Defendant's coat. Defendant was immediately detained and officers recovered a second handgun in the right breast pocket of his coat. The guns were loaded and matched the two guns reported stolen from Frontiersman.

Officers also searched Defendant's pickup truck and found a duffle bag containing a black ski mask, lock picking tools and ammunition. Two additional guns were found in a backpack located in the rear of the truck.

Following defendant's arrest, he was interviewed. After having been advised of his rights, Defendant agreed to be questioned. Defendant admitted he burglarized the Frontiersman and stole the guns and ammunition.

Defendant is currently in custody.

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
