The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Burglary-1st Deg-Poss Dangerous Weapon/Explosive

Minnesota Statute: 609.582.1(b), with reference to: 609.582.1, 609.11.9

Maximum Sentence: 20 YEARS AND/OR \$35,000

Offense Level: Felony

Offense Date (on or about): 06/02/2019

Control #(ICR#): 19156928

Charge Description: That on or about June 2, 2019, in Hennepin County, Minnesota, ROBERT EARL BUCKINGHAM, DOB 5/22/1986, either directly or as an accomplice, entered a building, without consent and with intent to commit a crime or committed a crime while in the building and possessed a dangerous weapon, or any article used or fashioned in a manner to lead the victim to reasonably believe it to be a dangerous weapon, while in the building.

COUNT II

Charge: Aggravated Robbery-1st Degree

Minnesota Statute: 609.245.1, with reference to: 609.245.1

Maximum Sentence: 20 YEARS AND/OR \$35,000

Offense Level: Felony

Offense Date (on or about): 06/02/2019

Control #(ICR#): 19156928

Charge Description: That on or about June 2, 2019, in Hennepin County, Minnesota, ROBERT EARL BUCKINGHAM, DOB 5/22/1986, took personal property from the person or in the presence of Victim 2, knowing that he was not entitled to the property and used and/or threatened the imminent use of force against Victim 2 to overcome his resistance or powers of resistance to or to compel acquiescence in the taking or carrying away of the property, while a dangerous weapon, or an article used or fashioned in a

manner to lead the victim to reasonably believe it to be a dangerous weapon.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On June 2, 2019, around 11:12 a.m., Minneapolis Police Department responded to a report of a burglary at a residence on the 2700 block of 12th Avenue South, Minneapolis, Hennepin County, Minnesota.

Victim 2 was at his home watching his brother when an unknown male came through the front door with a handgun, pointed the gun at Victim 2, and demanded that Victim 2 give him all the money in the home. The male was later identified as ROBERT EARL BUCKINGHAM, DOB 5/22/1986, "Defendant" herein, in part because on August 11, 2019 Defendant broke into Victim 2's home again (charged under Court File No. 27-CR-19-19665). Victim 2 reported that it was the same person both times. Police obtained a search warrant for Defendant's phone and determined that Defendant's phone was in the vicinity of Victim 2's home at the time of the burglary on June 2nd, based on the call detail record data.

On June 2nd, Defendant went into the bedroom west of the living room with Victim 2. Defendant grabbed the first piggy bank and smashed it open with his handgun and took money. Defendant attempted to break open a second piggy bank, but was unable to do so. Defendant then went into another bedroom, southeast of the kitchen, and opened up the top drawer of a dresser and took something from inside the drawer. Victim 2 was unsure what was taken. Victim 2's brother was in another bedroom and made a loud noise that spooked Defendant. Defendant demanded Victim 2 to tell him who had made the noise. Victim 2 showed Defendant his brother in the other bedroom. Defendant pointed the gun at Victim 2's brother and shut the door. Defendant went back to the other bedroom and rifled through the dresser drawers before leaving the house. Victim 2 was unsure how much money or other property was stolen.

The following facts may be used as Blakely factors to support an upward sentencing departure and increased bail: the offense occurred where Victim 2 had an expectation of privacy; Defendant has prior convictions where a victim was harmed; Defendant committed the charged crime in the presence of a child; and Defendant has at least five prior convictions for felony Burglary in the First Degree. Defendant is a dangerous offender who has two or more prior convictions for violent crimes and is a danger to public safety.

Defendant is currently in custody on Court File No. 27-CR-19-19665.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
