The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Murder - 2nd Degree - With Intent-Not Premeditated

Minnesota Statute: 609.19.1(1), with reference to: 609.11.5(a), 609.19.1, 609.11.9

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 06/04/2020

Control #(ICR#): 20152438

Charge Description: That on or about June 4, 2020, in Minneapolis, Hennepin County, Minnesota, RYAN VAN FRAZIER JR. caused the death of B.S., a human being, with intent to effect the death of that person or another, but without premeditation, while using a firearm.

Minimum Sentence: 3 YEARS

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On June 4, 2020, at approximately 9:47 p.m., officers were dispatched to a shooting in the area of 14th Street East in Minneapolis, Hennepin County, Minnesota. Upon arrival officers were met by a group of people on the street who were screaming and pointing to a male victim, B.S., who was lying on his back on the north side of 14th Street. Officers immediately began rendering first-aid to B.S. and observed two gunshot wounds to his chest area and another gunshot wound on his left arm. Officers applied pressure to the gunshot wounds and applied a chest seal. Medics and rescue arrived at the scene shortly after officers and transported B.S. to Hennepin County Medical Center where he was later pronounced dead.

Officers spoke to several witnesses who were at the scene, including Witness A. Witness A told officers that she was at her residence on the night of June 4th when she heard banging on her front door and a woman's voice yelling for her to come out and fight. Witness A opened the door and saw a woman she knows as Kayla outside. Kayla is the current girlfriend of Witness A's former boyfriend, RYAN VAN FRAZIER JR., DOB 12/18/1996, Defendant herein. Witness A also observed the Defendant's car parked outside. Witness A called 911 and then called her brother, B.S., asking him to come over in case the Defendant was nearby. Witness A opened her screen door and was immediately attacked by Kayla and the two started to "tussle" on the front lawn. While this was happening, B.S. had also arrived. Witness A heard the Defendant repeatedly tell B.S. "I'm going to shoot you. I'm going to shoot you." B.S. replied by telling the Defendant "I'm not here for all of that" and "If you're going to shoot me, shoot me." Witness A told officers that at one point she observed the Defendant pull a black, semiautomatic handgun from his waistband. Around this same time, Witness A ran inside her home to get her crying baby. While inside she heard 4-6 gunshots. Witness A ran back outside and saw B.S. laying on the ground across the street and observed that the Defendant, Kayla and Defendant's vehicle were gone.

Several other witnesses provided statements to the police indicating that they had heard the altercation between the two woman and then observed two males arguing in front of the address. Witnesses also reported hearing one male say "just shoot me then" or something similar and observed the other male pointing a gun at the first male. This was followed shortly after by 4 or 5 gunshots. One witness described seeing the male with the gun, the Defendant, chasing the other male, B.S., around the street. That same witness observed the female who was with the Defendant hit B.S. This witness then observed the Defendant standing in the street and saw him shoot approximately 4-5 times at B.S., who was standing near the sidewalk across the street.

Car 21 responded and processed the scene. Several items of evidence were collected, including three .45 caliber discharged cartridge casings that were located in a cluster on the north side of the street, one discharged cartridge casing in the middle of the street slightly to the west and one discharged cartridge casing in the street approximately 15-20 feet from the north curb. Based on witness statements, these discharged cartridge casings were located in the area where the Defendant's car had been parked.

The Defendant was gone on arrival and his current whereabouts are unknown.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
