The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

#### COUNTI

Charge: Criminal Sexual Cond-1st Degree-Penetration/Contact - Injury - Use Force/Coerce

Minnesota Statute: 609.342.1(e)(i), with reference to: 609.342.2(a), 609.342.2(b), 609.17.4(2), 609.101.2,

609.342.2(c), 609.3455.10

Maximum Sentence: 15 YEARS AND/OR \$12,000-\$40,000, PLUS CONDITIONAL RELEASE

Offense Level: Felony

Offense Date (on or about): 03/01/2020

Control #(ICR#): 20055652

Charge Description: That on or about March 1, 2020, in Hennepin County, Minnesota, Jory Daniel Wiebrand attempted to engage in sexual penetration with Victim by using force or coercion, and caused

personal injury to her.

Minimum Sentence: 144 MOS

#### **COUNT II**

**Charge: Criminal Sexual Predatory Conduct** 

Minnesota Statute: 609.3453.1, with reference to: 609.101.2, 609.3453.2(a)(1), 609.3453.2(b),

609.3455.7, 609.3455.10, 609.3455.6

Maximum Sentence: 3 YEARS UNDERLYING CRIME + 25%, AND/OR \$20,000

Offense Level: Felony

Offense Date (on or about): 03/01/2020

Charge Description: That on or about March 1, 2020, in Hennepin County, Minnesota, Jory Daniel Wiebrand committed the predatory crime of false imprisonment in violation of Minn. Stat. 609.255 that was motivated by Jory Daniel Wiebrand's sexual impulses or was part of a predatory pattern of behavior that had criminal sexual conduct as its goal.

#### **COUNT III**

**Charge: False Imprisonment-Intentional Restraint** 

Minnesota Statute: 609.255.2, with reference to: 609.255.2

Maximum Sentence: 3 YEARS AND/OR \$5,000

Offense Level: Felony

Offense Date (on or about): 03/01/2020

Control #(ICR#): 20055652

Charge Description: That on or about March 1, 2020, in Hennepin County, Minnesota, Jory Daniel Wiebrand intentionally confined or restrained Victim without her consent, and Jory Daniel Wiebrand knew he did not have legal authority to do so.

#### STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On March 1, 2020, Minneapolis Police officers were dispatched to an apartment complex located on the 700 block of 8th Avenue SE in Minneapolis, Hennepin County, Minnesota on the report of an attempted sexual assault. Officers responded and spoke with a known adult female, Victim herein. Victim reported that she was taking out the recycling when she was attacked. Victim stated that she went to the fenced garbage area and noticed an individual walking towards her. She figured it was just another resident, so she turned to dump her recyclables. When she did, she was attacked from behind. Victim described the assailant as a white male, approximately 30-40 years old with scruffy, greyish facial hair and a straight build who was wearing a black cloth jacket. This assailant was subsequently identified as JORY DANIEL WIEBRAND, DEFENDANT herein, by DNA evidence.

Victim stated that Defendant put one hand over her mouth and the other around her stomach preventing her from getting away. Victim stated that she started screaming and went limp, dropping on to her right hip. During the fall, Victim's glasses were knocked from her face and she sustained an abrasion to her cheek. Defendant also lost his balance and let go of Victim. Defendant then fled the scene. Victim ran to her apartment and 911 was called.

Officers took a swabbing of Victim's face and male DNA was located. This Y-chromosomal profile was compared against Defendant's known sample and found to match.

Defendant was identified through DNA evidence in a string of sexual assaults, assaults, and burglaries in this same Minneapolis neighborhood occurring between 2015 and 2020. These crimes bear a marked similarity in pattern of attack. These crimes include but are not limited to:

On March 23, 2015, Defendant assaulted a known adult female in a parking lot located on the 1300 block of 8th Street SE in Minneapolis. Defendant approached this victim from behind as she cleared snow from her vehicle. Defendant sprayed this victim in the face with pepper spray and threw her to ground. Defendant attempted to remove her jacket but was unable. Defendant held this victim to the ground and penetrated her with his fingers and penis before she was able to break free and flee.

On February 25, 2018, Defendant assaulted a known adult female in the backyard of her residence located on the 800 block of 20th Avenue NE in Minneapolis. Defendant approached this victim from behind and put his hands over her mouth forcing her to the ground. Defendant pulled down this victim's pants and penetrated her with his fingers. He also reached under her shirt and ripped her bra. When he pulled down his own pants, this victim was able to break free and flee.

On August 4, 2018, Defendant assaulted a known adult female on the porch of her residence located on the 800 block of 6th Street SE in Minneapolis. Defendant approached this victim from behind placing his hands on her mouth and neck. Defendant forced this victim into her residence. Defendant grabbed this victim's breasts and penetrated her with his fingers. When he pulled down his own pants, the victim fought back hard. Defendant sprayed her in the face with pepper spray and then fled the residence.

On February 8, 2019, Defendant assaulted a known adult female as she walked from her residence to a bus stop in the area of the 600 block of 8th Street SE in Minneapolis. Defendant approached this victim from behind and put his hands over her mouth as she screamed. Defendant dragged this victim to a nearby wooded area and threw her to the ground. He then grabbed this victim on her crotch over her clothing.

Defendant fled when a neighbor came outside.

On August 7, 2019, Defendant assaulted a known adult female in her residence located on the 700 block of 4th Street SE in Minneapolis. Defendant blitz attached this victim from behind as she entered her bedroom. Defendant put his hands over this victim's mouth and across her neck throwing her onto her bed. Defendant penetrated this victim with his fingers. When she fought back, Defendant sprayed her in the face with pepper spray and fled.

Additional crimes of this nature were committed by Defendant on June 2, 2019, July 18, 2019, July 21, 2019, September 12, 2019, January 3, 2020, February 18, 2020.

Defendant is presently in custody on separate charges. A warrant is requested so that additional bail may be set on this case.

#### SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
