The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-3rd Degree-Substantial Bodily Harm

Minnesota Statute: 609.223.1, with reference to: 609.223.1, 609.101.2

Maximum Sentence: 5 YEARS AND/OR \$3,000-\$10,000

Offense Level: Felony

Offense Date (on or about): 05/12/2020

Charge Description: That on or about 5/12/2020, in Minneapolis, Hennepin County, Minnesota, VENNIE JEROME WILLIAMS assaulted Victim and inflicted substantial bodily harm.

COUNT II

Charge: Harassment - Intent to Injure

Minnesota Statute: 609.749.2(1), with reference to: 609.749.3(a), 609.749.2

Maximum Sentence: 5 YEARS AND/OR \$3,000-\$10,000, 1 YEAR AND/OR \$3,000

Offense Level: Gross Misdemeanor

Charge Description: That on or about 5/12/2020, in Minneapolis, Hennepin County, Minnesota, VENNIE JEROME WILLIAMS harassed Victim by manifesting an intent to injure Victim through the commission of an unlawful act and committed the offense because of the victim's actual or perceived sexual orientation.

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On May 12, 2020, at approximately 9:00 a.m., Metro Transit Police Officers responded to 4th Street and Marquette Avenue in Minneapolis, Hennepin County, Minnesota near the Nicollet Avenue lightrail platform.

There, officers met with a known adult male, Victim herein. Victim reported that he was walking across the Nicollet Avenue lightrail platform when a person he did not know, later identified as Defendant VENNIE JEROME WILLIAMS (6/5/1980), suddenly cocked his right arm back and threw what Victim thought was a rock directly at him. Defendant was about three feet away from Victim when he threw the unknown object. The object struck Victim directly in the left eye and caused a great deal of pain.

Officers observed redness to Victim's eye. Victim stated that his vision was cloudy. Victim went to Hennepin County Medical Center and learned that he had suffered a Corneal and Ocular Abrasion which could lead to permanent damage to his injured eye.

Officers retrieved surveillance camera footage of the incident that clearly captured the assault. Shortly after the assault, Metro Transit officers found Defendant near 6th Street South and Marquette Avenue. Victim was transported to the area for a show-up and he positively identified Defendant as his attacker.

Officers arrested Defendant. While Defendant was seated in the back of the squad car, he began speaking spontaneously. Defendant repeatedly swore and had an angry demeanor. During his rant, Defendant made statements indicating that he had assaulted Victim because he perceived that Victim was homosexual.

Victim attended a follow-up appointment with a specialist who diagnosed him with Traumatic Hyphema of the left eye and Traumatic Iritis. Victim told investigators that his eye was still full of blood and that his vision was still blurry. Doctors advised him that the eye was at a delicate stage of healing and that if the pressure builds up anymore in the eye, he could lose his vision in that eye permanently. Victim was told to stay home to recover and not to do anything physical, including driving or going to work. Victim is required to remain seated upright at all times and is only supposed to move in essential situations. These restrictions are expected to last for at least a week. Doctors also told Victim that as a result of this injury, he will remain at risk for serious medical complications involving the injured eye for many years to come.

Defendant is currently in custody.
