The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Burglary-1st Deg-Dwelling-Occupied-Non-Accomplice Present Minnesota Statute: 609.582.1(a), with reference to: 609.582.1, 609.582.1a

Maximum Sentence: 20 YEARS AND/OR \$35,000

Offense Level: Felony

Offense Date (on or about): 09/20/2020

Control #(ICR#): 20008381

Charge Description: That on or about 9/20/2020, in Hennepin County, Minnesota, DANNY LEE DENZER, either directly or as an accomplice, entered a dwelling, without consent and with intent to commit a crime or committed a crime while in the dwelling and another person, Victim, who was not an accomplice, was in the dwelling at any time while DANNY LEE DENZER was in the dwelling.

Minimum Sentence: 6 MONTHS

STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On September 20, 2020, at approximately 7:25 p.m., officers were dispatched to 28xx 101st Street West in Bloomington, Hennepin County, Minnesota on report of an assault in-progress. Upon arrival, officers found DANNY LEE DENZER, DOB: 8/15/1964, Defendant Denzer herein, walking around inside the home. Defendant Denzer was secured by officers, who then heard a woman screaming in the basement and a male saying "Give me the money." Officers proceeded down the stairs towards the basement and they continued to hear a woman screaming and what sounded like someone being hit.

In the back bedroom, they found a male, later identified as ROBERT LAWRENCE GABIO, DOB: 2/13/1975, Defendant Gabrio herein, and female, Victim herein. Defendant Gabrio had a knife in his hand which he was holding close to Victim. Defendant Gabrio rushed towards officers, holding the knife in a stabbing position before turning back towards Victim. Officers were eventually able to subdue Defendant Gabrio and take him into custody.

Victim stated that she had been talking with her sister when a car backed into her driveway and two males forced their way into her home. She stated that Defendant Gabrio grabbed her by the throat and threw her over the couch. Defendant Gabrio then put her in a headlock and drug her to the basement, displayed a knife, and demanded that she give him cash. Defendant Gabrio put the knife to her throat and pushed her towards a safe in the back bedroom. Defendant Gabrio demanded money and threatened to cut her throat and kill her husband. She said Defendant Denzer was the second male who entered the home.

Victim suffered a cut to her left ear and had several bumps on her head.

During a search of Defendant Gabrio's person, officers recovered a flashlight, several phones, and \$7,160.00 in cash. During a search of Defendant Denzer's person, officers recovered approximately .26 grams of suspected methamphetamine.
