# HENNEPIN COUNTY SHERIFF'S OFFICE INVESTIGATIVE REPORT

#### **SYNOPSIS:**

This report pertains to a digitally recorded interview of a potential witness regarding this death investigation.

#### **OFFICERS INVOLVED:**

From the Hennepin County Sheriff's Office Investigative Division: Det. Nestrud, Det. Braun, Det. Soeffker, Det. Hopkins.

#### NARRATIVE:

On 1-19-2019 I, Det. Aaron Nestrud was assigned to assist with the death investigation of Matthew Neil Tuhkanen (dob 8-4-1983). I arrived on scene and was tasked with conducting a canvas of the occupants of the apartments located within the housing complex located at 2760 Louisiana Court in St. Louis Park, Minnesota along with Det. Braun, Det. Soeffker and Det. Hopkins.

At about 8:17 PM Det. Braun and I knocked on the door of apartment #8. Apartment #8 is directly across the hall from the unit where Tuhkanen encountered law enforcement and subsequently died, apartment #7. These apartments are located on the second floor of the three story housing complex. This report will be a summary of the digitally recorded interview. The complete interview will be saved to the main case file for future evidentiary value. For greater details of the interview refer to the complete digitally recorded interview.

The resident of apartment #8 identified herself as Jessica Marie Stillday (dob 3-7-1981). Stillday stated that a contact phone number for her is 612-407-4867 and that she has lived at this location for about 1 1/2 years.

Stillday stated that about 5:00 PM a male from the unit across the hall (apartment #7) was in the hallway and as Stillday was arriving home he told her that a male had been knocking on her door. Stillday stated that the male that had been knocking on her door was her "baby's daddy" and the male that told her about the male that had been knocking on her apartment door was the "baby's daddy" of apartment #7. Stillday stated that she had never seen that male here before. That male was later identified as Matthew Neil Tuhkanen (dob 8-4-1983). Stillday stated that she could hear the tenant of apartment #7 Mylee Jane Workman (dob 7-8-1981) and Tuhkanen loudly arguing. Stillday stated that Workman has lived at this address for about 3 months.

Stillday stated that she heard Workman tell Tuhkanen "here's your meth, leave." Stillday then stated that Tuhkanen left the hallway and was speaking to an unknown party outside near a vehicle in the parking lot. Stillday stated that Tuhkanen then came back to apartment #7 and was again knocking on the door and saying "son, I love you." Stillday stated that Police Officers arrived on scene and Tuhkanen fled the area to an unknown location but possibly to an apartment on the 3rd floor of this apartment complex.

Stillday stated that after the police left, Workman went upstairs to the 3rd floor and brought Tuhkanen back to her apartment (#7). Stillday stated that she observed both Workman and Tuhkanen enter apartment #7 through the peep hole of her apartment door. Stillday stated that at about 5:56 PM she called 911 Emergency and advised the dispatch operator that Tuhkanen was back in apartment #7 and that she knew Tuhkanen had active warrants and later stated that she could hear Tuhkanen and Workman again arguing.

Stillday stated that the Police again arrived and knocked on apartment #7. Stillday stated she observed Workman open the apartment door and point towards the back of the apartment as Workman left the apartment with her child climbing the stairway towards the 3rd floor. Stillday stated that a few minutes later she heard a "boom, boom, boom, boom" and that she heard Workman yell "oh my God they shot him".

Stillday stated that Workman then waited in her apartment (#8) where Workman told her that Tuhkanen was depressed, bi-polar and that Tuhkanen had wanted to die. Stillday also stated that Workman told her that Tuhkanen had told Workman not to open the apartment door as he had warrants.

Stillday stated that at one point she heard the police yell "put your hands up, get down, get down".

I provided my business card to Stillday and advised her to call if she remembers any additional details.

left.

JMS Yeah.

ADN Right? JMS Yeah.

ADN Do you think he stayed in the building somewhere?

JMS Upstairs, some apartment building.

ADN Do you think he was in one of the apartments up there?

JMS Yeah, yup.

ADN Okay, you don't have idea maybe which one?

JMS No, un-uh.

ADN Um, so then at some point he comes back down, he starts banging on the door

again?

JMS No she went up there and got him.

ADN Oh okay.

ADN Okay. **JMS** Yeah. **ADN** So, what time do you think you ended up calling the cops? Do you remember, um, you guess, can you check your phone? **JMS** 5:56. Okay. So around 5 the, the guy shows up, ah the baby daddy. ADN **JMS** Yeah. **ADN** He shows up the first time, right, the 5 o'clock? JMS: No, that's the second time. ADN Un, you said you called the police at 5:56. **JMS** 5:56. ADN Isn't that what you just told me?

**JMS** Yeah. ADN And earlier you told me that it was around 5pm when you were out here with the groceries and there ... **JMS** ...yeah... ADN ...was banging on the doors... **JMS** ...yup that was him... ADN ...so it's the first time? **JMS** Yeah. **STB** So 5pm was the first time he was here? **JMS** Yes. ADN Okay. So then, uh, so between 5 o'clock, the cops arrived. **JMS** Uh-huh. ADN Tried to talk to him but he left, he went upstairs somewhere... **JMS** ...yeah... ADN ...in one of the apartments? **JMS** Um-hum. How many floors are in this building? ADN **JMS** There is, one, two, three. ADN And we're on the second? **JMS** Yup. Okay, so it's just, it's in the, one of the, was it four upstairs, four apartments? ADN **JMS** One, two, yup four. ADN Okay, so it's in one of the four. **JMS** Yeah. ADN And you're pretty sure he stayed in one of those? **JMS** Um-hum. Okay, so if we go back to when he's at the door, um, did you see them hand ADN him any meth? Do you know if he, uses... **JMS** ...no, I just, I just heard it, I just heard it... ADN ...you just heard him say... ... I was, I was peeking through my peek hole and I heard her say here's your **JMS** meth, go. ADN And that was that first time. **JMS** Yeah. ADN The first time he was there. Yeah. And he said that you got, you got a pack of cigarettes of mine. She said **JMS** no I have my own money to buy my own pack of cigarettes, and when you were gone outside, she, she opened the door she through the pack of cigarettes at

him. **ADN** Okay. **JMS** That's when he came back in, knock on the door and that's when the cops came and... ADN ...so do you know why the cops were called the first time? Were they being really, really loud? Was there... **JMS** ...yeah... ADN ... was there fighting? **JMS** ...no just argue.... **ADN** ...was he hitting... **JMS** ...just arguing... **ADN** ...just super loud arguing? **JMS** Yeah. ADN Okay, so you didn't see any like physical? **JMS ADN** Um, hitting or anything like that, were they, were they yelling back and forth, was he yelling at her, was she yelling at him? **JMS** She was yelling at him. ADN Okay... **JMS** ...and... ADN ...and this was the first time you ever saw him. **JMS** Yes. ADN Okay, do you know how long, how long have you lived here at this apartment? **JMS** Um, like about two years, it be up in 4 like 6 months. **ADN** So you've been here about a year and a half, right? **JMS** Yeah. ADN Okay, and you have never seen him before? How... **JMS** ...no she... ADN ...how.... **JMS** ...she just moved in like, like three months. **ADN** So she's only been there for about three months? JMS<sup>®</sup> Yeah. ADN Okay, have you ever had any talks with her beforehand, um any other conversations about her baby daddy? JMS Nope. ADN Okay. **JMS** I really don't, I don't talk no other people in these apartment buildings. ADN Okay. JMS I stick to myself.

ADN Um, so a little bit later, in the conversation you were talking about how he had said that, that he was, or she had said that he was really depressed and he wanted to kill himself or something like that. Can you tell me more, what, what, what was that. She said he had like dipolar hypanet dipolar. **JMS** ADN Bipolar? Bipolar and everything and, he lost his wife overdosing, and he been prison off **JMS** and on, and you know he said, she, she told him, I can't help you out no more, and that when I heard boom, boom, boom, boom, boom, boom. Okay, so when the shots, when, when the shots happened, would, do you know **ADN** where she was? She was, she was in the upstairs, in the hallway. **JMS ADN** So she was upstairs, not in that apartment? No. She was in the hallway with another cop. **JMS** ADN Okay. **JMS** Then I heard them, the gun shots and I said, are you okay, she, she ran down the steps, and she said, let me come into your apartment, and I let her, let her sit right down on the couch. **ADN** Okay. Did you hear any of the interaction between the police and um, the guy in, ah in the apartment? The, the cops say, the cops said, put your hands up, get down, get down, get **JMS** down, and then later we hear, we heard 4 gun shots. **ADN** Okay, you heard him saying, did you hear him ah, what, so, you said put his hands up, um, did the officer say anything else? Um, indicating that it, there was.... **JMS** ...no... ADN ...was anything else... **JMS** ...uh-un... ADN ...present or anything. **JMS** No. ADN Okay, um, did she talk about him, did, did, in we were talking, did, did she say that he had access to any weapons over there or anything like that? **JMS** No. un-uh. **ADN** She didn't say anything about it? **JMS** No. **ADN** Okay. **JMS** Un-uh. ADN Um, okay, can you think of anything else? No, how did the, ah, what exactly did you hear the cops before the gun shots? STB

**JMS** Puts your hands up and get down. STB One time each? Ah, well I just heard it, I just heard it only one time... **JMS** STB ...okav... **JMS** ...saying it. STB Then how many gun shots did you say you heard... JMS ...four times. STB Four times? **JMS** Yes. But you distinctly heard them say, put your hands up... STB **JMS** ...yup and get down. STB And get down. **JMS** Yup. Did you see him with any weapons when you saw him out...? STB **JMS** ...no... STB ...in the hallway? JMS Hu-un, nothing. STB Okav. The complete interview will be saved to the main case file for future evidentiary value. For greater details of the interview refer to the complete digitally recorded interview.

Det. Braun and I spoke with the occupant of apartment #6 who identified herself as Latrice Denise Dobbins (dob 4-9-1983). Dobbins provided a contact phone number of 763-438-3415. Dobbins stated that she was home all day to include the last several hours. Dobbins was asked if she had any knowledge of a possible domestic that had occurred earlier in apartment 7. Dobbins stated that she had been sleeping in her apartment in the rear bedroom which is on the opposite side of the building. Dobbins further stated that she did not hear any of the interactions between the tenants of apartment 7 today and stated that she did not even hear the reported guns shots.

Dobbins did stated that "Mylee" identified as Mylee Jane Workman (dob 7-8-1981) and Workman's son's father identified as Matthew Neil Tuhkanen (dob 8-4-1983) have had issues in the past and believes that Workman and Tuhkanen were fighting the previous night.

I provided Dobbins with my business card and asked that she call if she remembers anything else that may assist me in my investigation.

### HENNEPIN COUNTY SHERIFF'S OFFICE INVESTIGATIVE REPORT

#### **SYNOPSIS:**

This incident pertains to a death investigation in the city of St. Louis Park.

#### **NARRATIVE:**

On January 19, 2019, at approximately 8:39 p.m., I, Det. Diane Nelson along with my partner, Det. Cory McClouden, interviewed Mylee Workman at the St. Louis Park Police Department. Ms. Workman was in a family room with her 4 year old son, Prior to the interview, was moved to the lobby with his grandmother, Vicky Evanov.

Ms. Workman had called the police earlier in the day following a verbal argument with the deceased party, Matthew Tuhkanen. Ms. Workman agreed to speak with us, and began doing so before I could turn my digital recorder on. During the interview, Ms. Workman was highly agitated and very difficult to keep on task. The interview was digitally recorded and a copy of the interview was uploaded into the media section of this report.

Workman told us that she had stayed overnight at her father's house on January 18, 2019, because they had plans with her father for the following day. At that time, Matthew Tuhkanen was staying at the apartment she usually lived at. The next morning, she was texting back and forth with Matthew. She felt that this was odd, because usually they spoke on the phone. She was worried that he was perhaps drinking or using some sort of substance. She felt that Matthew was texting because if he called her, she would figure out that he was using something.

When she arrived back at the apartment, she opened the door and Matthew was crouched on the floor by the kitchen. He was crying and holding a bottle of Vodka. She didn't know where the Vodka had come from, but she took it from him, emptied it out, and put it in a dumpster. At that point, she and Tuhkanen started to argue. She told us that when Matthew drinks, he gets angry and upset. She claimed that he has never physically assaulted her, but he tends to be belligerent.

They continued to argue, and at one point, she decided to call the police because she knew that he had warrants. When she made the call, and police initially arrived, Matthew left the apartment and went to the floor above. When officers didn't locate Tuhkanen at the apartment, she became angry and asked how it came to be that they did not locate Tuhkanen. As she was talking to us, Workman went from jittery and nervous to emotional to angry. Eventually, the police left.

She heard noises from the floor above her apartment, so she went up to see what was going on. She advised that she saw Tuhkanen physically fighting with an African-American male who she did not know. She told Tuhkanen to come back to the apartment, and he did. When they arrived, they were in a back bedroom. They heard a knock at the door, which was the police returning. Tuhkanen asked her to not let the police in multiple times. However, she went to the door with her 4 year old son, and opened the door. She said that police rushed in and she and her son went into the hallway. She told us that she took her son up one floor, so that he wouldn't see his dad getting arrested.

She said that she didn't hear any of the interaction between Tuhkanen and the police, but that she

heard 4 shots and she knew that Tuhkanen had been shot. I asked if there were any weapons in the apartment, and she initially said that there were not. She then corrected herself, saying that a week prior, she had found a "throwing knife" of Tuhkanen's on the floor. She had hid it from him in the closet in the bedroom. She said that Tuhkanen didn't know where it was and didn't know where she had hit it because he wasn't there when she did so.

MJW You know what the bottom line is, um, he had warrants and he's mine, you

know, he has a lot of issues, um.

MJW I'll be alright, I loved him, I thought I could help him, you know, I tried...loved.

MJW He woke up one day and now she was dead lying next to him. He had three

kids.

MJW Um, you know, he's had a shitty life, he um, his norm is getting down.

MJW And he, nobody, nobody gives a fuck.

DMN What's his full name?
MJW Matthew Neal Tuhkanen.

DMN Matthew Neal Tuhkanen?

MJW Um, he never had discipline, he never, I think that says a lot for him, saying

ideas, saving [inaudible 2:05], this is my sister, I just need to tell her I'll call her

back.

DMN Yup.

MJW Hello, hi um, Marg I'm going to call you back, I'm talking to the investigators

Sheriff's right now. Okay. I love you, bye.

DMN Okay. So about five years ago you guys started the relationship? Are you

married right now? Are you...

MJW

...no...

DMN

... are you just together?

MJW

... yeah, like, um, so I met him um, the day he got out, he had been in prison. his wife had died two before that, um, and I looked at him and I just. I could tell that he was sad, I could tell his soul was sad, I met him the day he got out of prison, and um, but I wasn't trying to like be his girlfriend or anything. I was like you know hey, um, we were both living at Stepping Stone shelter in Anoka. Um. he was on parole, um, I mean I'd never been to prison or jail much, you know I've um, in AA, trying to get my life together, um, but I'm always trying to help people, you know. And I, I thought he was like. I could just tell he was sad, you know. So it's like I needed a friend and ah, so said come sit down with me and he said I'll be right back. And he never came back. Well um, the third day, um, he said you know, not trying to be rude to you but you know, I just have a lot of issues and um, um my wife died two years ago, I just got out of prison, and I'm fucked up and you probably don't want anything to do with a person like me. And I'm like, I just wanted to be your friend, you know, Um.

DMN

So you guys at some point started a relationship then?

MJW

Um-hum.

DMN

Okay.

MJW

Um, his mom had custody of his kids.

**DMN** 

MJW

Um, so I met um, his mom, his kids and you know um, I don't know, something, I didn't have any kids, I got pregnant a year later. Um. I was sober and I um. was 33, um, so I, I thought you know, um, that I'd been sober off heroin for 15 years and um, I guess I waited too long and, I, I wasn't going to have kids, I guess but. I waited so, I, if I did I just didn't want to bring them into an addiction.

DMN

Sure. Sure.

MJW

That's what I didn't want, um, my mom died of cirrhosis of the liver. And the day I looked at that little boy, I said you know, I will never put you through what I have been through. You'll never want me.

DMN

MJW

So you were, you, you got yourself together, which is great. You guys, have you and Matthew been in a relationship the entire time? Or on and off? I mean, he's, he ended up in prison, um, and ah, you know what I think, he did a lot of time in solitary and stuff, but when, after his wife died, you know just

Was he, was he both...

being alone, he'd cry.

DMN MJW

... It hurt his soul...

DMN

...oh sure...

MJW

...it's not good for your soul, you know...

DMN

...sure...

MJW

... he ended up back there when he was with me, and ah, he came out different, you know. His soul was even sadder.

DMN

And, and that, and that, you know it happens and that sucks. So...

MJW

...and you know what, nobody ever tried to fucken' help him, the system fucked him every time that we would call his parole officer, and say he's mentally ill and needs help, please help him, you know.

DMN

Was it...

MJW

...he's using because it, you know, he needs help, can you please help us help him, you know and.

DMN

Is, is he, was he actively using recently?

MJW

Yeah, like last night I ah, went to my dad's house.

**DMN** 

Um-hum.

MJW

...[inaudible] and [inaudible] Lake . And ah, you know why, I came to the place from the shelter, the apartment that I am at, and um, you know your [inaudible] you.

DMN

And so he, he didn't live with you...

MJW

...again...

DMN

...but he maybe stayed in every so often.

MJW

Always, a lot. Um, cause it was, you know what, I was afraid for him, I didn't want him to be out on the streets, I mean he's mentally ill, like honestly, I'm not, I'm not feeding you bullshit...

DMN

...no, no, no...

MJW

...like um, I mean he schizophrenic, just, um...

DMN

...is he, is he diagnosed ...?

MJW

...yeah...

DMN

...schizophrenic? Okay, so...

MJW

...yeah. It's been, his dad committed suicide last year, um, it's just in his family. You know um...

DMN

...and, and sometimes it, that happens so, so what, what drug of choice is he been using lately?

MJW

Well uh, okay so this is what happened, I ah, he's been sober off drugs I guess, actually I don't really know. Last night I, I went to my dad's house with my son, um cause we, I have a good dad, you know and um, I don't know, I'm close to my family and...

**DMN** 

...yeah...

MJW

...my son loves my dad, so we spent the night, um we were going to go do this Home Depot thing where once a month they do a thing for kids, like you can build a.....

CTM

...like a bird house.

DMN

...yeah...

MJW

...yeah you get it, a bird house, well so it's not till February 2<sup>nd</sup>, but we thought it was going to be today.

**DMN** 

Um-hum.

MJW

So he spent the night, um so we're going to be going in February 2<sup>nd</sup>, but whatever. Long story short, um Matt was there last night, alone, um, I got there

today, um my dad dropped us off. And ah, he'd been drinking.

DMN Um-hum.

**MJW** Um, Matt can't drink, Matts um, and he blacks out immediately, he, all of his

charges that he has ever gotten, especially for assault he's been drunk.

DMN Um-hum.

Um, and that was another thing right, you know, ah he's never hurt a soul when MJW

he's sober.

DMN So he was drinking today...

MJW : ...yeah...

DMN ...you kind of knew, given ....

MJW ...I ah...

DMN ...his history...

MJW ...yeah, yeah I mean could, like when I walked in, I said, have you been drinking? And he, he said, here you can throw the bottle away or dump it out.

Um, so it was vodka, um half gone, I dumped it out.

DMN Uh-huh.

MJW Immediately cause I was flipping out on...

DMN ...is, is that in the trash then right now? Probably...?

MJW ...it's in the garbage, in the dumpster...

DMN ...sure, sure...

MJW ...I mean I just ah, I never tolerate that shit, you know.

DMN Sure.

MJW You know I was pissed, I was really pissed.

DMN Okay.

MJW Um, especially, you know like with my child like, in, ah, I was wondering cause he wouldn't answer the phone, he would only text me.

So you kind of figure he would have known that you knew at that point, maybe? DMN MJW Of course, and he'd only um, I'd seen him drunk, um one time, and that was ah, I was pregnant, 6 months pregnant. Um, but him, he ah been drinking that night, um, ah his mom told me, if you ever see or hear him drunk, run far and fast.

DMN Um-hum.

MJW Um, he's changes. He's ah, he'd ah never beaten on me, it's just um...

DMN ...something bad.

I've never been scared of him, he, he'd never hurt me and I could bet the world MJW on it, sober. Not his kids, not his, nobody. Drunk he's gone, he's gone, he's gone and ah, he wasn't drunk, completely, I mean he wasn't blacked out, but ah, had I not came when I did, well he would have been.

What time did you get back to the house do you think? DMN

**MJW** Um, I don't even know. Um, I don't even know three, I don't know.

DMN Okay... MJW ...um... DMN ...you got back and he was maybe drinking a little bit, and... MJW ...he had been drinking heavy, I dumped the bottle out... **DMN** ... okay, what happened then? MJW Well I was pissed, you know. DMN Oh yeah. MJW For one because I, you know, um, I'm on heroin, I mean I've been sober off of that for a while, uh 15 years, I would just, then I started using crack and I've been sober off that for six. I'm on methadone now trying to come off methadone, um, yeah and I came from a shelter, I'm just trying to get my shit together, I have a son and I need, need, my son needs... ...he needs you... DMN MJW ...everything I can give him... DMN ...yeah... MJW ...and uh, you know now I'm [inaudible] I still have behaviors that I have, you know, just the chaos and the Dad, and I tried to ah.... DMN ...it's, it's a lot that you have going on. So... MJW ...and I, and I just, I, I, love his dad. I really do. I, you know I, I just, I just wanted to help him and I couldn't say no, I couldn't. You know and that I ended up calling cops cause I was just pissed, I guess trying to be a bitch, I don't know, he had warrants. DMN Were you, were you guys... MJW ...I know I was wrong, um... DMN ...not... CTM ... Was that after you'd dumped out the bottle? MJW Yeah, we started arguing right away. CTM What, what were you guys arguing about? MJW Um, just dumb shit, like ah, I had these markers of my friend's, you know and he called my friend up and was like yeah I got your markers, and yeah like you know just dumb shit, you know and but I had the bag my markers and her markers mixed, you know. CTM Like coloring... DMN ...like coloring... MJW ...yeah, yeah... CTM ...okay... **MJW** ...like we color, you know... DMN ...yes, yeah.... ...but I was mad because, I didn't get a chance to separate them. My markers MJW and her markers, and he carried the whole damn bag of markers out to her.

DMN So you guys were arguing...

MJW ... yeah I mean it's, that not why I called the police. It is but ah, I don't...

CTM ...it was, that was the start of it...

MJW I wanted him to out of my..., I, I, you know, what I just can't, I told him, Matt you can't live here for a while, okay I'm not losing my housing over this.

CTM ...um-hum...

MJW ...end of story. So I wanted to say [inaudible] I love you and...I hate to let him go, and uh, I didn't want him on the streets, what if it gets worse and well, you know what, I just, it, it pulled on my heart, to...

CTM ...yes...

MJW ...so hold on, let me just finish it, I'll tell you. So um.

DMN The cops come?

Ah, ah, I knew he had warrants. Um I just looked online today telling me he had warrants and I thought um, you know you're going to deal with your shit, I, I'm trying to get healthy and ah, I can't do that if you're here, I told him that, I can't do that if you're here [inaudible]...second, about losing my apartment.

CTM Well it's your housing right?

MJW Yeah, yeah. So I told him, you know that I, you know, he felt bad, you know, he didn't want to go.

DMN Right cause it's, its cold but at the same time, you got to do what you got to do cause you've got your little guy...

MJW I know, but...

...so, so you called the, et, you called the police, because Mylee, here's the thing, your little boy, you put him first today, what happened after that, what happened on the rest of the day, you're putting your little guy first. Okay, and that's what, that's what good mom's do. Okay.

MJW I just wanted to be a good mom, I don't care about, I told Matt that today, I said you know what at the end of the day I don't care at the end of my life, if I die with nothing, if I have nothing but I'm a good mom, that's enough for me.

DMN ...well and you, you...

MJW ...I'll be happy...

DMN ...and, so you, you did the right thing...

MJW ...I just can't...

DMN ...trying to keep your son safe...

MJW ...I just got to the point you guys that I know I can't fix him, I can't help him. He gave up, I think, is what happened, and it's sad, it's very sad, but you know what, you guys, I, I don't know, I just, I, I don't know what to do...

DMN ... well let's, let's talk about what happened today. Okay. So, after you called the police, did he stick around or did he take off?

MJW Apparently he hid in somebody's apartment.

DMN In, in the building?

MJW Yeah, apparently that's what they said and ah.

DMN Who would that have been, if...

MJW ...I don't even know. But I heard him argue, I heard some fighting upstairs, [inaudible] and they tell me if he comes back call us, okay...

DMN ...okay...

MJW ...okay, you know and it's so easy to say, but you know, when um, you look at somebody you love and you know, it's fucking hard, so anyway, um, he was fighting upstairs with some dude I don't...

DMN ...uh-huh...

MJW

...and ah, and I never seen the dude in my life, had his arms around Matt his neck or something, and Matt was like, open your door, you know cause the dude was hurting him and he, he ran down to my apartment, it was within 5 minutes the police were there.

DMN

Okay.

MJW

And um,...

DMN

...the, the guy ran down to your department, apartment?

MJW

Matt did.

**DMN** 

Matt did.

MJW

Yeah, and ah within, you know, I, I don't know how long cops came back, whatever, um, I guess the worst part is you guys, but I, I, called the police and told them about his warrant cause I just don't want to deal with the bullshit anymore.

DMN

Well, and, and...

MJW

...but you know I, I didn't want them to shoot him.

DMN

No. I, no, so...

MJW

...his whole family's going to blame me, you know.

DMN

You know what...

MJW

...his sister told me like, my family can't stand you, you know what, I've been the only one that's stuck by his side and jeopardized my housing everything, and now my sobriety, everything I have gained, any, any steps that I've moved forward, I jeopardized to be for he was okay, nobody gives a fuck, his family didn't care.

DMN

Look, let's talk about what happened today, because Mylee...

MJW

...so...

DMN

...it sounds to me like, you were looking out for your little boy...

MJW

...a, a, a absolutely. If my little boy's at the door...

DMN

...so after....

MJW

...and he's telling the police my daddy's not here, no bullshit, [inaudible] so I opened the door. The police are like open the door, and I open the door and they came parading in and I grabbed my son and walked out and...

DMN

...is that the first or second time?

MJW

... second time.

DMN

So, about what time was that?

MJW

I don't, you guys, I don't even know, have no idea, I don't know.

DMN

Was it dark out or light?

MJW

Yeah, dark.

**DMN** 

So...

MJW

...I mean I couldn't really tell you, I could look.

DMN

Yeah could you.

MJW

Okay, I can give you an estimate, yeah, I know...

DMN Okay. MJW Yes.

DMN While you look that up, so about three o'clock he sent up to a neighbors, and kind of hid out.

MJW And hid out, somebody let him in.

DMN And then he came back? Did you call him back or did he come back on his own?

MJW Um, hold on.

Sorry, you live on the first, second how many floors are there in here?

MJW Um, there's a bottom floor apartment, you know...

DMN Basement floor? Kind of ...

MJW You like, you know actually there's a couple apartments down there and then I live on, you know second, when you walk in, I, you walk up there's one set of steps, I'm on that floor.

Okay, in which, where did he go? He, he did, so did he go up to the next floor up?

MJW Um, yeah apparently, but yeah, I didn't know that 'cause I was in my apartment.

CTM Oh.

MJW You know, um, the police told me, ah...

DMN Do you have other names that you go by all, is it Mylee or is it Jessica? Who's Jessica?

MJW My neighbor across the hall.

DMN Oh okay, okay, well okay.

MJW No I mean, you know what, she is just an [inaudible] lady, she just let us in, she said I was just standing there before [inaudible 14:54] and I heard the fucking gunshots and I knew right away, but why'd they kill him...

DMN ...so...

MJW ...probably threatened his life, I don't know. You know I don't even want to hear it, cause if this, my heart's so hurt, I don't know what to say, I mean...

DMN ...okay, so let's, lets Mylee let's try and get back on track, okay. So, he comes back from wherever he was in the building, and it was dark, and he came inside...

MJW ...he was hiding upstairs...

DMN ...yeah...

...he was hiding upstairs, and I walked upstairs cause he was fighting, cause I could hear him. And ah, I, I could only hear him [inaudible] a little. So I didn't, you know, if I knew it was Matt I would have fuckin' opened you know....

DMN ...um-hum.

MJW Oh who is that? Whatever, so I saw that he's fighting over, I'm not going to even fucken, you know, I'm not going to do that. So I let him come in, you

know, and he's like babe why would you call the cops on me and, I was just so bitter I, I can't fucken do it, I said you know why, I don't know Matt, I'm sorry, I don't know. And ah, literally within minutes, the cops are at the door, um, he like don't answer it, don't answer it, um, but yeah at the end of everything, I, guess what, I have a boy to take care of. End of story.

DMN

...okay....

MJW

...that's my job.

DMN

So, so you brought him, he, he was fighting with a guy upstairs, a black guy.

MJW

Um-hum.

DMN

And you didn't know his name at all?

MJW

I never seen him at all.

DMN

What does he look like? Big guy, little guy?

MJW

Ah, he was tall and dark...

DMN

...okay...

MJW

...but, I, I've never seen him before.

DMN

Okay.

MJW

But, he, he was somebody's company.

DMN

Okay.

MJW

Matt told me he was in, who's ever apartment he was in, he didn't tell me that. Cause we started arguing about why I called the cops on him.

DMN

Okay, so he came back down, he's like why'd you called the cops?

MJW

Yeah, um-hum, he wasn't mad, he was hurt, you know.

DMN

Okay, so then what happened after you guys were talking about the cops?

MJW

They knocked on the door.

DMN

Okay, so that, they knocked on the door, and then what happened?

MJW

They start pounding, yeah and ah, I was like um, he told me, please don't answer, I'm scared, you know and um, he didn't want to let the police in.

DMN

And you...

**MJW** 

...and he told me if I go back, I'm going to hang myself, I can't do it emotionally. You know, I don't have it in me, and I knew that.

DMN

Um-hum.

MJW

I knew it in my heart he didn't have it in him, but um, I didn't think that was going to happen, I'm sure he probably, um the police came in, um, I walked out immediately, um, hold, [inaudible] um, I, I, I don't know, they all rushed in and I mean, I just wanted to get my little boy, I didn't want my boy to see his dad arrested. That's, that was my focus....

DMN

...so...

MJW

...my son.

**DMN** So you took him out in the hallway?

MJW I, went up to the second floor.

DMN To Jessica's house or somebody else's house?

MJW You're at 8A, um, no buddy I'm not at 8A okay, um no like I lived here for a couple months and Jessica, I never, I never even talked to her till the, ah, the

shooting and you know, she invited us right in and ah...

CTM Your neighbor gal?

MJW Un-huh, yeah across the hall, but um, no I grabbed my son and we walked up to the second floor, cause I thought the cops would have gone in, and ah, the fucken cops went in and took off. You know.

CTM Sure, did, Jessica on the second floor?

MJW No, no this before Jessica.

CTM Oh this is before Jessica. MJW This was before he got shot.

CTM Okav.

Um, I was on the second floor, and ah, my door was shut, and ah, I was with a MJW lady cop, came and stood there with us, um she was there the first time.

DMN Um-hum.

MJW And I heard the four shots and that's when they shot him. And I said they fucken killed him, didn't they? And nobody would tell me. Then I came down stairs to Jessica [inaudible] open the door and let us in, and ah, yeah came in.

Did you hear, go ahead? DMN

CTM I apologize, so you guys went up to the second floor.

MJW Just standing in the hallway.

CTM Standing in the hallway up on the second floor.

MJW Yeah, but I didn't have a jacket or shoes, and you know I would have gone outside maybe, but its so fucken cold...

CTM ...and then...

MJW ... I didn't want my son to see his dad taken out...

CTM ... completely understandable. I, I wouldn't want my little guy to see that either. But after you heard the four shots, is that when you came back downstairs and

went into Jessica's.

MJW Um-hum.

CTM Um, apartment? And she's right across the hall from you?

MJW Um-hum.

CTM Okay, I was going for clarification.

I mean I just like, like uh, I mean, okay so he's in my bedroom, it was my room MJW he got killed in, so like there was no weapons in my room, I know it. I can't imagine there were weapons in there. Um, and, so, I just don't know, I mean ah, you shoot somebody four times you're trying to kill them.

DMN Did, did you...

MJW ...it's my fault, I mean they were trying to kill him. I mean they're killing him.

They were going to kill him.

DMN Did, did you hear, you heard the shots?

MJW Yeah.

DMN Did you hear anything before that?

MJW No.

DMN Did you hear any yelling or...

MJW ...nope...
DMN ...talking...

MJW Nope nothing, nothing.

DMN At any time, did you tell him, hey Matt before the cops got there, Matt just

leave?

MJW Yeah.

DMN Did you tell him that you'd give him some meth if he left?

MJW What, really, no I wouldn't say that.

DMN Okay, I know, I know that's a weird question to have.

MJW Are you serious?

DMN But there is a lot of different ...

MJW No, I understand that.

DMN Good, are you clean right now?

MJW Yeah.

DMN Good.

MJW Yeah I'd give him some meth while, wow, no, I didn't say that ma'am.

DMN Good, you know what, can I tell you something, you may not, believe it or not,

but I'm proud of you. I'm glad...

MJW ...thank you...

DMN ...I'm glad to hear that, cause...

MJW ...you know I work my ass off to get to where I am today.

DMN And you're clean and you're taking care of your little boy and that's good.

MJW Well it's hard, you know what, I used to ask my mom why can't you stop

drinking and be my mom, but, let me just tell you...

DMN ...yup...

MJW ...but I didn't know what it was like.

DMN But now you, you do....

MJW ... now I do...

DMN ...and you struggle in that everyday...

MJW ...and I'm a mom, not every day, but you know when I look at him ...

DMN ...he's a beautiful little boy... MJW ...he's amazing... DMN ...he's great... ... and I know what love is today because of him. MJW DMN So... MJW ... I thought I did before, but yeah, I mean I didn't have any meth to give Matt. DMN There's, there's... MJW ...I, I didn't know he was using meth I guess, I thought he was drunk, I don't know... DMN ...do you know has he used meth in the past? MJW Oh veah, veah, veah. DMN Okay... MJW ...yeah I mean, you know what, 90 percent of our problems have been drug or alcohol related, [inaudible]... DMN ..do vou... MJW ...actually I'll say drug related because ah, I, I won't tolerate the alcohol... DMN ...um-hum... MJW ... I mean I don't tolerate the drugs either... DMN ...um-hum... MJW ...you know what, I fucken changed my life and I don't want my kid around it, period... DMN ...um-hum... MJW ...you know we had it, it's ah, man it's been a nightmare, it's been nightmare... ...has he, has um... DMN ...but I, I don't know what he's been up to all night. MJW DMN So once the officer, right, so once the officers came in the room, were you there when they were interacting with Matt at all? MJW No, no I was, ah, in the hall... DMN ...like automatically right away... Yeah, my door was shut, yeah they shut the door... MJW DMN ...so... MJW ...there was probably six of them went in there and shut, I mean I have no idea... DMN ...so... MJW ...no clue. So fair to say, fair to say that as you were coming in, as they were coming in DMN you were coming out with your little guy? Yeah, I was like behind the door, like I unlocked the door... MJW **DMN** ...um-hum... MJW ...and my son, like this is what I did, like, they were let us in, you know and I literally. I unlocked the door, and pulled the door open, put my head out and just come in. ... DMN ...and they came in past you... MJW ...yup... DMN

...yup...

MJW ...and I grabbed my son, and I left.

DMN Okay, So he didn't, he didn't see what happened.

MJW My son.

DMN Right.

MJW Absolutely not.

DMN Okay, that's great, right?

MJW No, absolutely but I didn't, I mean, um, I mean what, I don't know, so somebody

thought I told Matt he was like. To just leave and I would give him meth?

DMN Well, here's, here's a lot of times when we start investigations like this, we're

talking to...

MJW ...everybody's got a story, right....

DMN ...right, and so then we have to ask those crappy questions...

MJW ...oh yeah, I know, I get it.

DMN You know.

MJW Yeah.

DMN So that, as hard as it is to ask you...

MJW ...it's just crazy...

DMN ... because I know how proud you are of your sobriety.

MJW You, sorry but you know I'm not going to tell you I don't relapse in my life.

DMN ...well yeah. But you're good now, right?

MJW Yeah. And I, you know I, I'm trying to get on methadone now, I'm detoxing, I'm

on 55 milligrams, um that's my dial I guess today. That's what I'm trying to do

now, get off methadone.

DMN Yup.

MJW ...um...

DMN ...and you can do this...

MJW ...oh I can, but you know ah...

DMN So when you...

MJW ...this is the second time I've been on it, I, I was on 30 mg for ah, cause I was

using cocaine crack and ah, six years ago. And um, but I stopped, my

counselor was like, get back on Methadone because I don't want you to die.

DMN Um-hum.

MJW You know, she thought I was using crack in place of heroin. And she was afraid

I was going to start heroin again. So they say get back on Methadone

whatever, um...

DMN ...so...

MJW ...so I've been a prisoner of fucking up, you don't know. And I'm, I'm over it, I

said I want off of it, it saved my life, um I had an amazing little boy, then I'm done. I'm wanna...I want to move forward man. I want to grow, I want to give

my little boy a life. I can't, um methadone, methadone saved my life but I'm

done, I want off of it.

DMN So after you, I'm, I'm sorry to keep circling back around to...

MJW ...um-hum...

DMN ...but I, I want to be able to get you, you know to be able to, to be done tonight with your little guy.

MJW I don't even know what to say and...

DMN ...and...

MJW ...I just feel so numb.

DMN Well, and, and that's totally normal.

MJW So, why was he shot? Can you just tell me that?

DMN Honestly...

MJW ...why...

DMN Honestly Mylee, we don't even know.

MJW ...but you know what, you guys, when this is all, I don't need to tell you, this is the most fucked up thing.

DMN Um-hum...

MJW ...now I asked so many people, just tell me, if you can, [inaudible], You know what, you fucken owe me, can you just tell me, you owe me an answer...

DMN ...they, they may not...

MJW ...you owed me an answer, don't you think? Tell me something, just shut the door and let it be, no one cares about the girl and fucking, come on man, I just need that. Something...

DMN ...and, and Mylee, you know, it doesn't make it any better, they may not have known; the other thing too, is ...

MJW ...they knew though...

DMN ... when, well when an investigation like this goes on too, there's so many things happening...

MJW ... you know that, it's neither here nor there, you know but, ah you know I just...

DMN You, you know, you know now he has passed, correct.

MJW Yeah, absolutely um.

DMN So...

MJW ...but I, when, when you shoot somebody four times, they're trying to kill him. Why would you want to kill him, what did he do...?

DMN ...so that's what we're trying to figure out...

MJW ...that why I think it's my fault, yeah cause I called the police, what did they do, he was, he didn't have anything to threaten them with, you guys.

CTM It's not your fault...

DMN ...it's not your fault, here's what I want you to think about...

MJW ...I'm getting excited because I, well I don't think and I don't get it...

DMN ...Mylee here's, here's what I want I want you to think about, in the next couple...

MJW ...and I need to walk away...

DMN ... of days...

MJW ...from this and explain to my little boy that the police shot his dad but it's okay,

everything will be okay....

DMN ... Mylee

MJW What? I just want to know, man.

DMN Okay, so do we, but here's what I want you to do in the next...

MJW ... but who do I call for answers, you guys.

DMN Okay, one, one thing at a time. Alright first of all, we talked about this earlier;

I'm gonna say it again, and I want you to think about in the next couple of days,

okay. You were protecting your son. Okay.

MJW My heart's so broke.

DMN It, it's...

MJW ...it's so broken...

DMN ...it's, and it's gonna be broke, there's a lot of things that we don't know right

now, that we can't tell you right now. Okay.

MJW Okay, we can't go home...

DMN Well, the other thing too, we're almost done here and then the um...

MJW ...did the other lady like go in there, the guy, the cops said you know um, we'll

get you some clothes, my son doesn't even have shoes you guys,

DMN Well, in then...

MJW ...a jacket...

DMN ... we'll try and make, make that happen too, the main thing we want to do is, is

find out what happened.

MJW My purse.

DMN So after you came back downstairs, after you heard the shots, did you come

back down to the apartment or did you go to Jessica's?

MJW Um, I, to Jessica's.

DMN Is she on the floor above or she near...?

MJW ...right across the hall. In ah, she must of ur, ah, you know what, I don't even

know how I fucken got in contact with Jessica. It's hard now you see, I never talked to her before she had ah, to be rude to me. Um but I think she heard the

shots.

DMN And, and you guys just, did you wait there.

MJW Actually, you know what, I talked to Jessica after the first time.

DMN Yup...

MJW ... um of the police officer, is that your baby's dad, okay sorry.

DMN And, and did you tell her, yeah...

MJW ... I said yeah, um, you know I kind of explained what happened, you know just

start, um, she's like you know he's a nice, you know he's a nice guy but uh-

hum, that was after the police left the first time.

DMN And then, when they came back the second time, you went to her apartment,

you waited? MJW ...um, so, actually I was with some female cop, um, walked with me and um, on the second floor... DMN ...um-hum... MJW ...um, since then I just don't want my son to see his dad, you know, arrested... DMN ...um-hum... MJW ...and, so I was waiting for them to take him out, you know... DMN ...um-hum... **MJW** ...um, then I heard the shots, and I just knew... DMN Okay. Are there any, any weapons at all in the house? Anywhere? MJW Um, no. **DMN** Okay, does he, has Matt ever had a gun... MJW ...no... DMN ...before...? MJW ...not, not at my house, absolutely not, absolutely not... DMN ...would he, would he ever ... MJW ...there's no gun in my house.... **DMN** ...Okay... MJW ...Fuck no... DMN ...Perfect... MJW ... Absolutely not. DMN How about um, anything that could be considered a weapon, knives... MJW ...Um, yeah, yeah... DMN ...like kitchen knives I assume? MJW Um, yeah but he, he usually had throwing knives, you know. DMN Um-hum. MJW But, I had it hidden. DMN Okay, where would that have been? **MJW** In the closet, in my closet. DMN In your closet, okay. MJW Yeah, I saw it today actually and hid it. DMN Okay, where is it... MJW) ...and I said what are you digging around in my shit? Cause I'd, we'd lived together in Anoka at one point. DMN Um-hum. MJW And ah, and I mean but there's no way he could have found that. DMN So... MJW ...I doubt it. DMN Where did you see it today? When it was out...?

MJW

...On my floor, in my bedroom....

DMN Okay.

MJW But yeah, I mean I have a little boy to protect you know. So I'm like what the

fuck, where did you find this? Where, how did this get out?

DMN Are you'll use those little circle ones...?

MJW ... No, it was, it's like a hunting knife, it looks like. It's like this big.

DMN Um-hum.

MJW And there's like a parachute cord, I guess wrapped around it.

DMN Um-hum.

MJW You know, um, I think you throw it at a tree or um, I don't know.

CTM Is it black?
MJW Yeah, yup...

CTM ...it's a [inaudible]...

MJW ...yup. No, the blade is like that big...

CTM ...it's a 4 inch blade...

MJW ... yeah, yeah it's like this big probably, I would think.

DMN Um-hum.

CTM Is that about 8 inches, give or take?

DMN So...

MJW ...yeah [inaudible].

DMN When, when you saw it on the floor...

MJW ...this was way before the cops even...

DMN ...oh sure...

MJW ...came to arrest him....

DMN ...sure... MJW ...yeah.

DMN What did you do with it at that point?

MJW Well, at first I was pissed, you know, I'm like, picked it up off the floor, alright, and was like, what the, when the fuck did you, you know cause I, I found it like last week or something, um, cause, what happened was, we moved out of Anoka, ah, all of our shit was at his mom's house. So, I finally got an apartment for me and the part of the property and ah, we were going through stuff, and I find this and was like, uh, yikes, you know and I, I should have just thrown it [inaudible], I don't know why I didn't, but I grabbed it and I hid it, you know, cause I had, like my jeans, and my sweatshirts in my closet.

DMN Un-huh.

MJW Um, but yeah, I wish I would have just thrown it away. Um, I don't even know why I fucken put it up there, but I just, I was trying to hide it. You know, I didn't

want him to come across it.

DMN Had you put it on top, like a ...

MJW ...um...

DMN ..it, where it, where it...

MJW ...well there was two shelfs, in my closet, like you know, like one, two, um, I put

it on the first shelf.

DMN Um-hum. Behind stuff or just sitting there?

MJW Um, well I think there's, I, I think it was sweatshirts, I put it in between, um.

DMN Okay.

MJW Shirts, shirts or jeans. I...

DMN ...sure, sure... MJW Between them.

DMN Could you see it at all or no...?

MJW ...no, no.

DMN Did he have...?

MJW ...he wasn't in there when I hid it.

DMN Okay, so, does he have other knives or other, or, things like that, like throwing

stars or knifes or...

MJW I think he has but like when I moved, all that kind of shit I threw away.

DMN To the best...

MJW ...period.

DMN So to the best of your knowledge, any other knives...

MJW ...he didn't have, I don't believe he had weapons on him, absolutely I don't. I

truly don't.

DMN Okay, but you know that we have to ask.

MJW Yeah, yeah. I really don't know, but I mean, guns no, no I, I had a permit to

purchase firearms, ah, it's expired, but that's just like, I, um...

DMN ...have you purchased any?

MJW No, not in a long time, I mean I, look, I was raised shooting guns like at my

cabin with my dad, you know yeah. I [inaudible] them yeah.

DMN Are there any guns in the house

MJW No, absolutely not.

DMN Okay.

MJW No, I had purchased them a long time ago.

DMN Okay.

MJW Before I was a mom, long time ago.

DMN Sure, well not even thinking about a kid.

MJW Well yeah, no, no I was 27 probably, but still, yeah.

DMN Yeah, yeah, yeah.

MJW Yeah, I wasn't going to have kids and.

DMN Right and then here you are.

MJW [Inaudible], you know what I am so glad I, told you that, and I, you know what,

God, God gave me the most amazing thing in the world.

DMN He's great kid, he's cute.

MJW Love, I know what love is, he's amazing. He's amazing, you guys, you should

have heard him talking to me today. Mom take some [inaudible], I'm like oh my

god.

DMN So when you guys were kind of arguing, when the cops came back the second

time, where were you when that was on...

MJW ...in my bedroom.

DMN You were in the bedroom?

MJW We were in there talking, we [inaudible] even in there, I heard the cops, I knew

it was the cops.

DMN So when you, when the knock came to the door, what did you do?

MJW When the cops came here?

DMN Yeah.

MJW I got up and walked out of my room.

DMN Okay and he...

MJW ...to the door...

DMN ...and he stayed in back...?

MJW ...um-hum...

DMN ...in your room...?

MJW ...um-hum...
DMN ...okay...

MJW ... okay, and my son walked right with me.

DMN ...okav...

MJQ ...and Matt was like don't do that pretty please, don't. You know, please don't

let them in, don't answer it, babe, please. And then he's like you know um, I guess I'm a firm believer for one and um, you know you, you deal with your shit,

you own up to your fucken shit. Along the line...

DMN ...and that's...

MJW ...he has warrants, I don't care. He needs to deal with his shit...

DMN ... you, you've owned your shit...

MJW ...and you know what...

DMN ...he needs to own...

MJW .... I'm in my fucken apartment, I'm not losing my apartment cause your dumb

ass has warrants.

DMN Does he have a car?

MJW No.

DMN No, okay. Alright, so he just primarily stayed with you when he kind of needed a

place.

MJW Yeah, uh, he just got out of fuck, jail like last week, no two, a couple weeks ago,

I don't know, Benton County.

DMN What, Benton County, I was going to say, was, where was he at, he was in

Benton?

MJW Um-hum.

DMN Is that St. Cloud? No.

MJW Yeah, yeah...

DMN ...okay...

MJW Um, yeah it's on the border.

DMN Part of it, yeah....

MJW ...yeah um...

DMN ...Benton, Sherburne...

MJW ...I don't know that...

DMN ...Stearns...

MJW ...oh yeah...

DMN ...sure, sure...

MJW ...it Foley right...

DMN ...sure...

MJW ...yup, um they picked him up, um, because you know, this is the sad thing, okay. When you're down [inaudible] and I was there, but ah, I guess it, you

know I, I got tired of being alone, um, I don't deserve to be alone. I should have been honest with him, but I felt emotionally responsible for him all the time, and

ah, you know that isn't how it's supposed to be.

DMN It, it is especially when they're gone, too. Did he have treatment for mental

health or was he just trying to self-medicate.

MJW No, I mean, you know he was taking Klonopin but he truly needed, I think, um you know, ah, but he needs, he needs therapy every, you know he needs more

than he was getting.

DMN Where, where does he see a therapist at?

MJW Um, I don't even know, he doesn't have a therapist, that ah, I mean, Nystrom

and Associates in New Brighton.

DMN Oh sure.

MJW I mean I was like the fucking receptionist making appointments and...

DMN ...sure, sure...

MJW ...you guys wouldn't believe...

DMN So he was, he was actively in some treatment though, for ...

MJW ... and he was trying, um, but you know like, he was on parole in Anoka County.

DMN Um-hum.

MJW Um, and a, er, like right away some charges just or some warrants popped up

last, um, last night.

DMN Um-hum.

MJW Saying that, um, 5<sup>th</sup> degree assault, like. He hasn't assaulted anybody, but...

DMN ... sometimes that stuff can lag, you know how it is right...

MJW ...well um, so the guy that I cheated on him with or whatever lives in [inaudible].

DMN Uh-huh.

MJW And um, you know one day he snapped, and ah, you know, he got out of prison, and ah, found out who it was and decided he was going to go over

there and make sure he knew then fucked up, you know.

DMN Um-hum.

MJW Um, so he, ah, he fought him and the dude didn't press charges, you know.
Um, but, ah, and then the state must have picked him up, um he was to the point where he's had so many assaults they could, um, easily picked him up for

sure.

DMN Sure...

MJW ...and um...

DMN ...sure...

MJW ... and ah, he was just in prison for having 3 assaults in 5 years, like, um, you

would have, he's on a downward departure, like...

DMN ...um-hum...

MJW ...the thing is he's been given many chances, on probation and he, he uses,

you know, any time he's been to prison, I think has been more of a probation

violation.

DMN Um-hum.

MJW You know, he doesn't stop.

DMN So...

MJW ...and I tell him like, okay [inaudible] no bullshit. Like you've been given plenty of chances and you've decided you'd rather get high, because your life is so

bad, that you, just do like so, like I tell him you can't buck the system, quit

trying. He never been alone, okay, you're stupid.

DMN So...

MJW ...so, I just, it, you know what, and another thing like, it sounds, I have a lot anger for him, but I do love him but you know what, I have a little boy that I

need to teach, you know I need, he needs to be taught, like, ah, you know, like

a mom...

DMN ...he...

MJW ...that, ah, you know, I don't know, my dad always told me, Mylee I don't care

what system it is, you can't fucken buck, move out of the way. Quit bucking the

system. My dad told me that, and I will never forget it. You know and ...

CTM ....when, when you guys picked him up from Benton...?

MJW ...um-hum.

CTM Um, who picked him up?

MJW His mom and me.

CTM Okay, she drive?

MJW Um-hum.

DMN Do you drive?

MJW No.

DMN No.

CTM Okay, how does he get around, or how did he get around?

MJW Um, Matt? Around where?

CTM Hey look did he go places, or did he?

MJW No.

DMN He just pretty much stayed with you?

MJW Yeah, yeah.

DMN He's be out the last week and half, he's stayed with you most of the time?

MJW Um-hum.

DMN Okay.

MJW And I know it's hard to [inaudible] you know, um.

DMN What do you think he used outside of alcohol in the last week, if you had to

guess?

MJW Oh meth, I'm sure.

DMN Sure.

MJW Ah, he like, I do things, you know, I leave the house, I... but one night I was like

are you high, you know, um, but I wouldn't let him sleep with us.

DMN Um-hum.

MJW Our bed I mean...

DMN ...what night was that?

MJW ...I, I guess I should say my bed..,

DMN ...um-hum....

MJW ...cause, chooses to sleep in his own bed. Um, I don't know, but, I don't

even know. Wednesday maybe.

DMN Okay, and so you could tell he was high?

MJW I mean, I'm not stupid, you know, he denied it, but...

DMN ...a lot of times too, we've had a problem, you could recognize that...

MJW ... I was like where did you get money, I was just like I called him out lying, and

DMN Um-hum.

MJW And um, I got dropped off at the same time did, met my dad outside and me and came in and 2:30, and we met there and um, right as we walked in, well Matt was sitting by the door crying.

DMN Um-hum.

MJW Like, crouched like, inside my apartment but like by my door, like, he even texted me and ah I called, yeah it was probably 10 times and ah why aren't you home and you know I was like what is wrong with you like, you know and ah, he wouldn't answer the phone.

DMN Um-hum.

MJW Should have been my first clue, but I just, um it's just wearing, it's wore on me, you know what I mean you [inaudible] to move forward, um, you feel robbed of it, kinda, and you know, um. But I said don't complain about what you commit you know.

MJW I know [inaudible], I, I came from a good place. I think dad knew, I don't know, my dad raised me.

affects him.

CTM How much time lapse do you think between the first time you called the police

and Matthew, now after you called, did he, did he just walk away? Did he, we

know he left your place and went upstairs.

MJW Cause he was outside with Ashley.

DMN Who is Ashley?

MJW My friend, that was coming to get her markers that she left at my house.

DMN Yeah, okay.

MJW Yeah so he thought he'd be, you know, a real smartass and bring them out to

her.

CTM Okay, was he outside with Ashley when the cops came?

MJW When I called them, when I called them.

CTM Okay.

Mills said she was at her apartment all day. Mills said she was not up around 1700 hours that day. stating she was taking a nap with her daughter. Mills said she did not hear any commotion in the building. She said she just saw a bunch of cop cars out front. Mills said she did not hear anyone say or yell anything. Mills denied hearing any loud popping sounds. Mills also stated that she did not hear the police say anything when they were at the complex.

### **SYNOPSIS:**

This report pertains to the digitally recorded interview of a potential witness regarding this death investigation. This potential witness was an occupant of an apartment in the same building as the death occurred.

### **OFFICERS INVOLVED:**

From the Hennepin County Sheriff's Office Investigative Division: Det. Nestrud, Det. Braun, Det. Soeffker, Det. Hopkins.

### **NARRATIVE:**

On 1-19-2019 I, Det. Aaron Nestrud was assigned to assist with the death investigation of Matthew Neil Tuhkanen (dob 8-4-1983). I arrived on scene and was tasked with conducting a canvas of the occupants of the apartments located within the housing complex located at 2760 Louisiana Court in St. Louis Park, Minnesota along with Det. Braun, Det. Soeffker and Det. Hopkins.

At about 8:45 PM Det. Braun and myself conducted a digitally recorded interview of the occupant of apartment #10 of the above listed apartment complex. Apartment #10 is on the 3rd floor and on the opposite side of the complex as apartment #7. The resident identified herself as Michelle Kay Specht (dob 5-23-1973). Specht stated that she lived at the residence with her child. Specht stated that she was home all day but that she did not hear any of the details of what had transpired on the 2nd floor early on this date, specifically the interaction of Tuhkanen and law enforcement. Specht stated that she did hear a "pop, pop, pop, pop, pop." Specht stated it was then she realized that Police were at the address and something was going on.

Specht stated that she spoke with Mylee Jane Workman, the resident of apartment 7 and mother to Tuhkanen's son at about 8:00 PM today (1-19-19) while Workman was at the police station on her cell phone. Specht stated that Workman told her that she had spent the previous night at her fathers house. Specht stated that she saw Tuhkanen at about 10:00 AM today, 1-19-2019 in the hallway of the 2nd floor and she stated she asked Tuhkanen where Workman was and Specht stated that Workman told her that he did not know, but that she may have spent the night at Workman's fathers home.

Specht stated that she did not see Workman today at all. Specht stated that Tuhkanen was very needy with Workman saying that she heard Tuhkanen say that Workman had time for everyone but him. Specht stated that she believed Tuhkanen may have had mental health issues.

I provided Specht with my business card and asked that she call if she remembers anything else that may assist me in my investigation.

### **SYNOPSIS:**

This report pertains to the digitally recorded interview of a potential witness regarding this death investigation. This potential witness was an occupant of an apartment in the same building as the death occurred.

### OFFICERS INVOLVED:

From the Hennepin County Sheriff's Office Investigative Division: Det. Nestrud, Det. Braun, Det. Soeffker, Det. Hopkins.

### **NARRATIVE:**

On 1-19-2019 I, Det. Aaron Nestrud was assigned to assist with the death investigation of Matthew Neil Tuhkanen (dob 8-4-1983). I arrived on scene and was tasked with conducting a canvas of the occupants of the apartments located within the housing complex located at 2760 Louisiana Court in St. Louis Park, Minnesota along with Det. Braun, Det. Soeffker and Det. Hopkins. The following report will be a summary of the interview. The complete interview will be saved to the main case file for future evidentiary value. For greater details refer to the complete digital recording of the interview.

At about 8:57 PM Det. Braun and myself conducted a digitally recorded interview of the occupant of apartment #11 of the above listed apartment complex. Apartment #11 is on the 3rd floor and directly above apartment #7. The resident identified herself as Gabrielle Leigh Findell (dob 2-5-1992). Findell stated that she lived at the residence with her children. Findell stated that she was home all day alone with her children. Findell further stated that she was sleeping this afternoon with her children and did not know of the police involvement or the reported domestic assault that occurred on the 2nd floor.

Findell stated that she heard a lot of loud banging/knocking on her door earlier this afternoon around 4:30 PM but that she did not answer it. Findell stated that at some point later in the afternoon she heard 4 loud bangs and thought that someone had pounded on the wall to try and let someone else know that they were being too loud. Findell stated that she did not even know the police were at the apartment complex.

Findell stated that she did know "Mylee." Mylee was later identified as Mylee Jane Workman (dob 7-8-1981) the occupant of apartment #7. Findell stated that she and Workman were friends and that she had met Tuhkanen a few times but that she did not really know him. Findell stated that she thought Workman had an Order for Protection against Tuhkanen but that she was not sure if the order was still active.

Findell stated that she was unaware of any physical violence between Tuhkanen and Workman. Findell stated that Workman had told her previously that Tuhkanen was "crazy."

Findell stated that she had not talked to Workman or Tuhkanen today. Findell provided a contact phone number of 612-434-9491.

## **SYNOPSIS:**

This report pertains to the summary of an interview with Tianna Mitchell, a resident at the 2760 Louisiana Court apartment complex.

# **OFFICERS INVOLVED:**

Detective Hopkins and Detective Soeffker

## NARRATIVE:

On 01/19/2019 Detective Soeffker and I, Detective Hopkins, were tasked with conducting canvas interviews of residents at 2760 Louisiana Court. These interviews were in relation to a death investigation of **Matthew Neil Tuhkanen DOB 08/04/1983** in unit #7 at the complex.

Detective Soeffker and I interviewed the resident in unit #12, **Tianna Reave Mitchell DOB 12/28/1990**. Unit #12 is on the top floor of the apartment complex, one floor above unit #7. The following is a summary of the interview with Mitchell:

Mitchell said she left her apartment sometime on the afternoon of 1/19/2019. She said she returned to her apartment complex to change shoes and saw a male, identified as Tuhkanen, outside unit #7. Mitchell said she did not know the names of the female resident of unit #7, identified by law enforcement as **Mylee Jane Workman DOB 07/08/1981**, or the male outside the door. Mitchell said she does not really know Workman, indicating she did not have much interaction with her outside borrowing cigarettes and saying hello.

Mitchell then looked through her phone to find a more accurate time frame of the events. Mitchell then said it was around 1600 hours when she went to her mother's car outside of the apartment. She said Tuhkanen was knocking on the door of unit #7 asking Workman to let him in the unit. She said Tuhkanen kept knocking and banging on the door. Mitchell reported that Tuhkanen then wanted his son to come to the door, but Workman refused. Mitchell heard Tuhkanen saying, "I love you bud," through the door and kept knocking on it. Mitchell reported that Tuhkanen threw a big bag at the door and kept saying, "Let me in." Mitchell reported she heard Workman said, "You're trying to take all my money and I'm not giving you my money." Mitchell said she got the impression that if "she would've opened the door, he would have probably, like, attacked." Mitchell the went on to say that Tuhkanen wouldn't stop trying to get in the apartment saying "he was really eager to get in."

Mitchell said she told her mother that they should call the police. Her mother advised her not to get involved. Mitchell then went to Family Dollar. When she returned there were squad cars out front of the apartment. She said she was asked by officers if Tuhkanen was still in the building. Mitchell told the officers, "he probably pretty much is probably still in the building because of these three (referring to units #9, 10, 11)." Mitchell said Workman knows the residents in units #9-11.

Mitchell described Tuhkanen as Latino, Mexican or Native American, she said she didn't believe he was white. Mitchell said Tuhkanen was similar in age and stature to Detective Soeffker.

Mitchell said no one knocked on her door or tried to get into her apartment at any time. Mitchell said after she talked to the officers regarding Tuhkanen outside unit #7, she made her daughter food. She then heard officers knocking on the doors of the units on the third floor. Mitchell said after the officers left, she heard Workman and her son go out the back door of the building. Mitchell said she then took a shower, and after she was done she noticed a bunch of squad cars outside.

Mitchell said she did not hear anything when the officers came back the second time. She said she didn't hear gunshots or screaming as she was in the shower at that time.

Mitchell she had previously witnessed two verbal arguments between Tuhkanen and Workman. She said she had witness them outside arguing, but said "this time, that, like, seemed serious cause he was eager to get into her apartment."

Detective Soeffker and I received information that Tuhkanen may have been with a black male in a unit on the third floor prior to the shooting. Mitchell said she was not aware of any other males that stay on the third floor of the apartment. She did say that unit #11 has her "baby's daddy" over sometimes. She described him as a white male. Mitchell said she has seen a Somali male in unit #9 and stated that was the resident's brother.

Mitchell then summarized her involvement in the incident. She again stated she spoke with officers and Yolanda, the apartment manager, after she returned to the building from Family Dollar. Mitchell said her daughter's father, Ty, did come to the apartment complex but stayed outside. Mitchell denied Ty ever being in her apartment.

The interview ended at approximately 2110 hours. I uploaded the audio recording to the case file, please review for complete details.

TRM Yeah, I hung, got a couple little cigarettes from her.

TRM And came and said like hi and stuff, but I don't really know her know her.

And they were lined up downstairs, and officers and they were like well is he still in the building, and I'm like, he probably pretty much is probably still in the building, because of these three. Um, 11, um cause she knows them, like, they kick it.

# **SYNOPSIS:**

This report pertains to the digitally recorded interview of potential witnesses regarding this death investigation. The potential witnesses were occupying an apartment in the same building as the death occurred.

# **OFFICERS INVOLVED:**

From the Hennepin County Sheriff's Office Investigative Division: Det. Nestrud, Det. Braun, Det. Soeffker, Det. Hopkins.

# **NARRATIVE:**

On 1-19-2019 I, Det. Aaron Nestrud was assigned to assist with the death investigation of Matthew Neil Tuhkanen (dob 8-4-1983). I arrived on scene and was tasked with conducting a canvas of the occupants of the apartments located within the housing complex located at 2760 Louisiana Court in St. Louis Park, Minnesota along with Det. Braun, Det. Soeffker and Det. Hopkins. The following report will be a summary of the interview. The complete interview will be saved to the main case file for future evidentiary value. For greater details refer to the complete digital recording of the interview.

At about 8:57 PM Det. Braun, Det. Soeffker, Det. Hopkins and myself conducted a digitally recorded interview of the occupants of apartment #09 of the above listed apartment complex. Apartment #9 is on the 3rd floor on the same side of the apartment complex as apartment #7 but on the opposite end. The occupants of apartment #9 were very deceitful and confrontational. The female that opened the door, identified herself as Huda Mara 1-1-1988 and stated that she lived at this address. A male later came out of the apartment and stated that his name was Paul Edward Neely (dob 7-5-1980).

It was later learned that neither party was the actual resident of apartment #9. The female later stated that her sister is Mara and that her real name is Iqra M. Abdullahi (dob 01-01-1988).

Neither party could provide truthful information. Both Abdullahi and Neely stated that they had no information regarding anything that may have occurred at the apartment complex.

# **SYNOPSIS:**

This incident pertains to a death investigation in the city of St. Louis Park.

## NARRATIVE:

On January 19, 2019, at approximately 10:49 p.m., I, Det. Diane Nelson along with my partner, Det. Nicholas Koch, interviewed Vicky Evanov at the St. Louis Park Police Department. Ms. Evanov is Matthew Tuhkanen's mother. During the interview, we asked Ms. Evanov about her son, his personal history, and any personal knowledge she had related to the events of the day.

The interview was digitally recorded and a copy of the interview was uploaded into the media section of this report. Ms. Evanov told me that her son had contacted her earlier in the day on January 19, 2019. He had asked if she had any money to spare. Evanov said that around noon on the 19th, she had stopped at the apartment and had given Tuhkanen 2 packs of cigarettes and \$30. She did not believe he was under the influence of any substance at that time.

She also stated that on multiple occasions, Tuhkanen had said that he "didn't want to live", but he hadn't specified a specific suicidal statement. However, he had attempted suicide at the age of 14. At that time, Ms. Evanov had found Tuhkanen hanging from a clothes line. She stated that she intervened, and that Tuhkanen went into treatment for depression and anxiety issues.

She also said that Tuhkanen could become angry when he was using either drugs or alcohol.

VLE I'm Vicky Evanov.

DMN Umm, can you spell your last name, please?

VLE E-v-a-n-o-v.

DMN ...in the past as well? Umm, do you know what those substances generally were? When he got struggles, I know it was either the drinking or it was, umm, I want to say Meth.

DMN Okay. And was he maintaining his sobriety recently? Or...

VLE That was, umm, it was like a week ago. I'm not sure the exact date but I can't even remember. It's, I'm feeling kind of like numb today 'cuz of all this stuff.

DMN It, it's a lot. And then here we are asking you...

DMN ... to recall things that you didn't think you were gonna have to.

VLE I don't know the date. I know it was a Friday.

VLE And, umm, he, they released him from Benton County. And I know that it was, we had snowfall.

VLE And I brang him, I brang two packs of cigarettes to him 'cuz I know him and her both smoke.

VLE I brang two packs of cigarettes and I gave him \$30 because that's, I said that's all I can give you right now. You know, because I take care of the other kids.

DMN Mm-hmm.

VLE I adopted his three children from his wife that passed away. And, umm, so I did that. And then I went to go meet my daughter. And when I saw him he seemed fine then.

DMN Okay.

VLE You know? He didn't, you know, he didn't seem like there was any issues. I mean I knew that, I know that they fight and argue a lot? But it's just kind of how their relationship has been a lot. I mean she struggles too, you know with having issues. So, you know.

DMN Umm, was she there when you went to the house?

VLE No.

DMN And did he say where she was at all?

VLE She was at her dad's.

DMN Okay.

VLE I know, that's what, 'cuz he told me last night. 'Cuz I had talked to him last night too.

DMN Mm-hmm.

VLE And they said, he was at his dad's, or she was there, I mean he said. And he said he was lonely. That's the, this is the part for Matt, you know, he gets really lonely when no one's around to talk to him.

DMN Mm-hmm.

VLE Or to be around him. He thinks that nobody loves him that way. You know? That was kind of his, you know, struggle.

DMN Okay. So last night he was a little bit lonely and, and you went over and saw him today?

VLE Yeah. But I didn't stay long 'cuz I had to get going to meet my daughter.

DMN Okay. And what time was that?

VLE That was at noon. I was meeting my daughter in St. Cloud 'cuz she works at the VA.

DMN Mm-hmm.

VLE So I was meeting her when she got off work. So that's why I left to go meet her.

DMN Did he seem, umm, can you tell when he's been drinking or using?

VLE Yes. Yes.

DMN Okay. And do you think he was drinking or using today?

VLE At that time, no.

DMN Okay.

VLE But I did talk to him before this incident that occurred. Because he asked me to come and get him.

DMN Okay. And what time was that?

VLE And it was I don't know the time exactly. I don't know the time. I have, I have him where he text me phone and asked me to come and get him and

DMN Mm-hmm.

VLE He texted me and said, will you come get me and ? And I said, no. I said he can't come to my house.

DMN Why not?

VLE Matt can't come to my house 'cuz my apartments don't want any problems there. And 'cuz Matt has a problem when he drinks.

DMN Mm-hmm.

And that is something that is, you know, and so they have a thing that they sent VLE me that say they don't want him on the property.

DMN Mm-hmm.

VLE So it's a trespassing thing.

DMN Mm-hmm.

VLE So he can't come there. So, and that was just after that weekend that he was at my house that I got that from them.

DMN Okay. And, you know, a lot of times that pretty normal with that housing situation.

VLE Right.

DMN Did he tell you why he wanted you to come and get him and Matthew?

VLE No, he just, well he just says...

DMN Or him and

...he always just tells me Mylee doesn't love me. But that's not how it really is, VLE 'cuz he gets, he doesn't understand, you know, a lot of things. So, he just has struggles.

DMN Do you know about what time that was? I know you, your phone is not with you. But...

VLE Umm, I don't, I, I, I can't tell you a time today. I don't know.

Okay. Did you primarily text with him after you left to go meet your daughter? DMN No. and then he called me. And then I talked to him and I could tell that he had VLE had something to drink.

DMN Okav.

VLE And I said, Matt, I can tell that you've been drinking. He said I haven't been drinking. But I'm his mom. I can tell.

DMN How?

VLE I can tell in the voice. Umm, he speaks, his speech is different.

DMN Okay.

VLE Speech is different and I can tell.

DMN So you knew that there was something going on?

VLE I knew he was drinking. I knew he wasn't like, like totally drunk or anything 'cuz he could still speak to me and he was being very nice to me, word-wise.

DMN Mm-hmm.

VLE And if he was totally inebriated, he wouldn't have been very nice to me verbally. So I can tell you that I know that he wasn't that way.

DMN Okay.

VLE Then but he, but he had been drinking. So...

DMN Okay. Would you say, how would you characterize it? You kind of alluded to it a little bit. Umm, but he was drinking really heavily, I mean, does he, does he get hostile and angry?

VLE Oh, he's, yeah. He can, he can be.

DMN And to your experience with him, it seemed like he had been drinking but...

VLE Yeah, he was fine. He just wanted, and I told him I couldn't come and get him.

DMN Okay.

VLE And he said well can't you just come and get me and bring me to Anoka?

DMN Mm-hmm. Mm-hmm.

VLE 'Cuz that's where I live in, in town. But then he'll just walk around the town and not have no place to go and I said, no. I'm not gonna do that.

DMN And it's, you know, it's cold and, and...

VLE Yeah.

DMN So about how long did that conversation go on? VLE It wasn't very long, about couple minutes probably.

DMN And when you go back would you be able to check your phone just to see what time that call came in?

VLE Yeah. Yep.

DMN Okay. VLE Yeah.

DMN Do you remember if it was maybe after you got back from seeing St. Cloud or? Yeah, it was after. I know it was after. This was all happening this evening, this didn't happen earlier today.

DMN Okay.

VLE 'Cuz I was with my daughter and I was in St. Cloud for, she got off at 3, we had dinner.

DMN Mm-hmm.

VLE And we sat and talked and then I came back. So it was after that.

DMN So do you, she

VLE It wasn't dark yet when I got home. So but the time I got the call from, umm, like Mylee and stuff it was already dark.

DMN Okay.

VLE So it was, somewhere between that transformation of the, you know, the sun going down and it getting actual dark out. You could see the moon, but you know.

DMN So you guys, if your daughter got off work at 3 and you went to grab something to eat, umm, probably got out there about maybe 4? Fair to say?

VLE Yeah, I don't, I can't tell you a time.

DMN Okay. When he called do you remember if it was light or dark?

VLE I don't know 'cuz I wasn't by the window at that time.

DMN Okay.

VLE It was dark when I left the house. So it was dark because I went to bring Wade, I had to go to Wade's mom's house.

DMN Mm-hmm.

VLE 'Cuz his, we went there. His sister and his son was there and the mom had to go pick up the daughter. So we went and sat there while she to run.

DMN And is that when he called you is when you were at Wade's?

VLE Yep.

DMN And so it was...

VLE I think I was on my way over there.

DMN Okay. So that was probably a bit, it was dark out at that point?

VLE Mm-hmm. It was dark, yeah.

DMN Okay. And umm, what else did he tell you, if anything, other than come get me and example.

VLE He didn't really say anything. He's just like come and get me.

DMN Okay.

VLE Yeah.

DMN And you told him you couldn't?

VLE And I said 'cuz like I said, you can't come here. I said I can't just bring him to my town and say just go walk the streets.

DMN Mm-hmm.

VLE 'Cuz he's done that before.

DMN Yeah.

VLE When he's had no place to go, he'll just walk and walk and walk. And he's done that in the cold. And where he, you know, he'll just keep walking.

DMN Mm-hmm.

VLE And then he doesn't have his medication. And then his, his mind, you know, there's a lot of mental health issues. There's been mental health issues since 14,

like I said, when I was talking in there.

DMN Does he have any other mental health issues? You mentioned that a couple times other than depression? Or is depression and anxiety primarily the two?

VLE I'm sure he has, I'm sure he has some kind of diagnostic. I don't know what it is. I mean I just know he said he goes to therapy.

DMN Okay. Do you know where his therapy is?

VLE I know he was going to Nystrom's.

DMN Okay.

VLE Umm, at one time the one in, ahh, New Brighton. But I don't know for sure.

DMN Okay.

VLE I don't know where the new one is.

DMN Okay.

VLE Or where actually who he sees or anything.

DMN Okay, alright. So, after you got off the phone with him, was that the last time you talked to him?

VLE Yep.

DMN When did you become aware that there was a problem?

VLE Mylee called me.

DMN Okay. And what did she say?

VLE And said that, that there was shots fired and she said that I think that they killed Matt. And I said they what? No one would kill him. I said why would they kill him? And she said, Vicky, there is no ambulance here. And I said Mylee they wouldn't kill him. He's not like that kind of person to kill. That's what I said. 'Cuz I couldn't, you know, see that. I said are you sure that Matt didn't hurt himself? That's what I said.

DMN Has, has he been suicidal in the past?

VLE Yes.

DMN Okay. Has he attempted or has he just said.

VLE Just said.

DMN Okay. So he's never tried to actively self-harm himself? Or...

VLE When he was a kid.

DMN Okay.

VLE When he was 14.

DMN Okay.

VLE I walked into the bedroom and he was hanging from a cord.

DMN Okay.

VLE And I lifted him up.

DMN And you intervened there?

VLE Yep. And I called the ambulance and they took him to the hospital and he went to, umm, a mental health unit.

DMN Mm-hmm.

VLE And then from the mental health unit to, ahh, Cambridge, umm, they said that he had a drinking problem.

DMN Mm-hmm.

VLE So he went there. And from that treatment center, they said he had mental health issues. Next time you can get him in to get mental health issues is when he tries to hurt himself again. That was my [inaudible] diagnostic.

DMN Okay.

VLE So this, he's been struggling with this for years.

DMN Okay.

VLE This is how it, how it, how it works.

DMN To your knowledge, has he ever actively taken steps towards trying to kill himself other than that time?

VLE No. No.

DMN Okay. And has he, but he's talked about it?

VLE I don't know that, he always says I'm better off dead. So...

DMN Okay. Okay.

VLE Well you know, 'cuz he always thinks that no one, he told me, he told me, was it yesterday? Nobody loves me except for

DMN Mm-hmm.

VLE And I said that's not true. Everybody loves you, I said. It's just that people can't handle all the stuff that comes with it, you know? The drinking, the drinking part to me, and the drug use is like, you know, I don't, I can't do it.

DMN Mm-hmm. VLE I can't do it.

DMN And it's...

VLE It changes people.

DMN It does. And it sounds like with him when he was on substances, he could be a pretty,

VLE Yeah.

DMN ...difficult person.

VLE Yeah. Well he would just get, like if he would say, to me, he'd be, he'd be okay as

VLE And in that mindset. But if he's in like the, you know, how you...I mean I have anxiety and depression to. So if you're into the mindset of umm being negative and sad and that kind of, you know, how, like feel sorry type thing for yourself?

DMN Yeah.

VLE And then, and I know, 'cuz I have it. So if I came here tonight in that kind of mindset, this could not be a conversation you could have with me 'cuz I couldn't have done this.

DMN Right.

VLE But, I...

DMN Well you're amazingly strong to...

VLE Right.

DMN ...talk to us. That's...

VLE No, I know.

DMN ...amazing.

VLE I know. I am a strong person. That's how God made me.

DMN Yep.

VLE But, umm, you know, he, it depends what kind of, that mindset? What he was.

DMN Mm-hmm.

VLE So he could be, like, if someone came and talked to him, he could be all like everything you would he was your best friend. But another time, if he's in that? Then you would think you were like, what did I ever do to you?

DMN Mm-hmm.

VLE You know? You just don't know.

DMN You don't know what you're gonna get with him. Hey, to your knowledge, did he have access to any weapons of any kind? Even if it's a, a knife? Or a handgun? Or...

VLE I don't know. I, I know, I've, I want, I'll tell you that I know that he liked knives.

DMN Mm-hmm.

VLE That was something that he liked.

DMN Mm-hmm.

VLE When he was kid, my dad used to teach him to, you know, whittle stuff.

DMN Mm-hmm.

VLE So those kind of things, he was interested in. But did he have any on him or that I know of, no. But I know there was no, like, he, there was no, I know he didn't have a gun.

DMN Okay.

VLE Or anything like that.

DMN Okay. Do you know if he had any knives currently?

VLE No. Currently I would say he didn't have any.

DMN Okay.

VLE But that's something, I don't, you know, I'm not there either. So I don't know.

DMN Okay. Did Mylee say anything else when you guys talked or?

VLE No. That's all she. She had said she didn't know anything and that then I hung up the phone with her.

#### **NARRATIVE:**

On January 19th, 2019 Detective Michael Hopkins and I, Detective Reed Soeffker, conducted a digitally recorded interview of Wasley in the hallway in front of her apartment located at 2760 Louisiana Court #3 in Saint Louis Park, Minnesota. Wasley was interviewed about her knowledge of a domestic disturbance and police involvement in the death of Tuhkanen. This report is a summary of Wasley's statements to both Detectives during the interview. The complete interview is saved to this case file for evidentiary value.

Detective Hopkins and I began trying to make contact with all the occupants of 2760 Louisiana Court. Unit #1 was an office for the apartment complex, Apartment #2 was occupied by Shelly Sage Mills (03/11/1991), Apartment #3 is the home of Tamara Lynn Wasley (11/09/1979), and Apartment #4 is a vacant unit. While we were attempting contact with occupants on the lower level, Wasley (11/09/1979) and her juvenile daughter arrived to her apartment (Apartment #3) at approximately 0846 hours.

Wasley stated that she knows the occupants of several apartments, including Apartment #7. Wasley stated that the occupant of Apartment #7 is "Mylee", her 4 year old son named and another, and the father of her child named "Matt" stays in the apartment sometimes. Wasley stated that the occupants of Apartment #7 have only been renting here for one month, but the occupants "seem to get along". Wasley states that that she is "not sure" if "Matt" is allowed to stay here because this apartment building is dedicated to "sober housing" for "women and children who are getting out of treatment."

Wasley stated that "Mylee" is "doing okay", but "Matt" is known to have a warrant and "skidding" between sobriety and intoxication. Wasley stated that she doesn't know "Matt" well enough to know his reputation, but he is stressing "Mylee" out. Wasley stated that "Mylee" told her that "Matt" is supposed to be in treatment but "Matt" may be causing "Mylee" to lose her housing.

Detective Hopkins left a business card to contact us if she thinks of anything more she wants to share with us.

Wasley stated that Apartment #4 is vacant.

## NARRATIVE:

On 1-30-2019 the above listed Detectives conducted a digitally recorded interview with Yolanda Mae Farris DOB 7-29-1964 at 2759 Louisiana Ct. #9 St. Louis Park, MN. Farris was interviewed regarding her knowledge of what occurred inside 2760 Louisiana Ct. between Mylee Jane Workman DOB 7-8-1981, Matthew Neil Tuhkanen DOB 8-4-1983 and the St. Louis Park Police Department on 1-19-2019. This report is a summary of Farris' statements to Detectives' questions during this interview. Refer to the report titled ""Q&A Yolanda Mae Farris DOB 7-29-1964 on 1-30-2019" for greater details. The Q&A report with Farris is a transcription of Farris' interview. A copy of this Q&A report and digitally recorded interview are attached to this case file for evidentiary value.

Farris stated that she lives at 2759 Louisiana Ct. #9 St. Louis Park, MN. Farris stated that she works for Perspectives as a "coach". Farris stated that Perspectives is a program that assists women and their children in homelessness, poverty and trauma. Farris stated that one of her functions as a "coach" is to mediate and act as a liaison for the women and their children in this program with Law Enforcement.

Farris stated that on 1-19-2019 she was working in the "LAC" (Louisiana Court) office which is located in 2760 Louisiana Ct. Farris stated that between approximately 4:30pm and 6:00pm she heard loud noises and banging coming from inside this building from her LAC office. Farris stated she exited her office and observed St. Louis Park Police Officers on the second and third floors of this apartment complex.

Farris stated that she made contact with Officers "Sam" (Officer Heffernan) and "Maurice" (Officer Smith) inside the apartment building. Farris stated that she was advised that Law Enforcement had been called to this apartment complex in regards to a "domestic". Farris stated that she accompanied Law Enforcement as they searched the apartment building looking for Matthew Neil Tuhkanen DOB 8-4-1983. Tuhkanen was believed to have been involved/suspect in this "domestic" call. Farris stated that she knocked on the apartment doors inside this apartment building but was unsuccessful in

making contact with any of the tenants.

Farris stated that she then proceeded to go to the second floor and to apartment #7. Farris stated that she, along with Officer Heffernan, spoke with the tenant in apartment #7. Farris stated that she did not know this tenant very well and that she was new to the Perspectives program. Farris had to look up this tenant's name on her roster during this interview to recall the tenant's name. Farris was able to identify the tenant as "Mylee" (Mylee Jane Workman DOB 7-8-1981). Farris described Workman as a white female with blonde hair. Farris stated that she attempted to provide Workman with information regarding Perspectives and what resources were available to her in a "domestic" situation. Farris stated that she gave Officer Heffernan her business card who then gave it to Workman while both were inside Workman's apartment.

Farris stated that Workman and her 4 year old child appeared to be in an nervous, excited and distressed state while she was inside Workman's apartment. Farris stated that she had never met and does not know Tuhkanen. Farris stated that she was also shown a picture of Tuhkanen by Law Enforcement that night and again she stated she did not know or recognize him.

Farris stated that she was not informed of Tuhkanen's potential or intent towards violence by Workman or Law Enforcement that night.

Farris stated that after she departed Workman's apartment, she locked the door for the LAC and returned to her apartment. Farris stated that she continued to watch 2760 Louisiana Ct. from her apartment and observed more Law Enforcement arrive. Farris stated she attempted to make contact with Law Enforcement at a later time that night and to speak with Officers Heffernan and Smith. Farris stated she was prohibited from speaking to either Officer.

Farris stated that she knew Officers Heffernan and Smith from their previous involvements and interactions with Perspective tenants in the apartment complex. Farris stated that both Officers "were good guys".

So they just want to make sure that h...this guy hadn't ran in somebody's apartment and maybe got holdin' them in there. Ya know.

CLN Mmm hum.

YMF Well that's what they explained to me. So I started helping them because I know the ladies, and I'm knocking on their doors calling their names. So that they know I'm with them. And....um....we didn't have any luck, so we went back to the apartment of the lady...the....who had the incident.

DMN Which apartment was that?

YMF That was apartment number.....cause I can't remember off the top of my head. I'm sorry. Ah....that was apartment numberrrrrrrrrrr.......(flipping of pages)....oh, sorry. [flipping pages) That was Apartment Number 4. Malley. Apartment Number 7.

CLN Okay. Do you know the tenant that lives there?

YMF Well she's fairly new. Um. So I don't......I know of her...know her face and

everything, but I have never worked with her.

CLN Okay. How would you....let's say....physically describe her?

YMF Um....she's a white female, and I believe she has blonde hair. I believe. Mmm hum.

CLN Okay. Anybody else inside the apartment at the time?

YMF That's so screwy.

YMF I wanna say it was maybe between...well I can't remember the exact time. Maybe 4:30ish. Between 4:30 and 6 p.m.

YMF Somewhere around....roughly around that time.

CLN Okay. So they told you why they were here.

YMF Mmm hum.

CLN Um...what....what did you tell them? Did you...

YMF Again, I couldn't tell them anything because I didn't know him, and I barely know her.

YMF You know. I...when...when..the women come to the program, we do a....you know...introduction. They come to the office and, you know, they meet everybody but that was far as....as far as I had ever gotten with her. I never had any...ah...interactions with her at all, so.

No, only when we went to her apartment and I changed....gave her my information just in case she needed me.

CLN Okay. Did she tell you anything at this point?

YMF Nope. She didn't tell me anything. So was so distraught. You know....um....she was trying to keep the little boy contained 'cause he was four years old. He was flippin and dippin and she was...you know...she seemed a little nervous.

DMN Mmm hum.

YMF You know. And I don't know. It could have been from the police. Could be anxiety. I don't know. You know.

CLN Okay.

YMF Mmm hum.

CLN Well, after you had that conversation with Officer Sam and Maurice.

YMF Mmm hum.

CLN Ah...did you go back inside the LAC?
YMF I went to lock it 'cause I hadn't locked it.

CLN Okav.

YMF And then I came home 'cause they were leaving.

CLN Okay.

YMF Mmm hum.

CLN Who...who were leaving?

YMF The police.

CLN Okay.

YMF Mmm hum.

CLN (clears throat). Um....did you have any secondary or follow-up conversations with Officer Sam or Maurice, or any other St. Louis...

YMF ....no, I didn't...

CLN ...Park Officer?......

YMF ....see anybody until I came...when they came back after the situation. That's my son playing a game. I'm sorry. Um...after...um...when they came back for the call, and.....[inaudible 06:54] .....when they.....after they came back for the call, and.....they wouldn't let me talk to.....um...Sam, and I didn't see Maurice. I seen.....I know...ah....I know just about all of 'em. I was talkin' to.a.[inaudible 07:06] I came down. I was trying to find out what happened. And he's like, "Yolanda, I can't talk to you right now." You know.

DMN Yeah.

PMF But, I can tell you you guys are safe. So I kinda, you know, grabbed the women up and said, "We need to get out." 'Cause we were all in the hallway. Out of the way, you know. And....um....let them take care of everything, and....yep......I planned out some of it, ya'll know.

Okay. So (clears throat) just....just to walk it through and make sure I got it straight in my head, you know. You hear the banging, hear the pounding, you come out of your.....the LAC.

YMF Mmm hum.

CLN See some officers on the third floor, some on the second...

YMF ....Mmm hum....

CLN By Apartment 7...

YMF ...mmm hum...

CLN Ah....where did you talk to Officer Sam and Maurice? On the second floor or the third floor?

On the second......was it the second floor or third floor? Cause I heard it once on the third floor, so I think I started talking to them on the second, and then I ended up going to the third 'cause they kinda made me feel like their [inaudible 07:56] up the stairs. So then I went and started knocking on the doors, like the....the first one I got to was the lady named, Tierra. I was like,

"Tierra." I was knocking." So that she could hear my voice, but everybody door I knocked on, nobody answered.

DMN Mmm hum.

CLN Okay. So after you knocked on the doors, where did you go again?

We came back downstairs to....um....'cause I left a couple of 'em talkin' amongst each other, and came back and I said, "Sam, she don't have my information, I don't believe," 'cause I had....didn't know her. And, I had my card and... ah....wrote my personal cell phone number on the back. 'Cause it's the weekend and I really don't...you know....so I wrote my personal number and I say, "If you need me, call me. Call the police first and then call me." You know. And she's like, "Okay. I will."

CLN So you gave her your card to her.

YMF To her.

CLN When officers were present.

YMF Right.

CLN Sam and Maurice?

YMF No, to Sam. 'Cause Sam and I were in the apartment.

CLN Okay. So then after you gave 'em the cards, do you go back down to the LAC, or did you come back here?

YMF I came,....went back to the LAC office just to lock, and then I came home.

CLN Okay.

YMF 'Cause the door wasn't locked.

CLN So then after you come back here, at what point do you...ah...try to talk to Officer Sam again?

YMF Well, you know, I can see everything from my window...off my balcony here. And, I just saw the police. And I'm like, "Oh my God. This guy...I'm assuming, came back, or they found him, whatever." And I went down, but by the time I got downstairs...cause I gotta find shoes and keys....it was just....like more people than when I actually looked out the window. So like, more police officers at this point. And Sam was standin' off to the side, and I went to approach him and they wouldn't let me.

CLN Okay.

YMF And said, "Okay," you know. I understand that somethin' was wrong.

CLN And, just to make sure I understand correctly too, the man that was involved with Mylee in Apartment Number 7....

YMF ....mmm hum.

CLN You ha....you'd never seen him before?

YMF Never.

CLN Don't know his name?

YMF Don't know his name. CLN Okay. And, did you ever have a conversation with Mylee regarding this guy? YMF No, because I really don't know her. CLN Okay. **YMF** Uhh. DMN Do you just kinda see her as she comes and goes? I just saw her once when she came down to the office, 'cause we all have offices YMF down at the main office. That's where the groups and everything are. I seen her down....and when she initially moved in, then they bring her around. She introduce her to everybody. I hadn't seen her since then. So, I hadn't had no conversation with her about anything. Did you have any conversations with Officer Sam or Maurice regarding the CLN potential threat that this man would be ca....could be causing? YMF No. CLN In the apartment? **YMF** They just said that there was a domestic. They didn't give me no...they never give me any information, you know.... DMN Mmm hum. YMF But they'll just let me know if I can assist them. CLN Mmm. And a lot of times they'll be like, "No, we gotta Yolanda, but thanks." You know. YMF Yeah, but you had never....you didn't say anything to Officer Sam or Maurice like, CLN "Hey, this guy is dangerous. This guy did..." YMF ....no, because I didn't even know him. CLN Okay. YMF Uh uh. CLN Alright. YMF Uh uh. CLN Do you have any questions, Diane? About how long were you in the....ah...apartment with Mylee and Mr....Officer DMN Sam? YMF Um....no even five minutes. Did anything come up when you all three were talking about...about...ah...a DMN threat of violence or...or anything? YMF Uh. Uh. Nope. DMN Okay. YMFUh.

CLN Alright. I don't have any questions....ah...more for you Yolanda, but do have any further of me or Diane?

YMF No....um....no. I'm just....hate it had to happen, you know. Um...I hate anybody get killed, you know. Um....I'm glad that her and her baby is okay. I hate to see it happen to...ah... Officer Sam 'cause he a good guy, from what I know. You know.

DMN Mmm hum.
YMF It's just....a....

CLN ....Had he always.... YMF ....bad situation....

CNL ...kinda worked with you to.....

YMF ....always. Always. You know, he....um....one of the police officers they come through here in the summertime; pass out stickers to the kids, candy. You know. Get out and mingle with the women and...you know...and....and they always have a.....'cause I'm real nosy and they know....and...

DMN (laughter)

YMF ....you know, and I'm loud and all over the place, and they know I know everybody and everything. So they always kind of gravitated towards me... probably to use me, or whatever, but, you know....just to have a good relationship. It's good to have a good relationship with the police....

DMN ....yeah... YMF ....you know.

DMN It is, especially when you're kinda the....the go-between there. You said something about you're glad that....that Mylee and the little boy are okay.

YMF Yeah.

DMN That night...did you....I mean...did you have any thoughts that they might come to harm....

YMF None. 'Cause you know what.....um.....had I had any thoughts, I would have taken her and him down to the LAC office, or brought her over to my apartment.

DMN Mmm hum.

YMF Like, I never thought...because...mind you, when....um....she...when I was in her apartment with Sam those few minutes, she never said nothin' the whole time she was grabbing the baby. And, she never made no ey.....eye contact or anything.

DMN And....and some people just can't be me.....you know, they can't be reached like that.

YMF Right. Right.

DMN You know.

YMF Right. So I didn't....you know...I didn't get any feel about anything.

When they talked to you about it, was a domestic that they were there for. DMN

YMF Mmm hum.

Did they...eh...did you hear Officer Sam or Officer Maurice, either of them, ask if DMN

she was hit or injured, or anything...

YMF ....no. They didn't.....

DMN ....like that...

YMF ....ask any of those questions around me.

Okay. And did they tell you and they're like, "Yeah, some lady got hit...." DMN

YMF ...no.

DMN [inaudible 13:13] It just, "Hey. It's a domestic."

YMF ...it's just....

DMN .... "and we're good.".....

YMF ....a domestic, yeah.

DMN Okav.

It's just a domestic, and I just try to....not....and see if...'cause when he YMF said....um....I can't remember. I don't think it was Sam that said.....and I think it was another officer that said, "We just want to make sure that....um...he's not

in......just...you know...got into somebody's apartment and holdin' them."

DMN Mmm hum.

YMF You know.

But there was no reason behind that, other than couldn't find him in the building. DMN

YMF That was it.

DMN Right? Okay.

YMF Yeah, that was it.

DMN Alright.

YMF So they didn't say anything, and.....um...they...we all left out the building at the

same time.

**DMN** Mmm hum.

I just came across. And they stood out there and, you know, probably wrapped it YMF

up, or whatever. But I came up to my apartment.

DMN Okay.

'Cause that was it, you know. And I remember, as we was coming out the door... YMF when we came out her apartment, she locked her door. But then when we got down to the front door, she came back out. And then I remember Officer

Sam....um....Sam turned to her and say, "You need to go back in your apartment

and lock your door."

DMN Mmm hum.

And she's like, "Okay." 'Cause I think she was trying to probably make YMF

sure it was safe. I don't know. You know.

DMN Did they talk about anything else? Officer Sam and Mylee at that point?

No. She....he just talked, cause we were at the point through he just said, "You YMF

need to go back in your apartment and lock your door.

And did you say anything else between you and Officer Sam? DMN

Uh um. We can and went out the door. And I came... YMF

DMN ...came back out.

YMF Mmm hum. Mmm hum.

DMN Okay.

Yep. And I always said, "Thank you." YMF

DMN Oh, right. YMF You know....

DMN ...right.... YMF

....but...that was it. Just a normal police call.

DMN It....there was nothing....

Nothing. Nothing. I....I have played this over in my head so many **YMF** times. They're like, what is there anything that I could have done differently? You know.

CLN How did you learn that somebody lost their life over there?

I came back home and....um....'cause like I said, we were in the building YMF and....just....and....and...don't judge me.

DMN Uh huh.

But....just watching a lot....a lot of Law and Order, right. I knew when the YMF ambulance left without somebody - that made me suspicious.

DMN Mmm hum.

That was one thing. And then, all you guys and....you know....the Sheriff's YMF Department and all that, I'm like...uh ha, and then, the first thing was when I wasn't able to talk to Sam. That was my first hi....hint that...

DMN ....mmm hum....

....something was wrong. Didn't know, you know, that....didn't have a clue that **YMF** he....he don't....he not even the type of person that would shoot. You know. That never came to my mind, but I knew something was wrong.

DMN Mmm.

So I'm like, something.....and then when the....you notice he's putting pieces YMK together. And then I came home, and then somebody sent me a message....one of the girls that used to live here. Oh...on Facebook, and said, "There was a shooting at the courts. Are you okay?"

DMN Mmm hum.

YMK 'Cause they call us the courts.

DMN Mmm hum.

YMK And I'm like, "Yeah, I'm okay." I turn on the t.v., and then....

DMN ....and then you learned.

YMK Mmm hum.

DMN See, we call that being a good neighbor. I wish I had a neighbor like you.

YMK Mmm hum.

DMN Because you know what goes on.

YMK Mmm hum. Ever...all...everything that goes on. Sometimes too much, like right now. You know.

DMN Right.

YMK You know. So I was just....it was a lot. It...it really was. You know. It was a lot. It was so...

DMN Yes. Yep.

YMK It was scary. You know. It was so real, because it was so right here. But like I told the ladies...'cause everybody was just distraught. It could have been a random shooting. You know. Thank God that this man is trained, and...you know. It still is a bad situation, but.....That man...man could have came up here randomly. Been shooting at other per...people could have got hurt. You know.

DMN Did you have any indication that that was potentially the case that night? No, I didn't know. I....I didn't even....I didn't go there in my mind. I just knew something wasn't right.

DMN Okay.

YMK And when I kept playing it over in my head, and I could see Sam's face. I...we always laugh and interact. You know. And when he was looking like a puppy dog, like...you know, I just wanted to hug him.

DMN Mmm hum. Mmm hum.

YMK I knew something was wrong. But still, when I went and got my co-worker, I didn't say anything to her because I'm o....only assuming. I don't know.

DMN Right.

YMK You know. And I told her, I [inaudible 16:57] to come over here. Let's get this ladies because they was having a hard....the ladies in that building was having a hard time.

DMN Oh yeah. YMK You know.

CLN Okay. Well, I'm gonna....I'm gonna wrap up the interview here.

YMK Okay.

CLN It's approximately 1:13. Interview with Ms. Farris concluded.
