NARRATIVE:

On 7-30-2019 Det. Nybeck conducted a digitally recorded voluntary interview of Golden Valley Police Officer Hartneck at the Hanson Police Department. Officer Hartneck's interview on this date is a supplement to his initial report for Hennepin County case number 19000783 and Hopkins PD case number 190000118. This report is a summary of Officer Hartneck's statements to Det. Nybeck's questions during this interview. The complete interview is saved to this case file in both digital and transcription form. Refer to both forms for greater details.

Officer Hartneck stated that he was dispatched to assist in an OIS (Officer Involved Shooting) in the City of St. Louis Park on 1-19-2019. Officer Hartneck stated that he arrived to the general location of the incident (believed to be 2760 Louisiana Ct) and spoke with St. Louis Park police officer #3930.

Officer Hartneck stated that he was directed by this St. Louis Park police officer to go to the rear of 2760 Louisiana Ct and maintain perimeter on the apartment's rear door. Officer Hartneck stated that he was directed to not allow anyone to enter or exit this apartment complex from this rear door. Officer Hartneck stated that he believes no one entered or exited this apartment complex while he was at this perimeter location.

Officer Hartneck stated he does not recall who relieved him of duty at this perimeter location and he does not recall how long he was present at this perimeter location. Officer Hartneck stated that after he departed the incident scene he returned to his normal duties in the City of Golden Valley.

SH Hello it's Shawn.

CLN Ahh, Officer Hartneck, correct?

SH That is correct, Officer Hartneck.

CLN Hi. Detective Nybeck with the Sheriff's Office. Ahh, today's date is 7/31/2019. It's approximately 1006. I'm at the Hennepin County Sheriff's Office conducting a phone interview with Officer Hartneck of the Golden Valley Police Department in relation to Hennepin County case number 19000783 and St. Louis Park Police Department case number 19000303. Ahh, before I ask you any questions Shawn, I'm just letting you know this is a voluntary and a consensual interview related to St. Louis Park PD case number 19000303. Ahh, this case number is related to an OIS officer-involved shooting that occurred in the City of St. Louis Park on January 19th involving Officer Samuel Heffernan of the St. Louis Park Police Department. Additionally, ah, I'm asking you ahh, have I threatened you, coerced you, or demanded that you speak to me for the purpose of this interview?

SH No, you have not.

CLN Okay. And you're providing this interview of your own choosing, your own volition, correct?

SH That's correct.

CLN Okay. The purpose this interview and the subsequent accompanying report based upon this interview is to provide supplemental information related to your original report regarding your actions and knowledge related to the above-listed St. Louis Park case number. Do you have any questions about anything I've stated so far?

SH No I don't.

CLN Okay. On January 19th of this year, were you dispatched to assist the St. Louis Park Police Department?

SH Yes I was.

CLN Okay. Do you recall why you were dispatched to assist?

SH	Yes I do.
CLN SH	Okay And what was that for? Ah, the initial call we got was to assist with traffic control.
CLN SH	Were you designated to go to a specific location to help out? Ahh, yes. We, I responded to the general area, if I recall correctly. And then speaking to an officer on scene they directed me to where I needed to go.
CLN SH	Okay. And was that general area 2760 Louisiana Court? I believe so, yes.
CLN	And do you recall what St. Louis Park officer or supervisor you spoke to regarding your assignment? Possibly 3930 (badge #).
CLN SH	Okay. And what were you tasked with assisting with? Umm, I was told to go to the back of an apartment building, umm, and make sure nobody went in or out of the apartment.
CLN SH	And do you believe that apartment was 2760 Louisiana Court or a different apartment building. I believe that's it.
CLN SH	While you were maintaining perimeter on the back door for this apartment building, did anybody enter or exit from the rear entrance? I don't believe so.
CLN SH	Okay. And do you recall approximately how long you were at that position? I do not just because of the time lapse.
CLN SH	Okay. Umm, at some point were you relieved of your duty at that location? Yes I was.
CLN SH	Okay. And what did you do after you were relieved of duty? I returned back to the City of Golden Valley.
CLN	Okay. While you were present at that location, did you speak to any St. Louis Park police officer or supervisor or any law enforcement officer related to about what specifically occurred, specifically occurred in that apartment earlier that night? Yes.
CLN SH	And who did you speak to and what did you learn? I do not recall exactly who it was. I just asked what was going on because initially I didn't know and I just got told there was an officer-involved shooting.
CLN	Okay. Were you advised about which officers were involved or specifics related to that OIS? Nope. I was not and I couldn't names of any of the officers down there. I don't really talk to them, so.
CLN	Okay. Alright. Umm, I don't have any further questions for you. Do you have any

SH	questions for me? I don't believe so. Umm, like I said I haven't got a chance to watch my squad video or anything like that which would be there. Umm, but as far as my recollection of that night being it was seven months ago, that's the clearest picture I have.	
CLN	Okay. Well it's approximately 1010 in the morning. I have no further questions. And my interview with Officer Hartneck is concluded. I appreciate you making time out of your, ahh, vacation day to speak with me. And, ahh, that is all I have for you. Thank you, sir.
