NARRATIVE:

On 7-30-2019 Det. Nybeck conducted a digitally recorded voluntary interview of Minnetonka Police Officer Olson at the Minnetonka Police Department. Officer Olson's interview on this date is a supplement to his initial report for Hennepin County case number 19000783 and Minnetonka PD case number 19000272. This report is a summary of Officer Olson's statements to Det. Nybeck's questions during this interview. The complete interview is saved to this case file in both digital and transcription form. Refer to both forms for greater details.

Officer Olson stated that he was assigned to work for the Minnetonka Police Department on 1-19-2019. Officer Olson stated that he heard over his police radio that the St. Louis Park Police Department required assistance related to an OIS (Officer Involved Shooting) in the City of St. Louis Park. Officer Olson stated that he along with Minnetonka police officer Mace went to assist the St. Louis Park Police Department.

Officer Olson stated that he arrived at the incident scene (2760 Louisiana Ct) met with an unknown St. Louis Park police officer and entered this address with Officer Mace. Officer Olson stated that after entering this address he entered apartment #7 (scene of OIS) and observed the following: One St. Louis Park police officer and two firefighters towards the end of the apartment's hallway by a back bedroom. Officer Olson stated that he penetrated to approximately the door way for this bedroom and observed a firefighter and a St. Louis Park police officer in this bedroom along with an unknown individual who was laying on the ground (Matthew Tuhkanen/deceased). Officer Olson stated that he could only observe approximately 1/3 of the body that was laying on the ground.

Officer Olson stated that he was able to determine that his and Officer Mace's assistance was not needed further in the apartment based upon his observations and one of the firefighters stating that the individual (Tuhkanen) was deceased. Officer Olson stated that he did not observe or hear anyone in the apartment speaking about the OIS. Officer Olson was then directed to maintain a crime scene log outside of the doorway for apartment #7. Officer Olson stated that a crime scene log is done to document who and when an individual enters a crime scene and to account for anyone that may come into contact with potential evidence.

Officer Olson stated that he maintained the crime scene log for approximately 15 minutes before he was advised that he could return to the City of Minnetonka and resume his normal duties.

Officer Olson stated that at no time did he hear any St. Louis Park police officers or anyone present at the incident scene talk about any specific details related to this OIS.

TO Officer Tim Olson, Minnetonka Police Department

CLN Alright today's date is 7/30/2019 it's approximately 5:34 in the evening. Detective Nybeck Hennepin County Sheriff's Office. I'm in the, I'm at the Minnetonka Police Department in relation to Hennepin County case number 19000783 and Saint Louis Park case number 19000303. And I'm here with, can I get your full name and your rank?

Yep. Officer Tim Olson badge 135.

And how long have you been an officer with the Minnetonka Police Department? CLN

TO Uh a little over 15 years.

CLN Have you worked for another law enforcement uh, department prior to

Minnetonka?

TO Not as a peace officer.

Okay. Before I ask you any questions related to what occurred, what you did at this CLN uh crime scene for this case number. I just want to let you know this is a voluntary

consensual interview related to Saint Louis Park Police Department case number 19000303. This case is related to an OIS, officer involved shooting that occurred in the city of Saint Louis Park on January 19th, 2019 involving Officer Heffernan of the Saint Louis Park Police Department. Additionally before I ask you any questions is it correct that I did not threaten you, coerce you, or demand you to provide me a statement for this interview?

TO That is correct.

CLN And it's your choice and your, of your own volition to speak with me for this

interview? Correct...?

TO ...yes.

CLN Okay. Uh the purpose for this, of this interview and the subsequent accompanying

listed case number. Were you assigned to work on January 19th, 2019?

CLN TO	And was your assistance needed? Yes.
CLN TO	Did you proceed to the city of Saint Louis Park? Yes.
CLN TO	And at what location did you respond to? Uh we responded to 2760 Louisiana uh, Court. Louisiana Court.
CLN TO	When you arrived who did you speak to? Uh we offered assistance a to the Saint Louis Park officers that were on scene. And were directed to go into that building um to apartment number 7.
CLN TO	Do you recall what Saint Louis Park officer directed you into apartment 2760? I do not.
CLN TO	When you entered uh, apartment 2760 did you enter apartment number 7 inside that apartment complex? Yes.
CLN	And when you entered that apartment complex we're you with another Minnetonka officer? Yes.
CLN TO	And who was that? Officer Joe Mace.
CLN	When you initially entered the apartment or I'm sorry when you initially entered apartment number 7. What did you observe? Uh there uh there was at least one Saint Louis Park officer. Uh and uh I believe two Saint Louis Park fire personal.
CLN TO	And where were they when you entered the apartment? Uh they were towards the middle of the apartment uh kind of in the living room uh hallway area that lead towards what appeared to be a, at least one bedroom.
CLN	And when you entered were, was the, excuse me, was the officer speaking with the firefighters or were they separated? I believe they were separated at the time.
CLN	Were the firefighters speaking with each other?

ТО	I don't, don't recall.
CLN TO	Was the Saint Louis Park officer speaking to anybody or were they on phone? Not that I recall no.
CLN	Okay. And so you've encountered these three individuals when you first entered. What did you do?
то	Uh we inquired uh if they needed any assistance a as we made our way into the uh towards the back of the, uh apartment.
CLN TO	And was this a, question asked of the firefighters and the Saint Louis officer? It was just a general question that was directed um kind of towards everyone that was inside a, the apartment complex at the time.
CLN TO	Did you receive a response to your question? Yes.
CLN TO	And what were you directed to do? Uh at the time we, I was notified by a Saint Louis Park uh fire personal that the shooting victim was deceased. And then I offered any assistance to the Saint Louis Park officer that was a, on scene. And we were then uh redirected towards the entrance of the apartment a, to guard the doorway a, of the apartment number 7.
CLN	The firefighter and the officer, excuse me. Were these the ones you encountered in the living room hallway area? Or was it
CLN TO	yessomewhere else? Nope they were the same officers or personal that were inside the apartment.
CLN TO	Okay how far did you penetrate into the apartment? Uh we walked through what I would describe as a living room area and into the hallway that led towards the bedroom on the, the back left side as you walked down the hallway.
CLN TO	Did you go as far as that back left bedroom? Uh to the threshold of that doorway yes.
CLN TO	And what did you, did you look inside that apartment, or the b-, back bedroom? I saw that there was a fire personal inside the bedroom and there was a one person that was lying uh on the floor.
CLN TO	Did you observe any Saint Louis Park police officers in that back bedroom? Not that I recall.
CLN TO	How many firefighters were in that back bedroom? Um from my recollection uh at least one possible two.
CLN	And then you said you observed a, a body on the ground back, in that back bedroom?

CLN	Uh how much of that body did you observe?

то	Um. I would say I can't recall if it was the legs or, or the uh, the torso area. Um but it was I would say a third of the body.
CLN TO	Did you observe that body clothed or semi clothed or nude? Uh I believe the, the party had clothing on.
CLN TO	Did you observe any gunshot wounds to that body? No.
CLN TO	Did you overhear S-, the Saint Louis Park firefighters make any statements, statements while you were in that threshold for the door? No.
CLN	And then who, who gave you direction to either come inside the bedroom or to
ТО	leave the apartment? Uh I believe Officer Mace and I made a, made the decision not to enter the threshold um there was a, there was really no further need for us to be in the apartment at the time. And so we consciously made the decision to exit the apartment. Um but at the same time offered assistance to, to help the Saint Louis Park Police personal on scene with any other duties that they might need.
CLN	What factors did you or Office Mace take into account to determine that your assistance wasn't need, needed further in the bedroom? Uh the fact that a, from our obser-, from my observation that a, no further aid was being rendered to the victim. And that a, fire personal informed us that the party was deceased. Um that kind of made the decision for me that I didn't necessarily need to be inside the apartment at the time and didn't observe any other threats uh for police or fire personal in the apartment.
CLN TO	So you and Officer Mace exited the apartment. What did you guys do next? Uh when then held at a in the hallway uh in front of apartment number 7. And then I began um, uh crime scene log.
CLN TO	Did you do that, was that your decision or did somebody direct you to do that? Um I believe that was my decision initially and then I advised a Saint Louis Park police personal that I was uh beginning a crime scene log.
CLN ⁻ TO	And what is a crime scene log and what is the purpose of a crime scene log? A crime scene log is just a documenting uh the time that uh any personal enters or exits a crime scene. And it's also for, um documenting any personal that may have contact with any sort of evidence a, that is found within that crime scene.
CLN	And how, did Officer Mace help you do this? Or was he present when you were
то	manning the crime scene log? He was present.
CLN	Approximately how long were you outside apartment number 7 manning the crime
то	scene log? I would venture to guess a fifth teen minutes.
CLN	Were you directed by anybody on scene that your assistance was no longer needed to man a crime scene log?

то	Yes.
CLN TO	Do you recall who advised you of this? Uh I do not recall the specific person uh that advised us. I believe it was a Saint Louis Park uh, supervisor.
CLN TO	And when you were dismissed from that duty did you provide any other assistance to a Saint Louis Park Police Department that night? Uh not relating to that um specific scene.
CLN TO	Okay did you stay on scene after you were relieved of your duty? No we uh both myself and Officer Mace then returned a, to the city of Minnetonka.
CLN TO	Okay. And did you generate a report for what you assisted with that night? Yes.
CLN	Okay. While at any point while you were on the scene whether it was the arrival, speaking with a supervisor prior to entering the apartment, inside the apartment, or manning the crime scene log or at any other time. Did you have any contact or conversation with Saint Louis Park police officers regarding what occurred inside of apartment number 7 during the OIS? No.

On 8-2-2019 Det. Nybeck conducted a digitally recorded voluntary interview of Minnetonka Police Officer Mace at the Minnetonka Police Department. Officer Mace's interview on this date is a supplement to his initial report for Hennepin County case number 19000783 and Minnetonka PD case number 19000272. This report is a summary of Officer Mace's statements to Det. Nybeck's questions during this interview. The complete interview is saved to this case file in both digital and transcription form. Refer to both forms for greater details.

Officer Mace stated that he was scheduled to work on 1-19-2019 for the City of Minnetonka. Officer Mace stated that he was notified about an OIS (Officer Involved Shooting) in the City of St. Louis Park that night via radio and that he and Officer Olson of the Minnetonka Police Department drove to the incident location "code 3".

Officer Mace stated that upon arrival at the incident address (2760 Louisiana Ct. #7) he and Officer Olson were directed to apartment #7 and to assist as needed.

Officer Mace stated that he and Officer Olson entered this apartment and observed St. Louis Park police officers and firefighters in the back rear bedroom for this apartment. Officer Mace stated that he and Officer Olson never entered this rear bedroom but were able to observe firefighters administering what appeared to be medical aid to an individual inside this room. Officer Mace was not able to describe the medical aid being administered but at some point a firefighter informed both of them (Officers Mace and Olson) that the individual receiving medical attention was deceased.

Officer Mace stated that after learning that the individual inside the bedroom was deceased, he and Officer Olson exited the interior of apartment #7 and stood outside the this apartment for security purposes. Officer Mace stated that Officer Olson then began a crime scene log for apartment #7 and maintained the crime scene log until Officer Olson was relieved by Officer Peek of the St. Louis Park Police Department for this duty. Officer Mace stated he was present with Officer Olson as Officer Olson was maintaining the crime scene log. Officer Mace stated that Officer Olson maintained the crime scene log while standing outside apartment #7.

Officer Mace stated that at no time did he hear or overhear any Law Enforcement Officer or firefighter

Based upon Sgt. Tait's non-involvement in this OIS, Sgt. Tait was not subsequently interviewed by Det. Nybeck on this date.
