This report pertains to the review of emergency telephone calls received by Saint Louis Park Police Department from callers involved with the domestic disturbance prior to the death of Matthew Neil Tuhkanen (08/04/1983). Refer to all reports and attachments in this case for additional information.

NARRATIVE:

On January 29th, 2019 I, Detective Reed Soeffker, reviewed the digitally recorded 911 calls that were received by Saint Louis Park Police Department on January 19th, 2019 regarding a domestic disturbance. This report covers a single MP3 file containing three seperate phone calls. This report is a summary of these recordings. A copy of this recording has been attached to this case file for evidentiary value.

The first phone call to Saint Louis Park Police Dispatch begins at 0:00 and concludes at 2:37 on the timestamp on the digitally recorded file. According to the attached excel document, this call was received at 17:02:57 from 763-237-4926.

The caller identifies herself as Mylee Workman and stated that she lives at 2760 Louisiana Court, Apartment #7. Workman asks that police come and get Matthew Neil Tuhkanen (08/04/1983) who is identified as Workman's "baby's dad". Workman states that she is "tired of it" and that Tuhkanen has 3 warrants for parole violation. Workman states that Tuhkanen is out in the parking lot. Workman is asked by the Police Dispatcher if there was a "verbal altercation" and Workman replies, "Yeah, he didn't hurt me or anything".

The second phone call to Saint Louis Park Police Dispatch begins at 2:38 and concludes at 3:10 on the timestamp on the digitally recorded file. According to the attached excel document, this call was received at 17:09:48 from 763-237-4926.

The caller's voice is the same as the previous call and identified as Workman. Workman asks if police are coming to her house at 2760 Louisiana Court. The dispatcher tells Workman that the police are on their way. Workman states that "he" (implied Tuhkanen) is at her door and pounding. The dispatcher advises Workman to not open her door and that police are on their way.

The third phone call to Saint Louis Park Police Dispatch begins at 3:11 and concludes at 4:52 on the timestamp on the digitally recorded file. According to the attached excel document, this call was received at 17:56:42 from 612-407-4867.

The caller identifies herself as Jessica Stillday. Stillday tells the dispatcher that "the guy" (implied Tuhkanen) they were looking for came back to 2760 Louisiana #7 and went inside the apartment. Stillday told the dispatcher that she saw him go inside apartment #7 through her peephole across the hallway. Stillday told the dispatcher that "he" was upstairs hiding when police came, but his "baby's

mom" went upstairs and got him. Stillday describes him as a male in a black hoodie sweatshirt, grey jogging pants, and black and white Nikes.

NARRATIVE:

On January 30th, 2019 I, Detective Reed Soeffker, reviewed the digitally recorded Saint Louis Park 911 Fire Dispatch radio transmissions that were exchanged by firefighters and dispatch on January 19th, 2019 regarding the death of Tuhkanen. This report is the summary a single WMA file containing the radio transmissions. A copy of this recording has been attached to this case file for evidentiary value.

The digital recording begins at the 0:00 and lasts until 7:19 timestamp.

At the 0:13 timestamp a emergency tone is sounded. At the completion of the tone at the 0:25 timestamp, a dispatcher calls out "Station 2" a possible gunshot wound at 2760 Louisiana Court #7.

At the 0:42 timestamp an acknowledgement from Station 2 is returned. The dispatcher concludes the transmission this at 1816 (hours).

At the 0:54 timestamp Station 2 requests the call be sent again. Dispatch restates possible gunshot wound at 2760 Louisiana Court #7.

At the 1:14 timestamp Rescue 2 responds that they are en route. The dispatcher acknowledges this at 1819 (hours).

At the 1:24 timestamp Engine 2 states that they are en route. The dispatcher acknowledges this at 1819 (hours).

At the 1:35 timestamp Rescue 2 states that they are out. The dispatcher acknowledges this transmission by stating the time of 1820 (hours).

At the 1:53 timestamp Rescue 2 calls Engine 2 and states "GSW times 3 to the chest" (3 gun shot wounds to the chest) and that they will need their assistance inside the apartment "CPR".

At the 2:21 timestamp Station 1 requests an all-call for staffing. Dispatch acknowledges this request at 1822 (hours).

At the 2:40 timestamp tone goes out and dispatch calls for an all-call and states the time of 1823 (hours).

At the 3:04 timestamp Engine 2 states that they are arriving (on scene). Dispatch acknowledges this at 1823 (hours).

At the 3:19 timestamp Engine 1 states that they are en route. Dispatch acknowledges this without stating the time.

At the 3:35 timestamp Rescue 1 calls for Engine 1. Rescue 2 responds, and a "Code 4" (situation under control) is called.

At the 4:03 timestamp an unknown caller states that police are going to call crime lab, and that others can clear.

At the 4:14 timestamp Engine 1 calls out that they are arriving (on scene). Dispatch acknowledges this at 1829 (hours)

At the 4:26 timestamp Engine 1 calls dispatch to advise medics are "Code 4" (situation under control). Dispatch acknowledges without stating the time.

At the 4:42 timestamp Station 1 tells dispatch who will have "City Ops" at Station 1.

At the 5:07 timestamp Engine 1 calls Station 1 and states that "units on scene can handle".

At the 5:25 timestamp Engine 1 clears itself (leaving the scene). Dispatch acknowledges this at 1837 (hours). Engine 2 and Rescue 2 state "same traffic" (they will also leave the scene). Dispatch acknowledges this at 1837 (hours).

At the 5:47 timestamp Mobile Command is en route to the scene.

At the 6:03 timestamp Command 1 requests dispatch to ask "PD" (Police Department) command where to set up. Transmissions are exchanged between unknown units and it is decided to set up in the cul-de-sac.

At the 6:50 timestamp Command 1 states that they are arriving on Louisiana Court. Dispatch acknowledges this at 1904 (hours).

At the 7:04 timestamp Command 1 asks another unit for help with an unknown issue.
