The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

#### COUNTI

**Charge: Criminal Vehicular Homicide - Operate Motor Vehicle in Grossly Negligent Manner** 

Minnesota Statute: 609.2112.1(a)(1), with reference to: 609.2112.1(a)

Maximum Sentence: 10 YEARS AND/OR \$20,000

Offense Level: Felony

Offense Date (on or about): 04/28/2021

Charge Description: That on or about April 28, 2021, in Hennepin County, Minnesota, JACK HENRY BLASCHKE did by operating a motor vehicle in a grossly negligent manner, cause the death of Victim.

#### **COUNT II**

Charge: Criminal Vehicular Homicide - Driver Who Causes Collision Leaves Scene

Minnesota Statute: 609.2112.1(a)(7), with reference to: 609.2112.1(a)

Maximum Sentence: 10 YEARS AND/OR \$20,000

Offense Level: Felony

Charge Description: That on or about April 28, 2021, in Hennepin County, Minnesota, JACK HENRY BLASCHKE did, by operating a motor vehicle, cause a collision that caused the death of Victim, and JACK HENRY BLASCHKE left the scene of that collision.

#### STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about April 28, 2021, officers from the Plymouth Police Department responded to the area of 17220 County Road 24, in Plymouth, Hennepin County, State of Minnesota, on a report of a male lying unconscious in the driveway of the residence. Officers were advised that that male, later identified as G.M.S. (DOB: 8/2/1955), Victim herein, appeared to have a pulse and bystanders had started CPR.

Upon arrival, officers were advised that Victim had been struck by a vehicle. Victim's black Labrador had also been struck by the vehicle, and was located lying, deceased, approximately 100 feet away from Victim. Officers attempted emergency medical assistance to Victim while awaiting EMS. Victim was transported to North Memorial Hospital where he was later pronounced deceased as a result of massive internal injuries.

Officers learned through their investigation and discussion with witnesses that, shortly before 9:00 p.m., JACK HENRY BLASCHKE (DOB: 6/1/2001), Defendant herein, had been driving a vehicle and had pulled up next to another vehicle that was stopped at the red light waiting to turn to head west on County Road 24. According to witnesses in the vehicles, Defendant had indicated, by honking three times, a desire to challenge the driver of the other vehicle to a street race. Thereafter, Defendant accelerated and drove quickly away at a speed reaching well over 70 m.p.h. (in a 45-m.p.h. zone). Defendant's vehicle then struck Victim and his dog, who were crossing the street. Witnesses stated that once Defendant's vehicle struck Victim, Victim flew through the air and landed on the driveway. Defendant fled the scene and refused to return, despite witnesses encouraging him to return to the area because he had hit someone. Defendant did not contact law enforcement to report the crash with personal injury.

Officers observed a large quantity of vehicle parts scattered nearby throughout the roadway and the grassy area to the north of the road.

Officers later located Defendant, who was read his rights and questioned about the incident. Defendant claimed that he was driving in the right lane at a speed of 40-45 m.p.h. when he came around a curve and a guy and his dog were just right there in front of him. Defendant stated that he panicked and went north on County Road 101 after hitting the man, while his friend in another vehicle went in the opposite direction and called him about striking the pedestrian. Defendant admitted that he decided not to return to the scene and instead went to a friend's house. Defendant admitted that his father had warned him several times in the past about consequences related to his driving and that he had just been arrested for a DWI in Plymouth weeks earlier. Defendant stated that he was suicidal and asked if he would be going to prison.

Defendant is in custody.

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
