The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Murder - 2nd Degree - With Intent-Not Premeditated**

Minnesota Statute: 609.19.1(1), with reference to: 609.11.5(a), 609.19.1, 609.11.9

Maximum Sentence: 40 YEARS

Offense Level: Felony

Offense Date (on or about): 05/15/2021

Control #(ICR#): 20210609

Charge Description: That on or about 5/15/2021, in Hennepin County, Minnesota, DPREE SHAREEF ROBINSON, caused the death of victim, a human being, with intent to effect the death of that person or another, but without premeditation, while using a firearm.

Minimum Sentence: 3 YEARS

## STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On May 15, 2021, at approximately 8:32 PM, Minneapolis police responded to a shot spotter activation on the 2200 block of Ilion Avenue North, in the City of Minneapolis, County of Hennepin. This was a drive-by shooting that was captured on surveillance video. A juvenile female, "victim," who was jumping on a trampoline in a residential backyard was struck and killed by the gunfire. Video showed that the victim and two other juveniles who were on the trampoline were directly between the shooter and the intended targets, who appeared to be three males on the side porch of the residence, dressed in dark clothing. One of the three on the porch could be observed chasing after the suspect vehicle on foot and appeared to return fire three times.

Three 9mm discharged cartridge casings (DCC's) were subsequently located in the alley, consistent with having come from the individual who had shot at the suspect vehicle.

Through video surveillance and License Plate Reader (LPR) technology, the vehicle used for the drive-by was determined to be a 2014 Ford Fusion, MN plates 720 XRP. Aside from the positive LPR identification, the vehicle had other distinguishing characteristics.

Investigators determined that that this vehicle had been purchased on May 12, 2021, by a DPREE SHAREEF ROBINSON, DOB 08/09/2002. ROBINSON purchased the vehicle from an identified male, initials Z.G. ROBINSON instructed Z.G. not to let anyone know he had the Ford Fusion, and Z.G. acknowledged that he would not.

At all relevant times the vehicle could be located by LPR or surveillance video on 5/14/21 and 5/15/21, to include the time of the murder, ROBINSON's known cell phone was in the same geographical vicinity as the suspect Ford Fusion.

On his social media accounts, ROBINSON has touted himself as an active shooter for the Black Disciples Criminal Street Gang, making repeated references to firearms, shooting, the "opps," (street slang for opposition or rival gangs), and other comments like, "Never stand down bltch my mama raised a gangsta," and, "I know how to shoot and I know how to fight." ROBINSON also refers to himself as "GDK," or "Gangster Disciple Killer," which refers to a rival gang of the Black Disciples.

Subsequent investigation revealed that in February, 2021, ROBINSON had been engaging in threatening social media communications with a male resident of 2211 Ilion Avenue, initials W.J. W.J. has never directly answered the question of whether he was present at the time of the shooting. However, witness accounts of the scene indicate that both W.J. and the vehicle he drove were present at 2211 Ilion at the time of the gunfire.

The communications between ROBINSON and W.J. were aggressive and indicative of the kind that result in shootings between rival gang members. For context, ROBINSON had a number of previous posts that insinuated he was out looking for "opps," but they were afraid to come outside and face him. A pertinent example is, "The opps be tuff up onna net they don't even be outside."

It is known by law enforcement that criminal street gangs often use drive-by shootings against their rivals as a means to obtain "respect," or fear, which helps them promote their criminal activities.

In the texts between ROBINSON and W.J., ROBINSON dared W.J. to “pop out,” or come outside. W.J. responds, “I’m always outside you gone(sic) see me stop texting me like my bitch.”

Additionally, ROBINSON had apparently been romantically involved with W.J.’s sister. The two obviously had a bad break up, and W.J.’s sister had hostile communications with ROBINSON on 5/12/21, three days before the shooting, accusing him of cheating on her and lying to her.

Approximately thirty minutes after the 5/15/21 murder of the victim, ROBINSON conducted three internet searches related to changing the paint on a 2014 Ford Fusion, then quit using this cell phone forever. The thirteen calls he received at this number after the shooting went straight to voicemail. Further, despite an extensive, nation-wide search, the 2014 Ford Fusion that ROBINSON purchased on 5/12/21 and was last seen on 5/15/21 committing the drive-by shooting appears to have vanished.

Both W.J. and the homeowner at 2211 Ilion Ave North have been deceptive with law enforcement since the shooting. W.J. and his colleagues are part of a criminal street gang, “MCD,” or Money Chasing Demons. MCD is associated with the “Highs” affiliation of criminal street gangs. As such, they are rivals to the Black Disciples, who are associated with the “Lows” affiliation of criminal street gangs.

Evidence at the scene of the victim’s murder appears to have been tampered with. For example, a colleague of W.J., initials A.S., who was present (with a bag) at the murder scene when police arrived on 5/15/21, was arrested in Eagan on 10/11/21. He was in possession of a handgun at the time. Ballistics examination matched the 9mm possessed by A.S. on 10/11/21 to the DCC’s located in the alley in this case. (i.e., A.S. or someone he knew was the person who shot back at the maroon Fusion).

Search warrants executed on ROBINSON’s social media uncovered a Facebook conversation he had with his girlfriend, “A.H.,” in June, 2021. In this conversation, A.H. was upset with ROBINSON over a physical altercation the two had during which ROBINSON apparently broke A.H.’s cell phone.

A.H. repeatedly (eight times) made reference to or directly called ROBINSON, a “child killer,” and at one point tells him, “i hope you die for killin that lil girl.” ROBINSON responded, “ldgaf (“I don’t give a f\*\*\*”) what we go threw (sic) you don’t ever wanna see me in that cell.”

In February, 2022, investigators spoke with an identified individual, referred to hereinafter as “Witness 1.” Witness 1 is a documented acquaintance of ROBINSON. Witness 1 described to investigators how ROBINSON admitted to being present at the 5/15/21 murder of the victim.

According to Witness 1, ““Um. He (ROBINSON) had told me that he was in a – like – sh – clap out... (with the “opps”). Witness 1 clarified that clap out meant shoot out and that the “opps” were rival gang members. Witness 1 said, “...he said the next day, he seen that a girl had, um, had been shot in the head. But he said, he—he—he basically was telling me in a way he was confused. He didn’t know if it was them, or it could have been him.”

A review of the surveillance footage, some of which included audio recordings of the incident, revealed that the victim was shot prior to the three shots of return fire from the individual from the side porch of the residence. Further, the return fire took place after that shooter ran past the victim’s location and was in the alley pointing his gun at the suspect Ford Fusion, which was traveling away from where the victim was shot.

ROBINSON’s whereabouts are currently unknown. The State is seeking high bail to ensure his appearance and for purposes of public safety. Further, because making this complaint public may cause ROBINSON to flee, hide evidence, and endanger the safety of potential witnesses, the State is asking it be sealed until ROBINSON’s arrest.



## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
