STATEMENT OF PROBABLE CAUSE

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

12-6-2024 - AMENDED COMPLAINT - COMPLAINT IS BEING AMENDED TO REFLECT THE ADDITION OF ADDED PC LANGUAGE (EVERYTHING AFTER THE ***** LINE), ADDITIONAL COUNTS, AND THE ORIGINAL COUNT 1 IS NOW COUNT 3.

On October 23, 2024, at approximately 9:15 pm, Minnesota State Patrol troopers responded to a traffic accident that occurred off the exit ramp from I94 East, near Lyndale Avenue, in Minneapolis, Hennepin County, Minnesota. Upon arrival, troopers observed numerous cars with significant damage and multiple people with minor to severe injuries. After talking with witnesses and further investigation, troopers determined the following:

A Chevy Avalanche vehicle, MN license plate 500AA7, was traveling down the exit road from I94 East, heading toward Dunwoody Blvd. The driver of the Avalanche vehicle was later identified as TALON COVIE-CARDRELL WALKER (DOB: 2/16/95), hereinafter "Defendant." There was an adult female in the front passenger seat of the Avalanche vehicle. There was traffic on the road and numerous cars traveling slowly at the time. As Defendant approached Dunwoody Blvd., he sideswiped another SUV on the road, then crashed directly into the back of a Jeep Cherokee vehicle. Witnesses indicated Defendant was traveling approximately 100 MPH at the time of the crash. The Jeep Cherokee was pushed into the back of a Ford Edge vehicle, which was pushed into the back of a Nissan Versa vehicle, which was pushed into the back of a Toyota RAV4 vehicle, which then struck an Audi Q5 vehicle. The force of the crash caused two of the cars to be pushed 180 degrees sideways. Troopers located an open partially full bottle of liquor on the driver's side floorboard of Defendant's vehicle.

There was severe damage to several vehicles including the Jeep Cherokee vehicle. The driver of the Cherokee vehicle, Victim1, sustained fatal injuries and died at scene. Several other occupants of the various vehicles sustained significant injuries and remain in the hospital. Defendant was also taken to the hospital.

A blood draw was performed on Defendant at the hospital. Results are pending. Defendant has a prior Implied Consent license revocation on June 17, 2021.

***A sample of Defendant's blood was taken on October 23, 2024, at approximately 11:52 pm. Results of the blood test revealed an alcohol concentration of .093 g/100mLs of blood, +/- .006. Further, toxicology analysis revealed the presence of marijuana and fentanyl in his blood.

On November 22, 2024, a State Patrol sergeant spoke with adult female Victim2. Victim2 was sitting in the front passenger seat of Defendant's vehicle during the crash. Victim2 stated she met Defendant a few days prior to the crash and they would smoke marijuana together. Victim2 stated the night of the crash, Defendant picked her up in his vehicle and he drove to his cousin's house in Minneapolis. While at his cousin's house, Defendant smoked a large amount of marijuana. Victim2 stated Defendant initially appeared fine but then he went upstairs for a while. When Defendant came back down, he appeared "zoned out" and clearly under the influence of a controlled substance. She and Defendant then got back into his vehicle with Defendant driving. Victim2 stated Defendant was driving erratically, swerving back and forth, at one point striking a concrete median in the road. Victim2 stated Defendant kept driving faster and

faster. She observed the odometer reading over 100 MPH. Victim2 was screaming at Defendant to slow down but Defendant did not appear to respond. Defendant then crashed into multiple vehicles.

Numerous people were injured as a result of the crash.

Victim2 was hospitalized for over three weeks. She had multiple fractures to both legs and her right foot, including significant fractures to both femurs, a dislocated left hip, traumatic injury to her right knee and several fractures to her right foot. Doctors believe the injuries will have lifelong debilitating effects. She was pregnant at the time as well.

Adult female Victim3 was a passenger in the same vehicle as Victim1. Victim 3 lost consciousness at the scene as a result of the crash. Victim3 was taken to the hospital and diagnosed with a traumatic brain injury, a subdural hematoma and various other injuries. Victim3 had significant memory issues immediately after the crash and had trouble remembering events earlier in the night.

Five other people in the other vehicles also suffered pain, abrasions, and other minor injuries as a result of the crash caused by Defendant - Victims 4 through 8.

Defendant remains in custody. ***
