The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Criminal Sexual Cond-1st Degree-Penetration - Injury - Use Force/Coerce

Minnesota Statute: 609.342.1(e)(i), with reference to: 609.342.2(a), 609.342.2(b), 609.101.2, 609.342.2(c), 609.3455.10

Maximum Sentence: 30 YEARS AND/OR \$12,000-\$40,000, PLUS CONDITIONAL RELEASE

Offense Level: Felony

Offense Date (on or about): 10/13/2013

Control #(ICR#): 13339876

Charge Description: That on or about 10/13/2013, in Hennepin County, Minnesota, MOHAMUD HILLOW BULLE engaged in sexual penetration with victim, and caused personal injury to her using force or coercion to accomplish sexual penetration.

COUNT II

Charge: Criminal Sexual Cond-1st Degree-Penetration - Injury - Use Force/Coerce

Minnesota Statute: 609.342.1(e)(i), with reference to: 609.342.2(a), 609.342.2(b), 609.17.4(2), 609.101.2, 609.342.2(c), 609.3455.10

Maximum Sentence: 30 YEARS AND/OR \$12,000-\$40,000, PLUS CONDITIONAL RELEASE

Charge Description: That on or about 10/13/2013, in Hennepin County, Minnesota, MOHAMUD HILLOW BULLE attempted to engage in sexual penetration with Victim, and caused personal injury to her using force or coercion to accomplish sexual penetration.

COUNT III

Charge: Kidnapping-To Facilitate Felony or Flight

Minnesota Statute: 609.25.1(2), with reference to: 609.25.2(1), 609.25.2(2)

Maximum Sentence: 40 YEARS AND/OR \$50,000

Offense Level: Felony

Offense Date (on or about): 10/13/2013

Charge Description: That on or about 10/13/2013, in Hennepin County, Minnesota, MOHAMUD HILLOW BULLE confined or removed victim from one place to another without her consent, in order to facilitate commission of a felony or flight thereafter, and victim was not released in a safe place.

STATEMENT OF PROBABLE CAUSE

THE OFFENSE PORTION HAS BEEN AMENDED TO ADD AN ADDITIONAL COUNT OF CRIMINAL SEXUAL CONDUCT IN THE FIRST DEGREE AS COUNT 1, THUS RENUMBERING THE ORIGINAL ATTEMPTED CRIMINAL SEXUAL CONDUCT IN THE FIRST-DEGREE COUNT AS COUNT TWO. THE PROBABLE CAUSE PORTION REMAINS THE SAME.

ON SEPTEMBER 30, 2025, THE OFFENSE PORTION IS AMENDED TO INCLUDE COUNT THREE - KIDNAPPING.

Complainant has investigated the facts and circumstances of this offense and believes the following establishes probable cause:

On or about October 13, 2013, Minneapolis police officers responded to the report of criminal sexual conduct that occurred in Minneapolis, Hennepin County, Minnesota. Upon arrival, officers spoke with an adult female, Victim herein, who was visibly distraught. Victim stated that earlier that evening she was at an event in Minneapolis, Hennepin County. Victim had been out socializing with friends when she became separated from her group. Victim stated she was approached by an unknown male, later identified as MOHAMMED HILLOW BULLE, Defendant herein, who followed her and offered her his cell phone. Victim was unable to make a call so gave the phone back to Defendant. Defendant then pushed Victim into a ditch in a nearby park. Defendant held Victim down and placed his hands around her neck, impeding her breathing. Defendant pulled off her leggings and underwear and got on top of her. Defendant tried to sexually penetrate her. Defendant eventually got off her and left. Victim was afraid to move so laid there for a few minutes before receiving assistance from a passerby who called 911.

Victim was taken to the Hennepin County Medical Center where a sexual assault examination was conducted. Victim's eyes were swollen, and she suffered a hemorrhage to her left eye. Victim had scratches on her neck, marks and bruises throughout her body, and dirt on her knees. The sexual assault kit, including biological swabs taken from the victim's genital area, was sent to the Bureau of Criminal Apprehension (BCA) for forensic testing.

The Minneapolis Police Department (MPD) returned to the scene and took photographs of the area where Victim was assaulted. The area was muddy, and the grass was matted down. Victim's eyeglasses and shoes were recovered. MPD assigned the case to an investigator but at that time, Victim did not want to move forward, and the case was closed.

In 2020, as part of ongoing efforts to investigate previously untested sexual assault kits, the BCA completed testing on Victim's sexual assault kit and was able to obtain an unidentified major male DNA profile from Victim's perineal and rectal swabs. That profile was entered into the Minnesota and national databases but there were no matches or case associations at that time.

On May 7, 2024, the BCA determined there was a match to the unidentified male DNA profile from Victim's kit to an unknown DNA profile obtained in a 2024 domestic criminal sexual conduct case from St. Paul, Ramsey County, Minnesota. No identification was made at that time.

In October 2024, Defendant was a named suspect in an unrelated attempted murder and assault case in St. Paul, Ramsey County, Minnesota. Through the course of that investigation, Defendant submitted his DNA sample pursuant to a search warrant. The BCA completed forensic testing and determined Defendant's profile matched the previously unidentified male profiles from both Victim's kit and the 2024 domestic criminal sexual conduct case. In the present case, involving Victim, Defendant's DNA match

would not be expected to occur more than once among unrelated individuals in the world population.

On February 26, 2025, an investigator with the Hennepin County Attorney's Office met with Victim, who provided a statement consistent with her initial report from more than ten years earlier. Victim recalled that night she had gone out with her husband and friends to an event in Minneapolis. She stated she left the group she was with and intended to walk around the block. She stated she was approached by a stranger who told her he could help her. Victim stated he would let her use his phone, but she was unable to dial out and he took his phone back. She remembered laying in the mud, while he was trying to rip her clothes off, and she tried to act like she was already dead because it was hard to breathe. She stated he knelt on the backs of her knees, pinning her to the ground. She stated she tried to keep her legs clenched tight and was unsure if he penetrated her or ejaculated. She stated that at some point he got up and left. She laid there on the ground until it was quiet and then went to find help. She stated a man on a bicycle stopped and called the police. She had visible injuries including swelling, broken blood vessels, marks and scratches on her neck and body, and she had to hide herself for weeks until her injuries healed. Victim stated she recalled struggling to find the words to tell her young daughter how a "bad man on the street" had "hurt mommy." Victim confirmed she did not know Defendant and did not have consensual sex with him.

Defendant has a pending Attempted Murder and Second-Degree Assault case in Ramsey County (62-CR-24-6671) and is currently in custody in Ramsey County.
